Animal Advisory Commission Special Called Meeting to be held July 19, 9 a.m., with Social Distancing Modifications

Public comment will be allowed via telephone; no in-person input will be allowed. All speakers must register in advance (July 18 by noon). All public comment will occur at the beginning of the meeting.

To speak remotely at the Monday, July 19, 9 a.m., Special Called Meeting, members of the public must:

- Call or email the commission liaison, Belinda Hare, phone 512-978-0565, or email Belinda.Hare@austintexas.gov no later than noon, July 18, the day before the meeting. Email works best. The following information is required: speaker name, item number(s) they wish to speak on, whether they are for/against/neutral, email address and telephone number (must be the same number that will be used to call into the meeting).
- Once a request to speak has been made to the board liaison, the information to call on the day of the scheduled meeting will be provided either by email or phone call.
- Speakers must call in at least 15 minutes prior to meeting start time in order to speak, late callers will not be accepted and will not be able to speak.
- Speakers will be placed in a queue until their time to speak. Each speaker has three minutes to speak.
- Handouts or other information may be emailed to Belinda.Hare@austintexas.gov by noon the day before the scheduled meeting. This information will be provided to Board and Commission members in advance of the meeting.
