## Council Committee, Boards and Commission Action:

April 13, 2021- Public hearing conducted by Community Development Commission to collect feedback on community needs.

June 8, 2021- Public hearing conducted by Community Development Commission to receive public comments on the draft Fiscal Year 2021-22 Action Plan.

July 13, 2021- The Community Development Commission recommended approval of the Draft Fiscal Year 2021-2022 Action Plan with some recommendations that are outlined in the Action Plan's appendices.

## Additional Backup Information:

The Action Plan serves as the City's application to receive grant funds from HUD. In Fiscal Year 2021-22, the City expects to receive continued federal funding through four HUD formula grants: Community Development Block Grant (CDBG), HOME Investment Partnerships Program (HOME), Emergency Solutions Grant (ESG), and Housing Opportunities for Persons with AIDS (HOPWA). An annual Action Plan provides an overview of community needs, resources, priorities; and proposes activities related to housing, community development, economic development, homelessness services, and public services.

This request for Council action complies with the City of Austin's Citizen Participation Plan (CPP) and with program waivers authorized by HUD. The waivers are allowed to help prevent the spread of COVID-19 and to facilitate assistance to communities and households economically impacted by COVID-19. The waivers allow jurisdictions to conduct virtual public hearings.

The City anticipates receiving the following grant allocations from HUD-

CDBG: \$7,947,552
HOME: \$3,156,803
ESG: \$669,870
HOPWA: \$2,099,125

This anticipated funding is allocated to various programs via the FY 21-22 Action Plan.

## Public Input Process for the FY 2021-22 Action Plan

- The Community Development Commission conducted a public hearing on April 13, 2021, to receive
  public input on community needs for the City's federal Action Plans for Fiscal Year 2021-22 that
  relate to federal funding opportunities.
- Austin City Council conducted a public hearing on April 22, 2021, to receive public input on community needs for the City's federal Action Plans for Fiscal Year 2021-22 that relate to federal funding opportunities.
- The draft Action Plan was made available for a 30-day public comment period starting on May 6, 2021 and concluded on June 11, 2021.
- The Community Development Commission conducted a public hearing on June 8, 2021, to receive
  public comment on the draft Fiscal Year 2021-22 Action Plan.
- The Community Development Commission recommended approval of the draft Fiscal Year 2021-22
   Action Plan on July 13, 2021 with the recommendation to address public input by disabilities
   advocates regarding departmental outreach and communications as well as prioritize investments
   for households at 30 percent MFI and below, with a focus on reporting investments that benefit
   persons with disabilities.

If approved, the Housing and Planning Department will submit the City's one-year Action Plan to HUD no later than August 16, 2021.
