

ANIMAL ADVISORY COMMISSION MINUTES July 12, 2021

REGULAR MEETING APPROVED July 19, 2021

The Animal Advisory Commission convened, via video conferencing, in a Regular Meeting, Monday, July 12, 2021, 3 p.m.

1. APPROVAL OF MINUTES

Commissioner Norton moved to approve the minutes from the Animal Advisory Commission meeting, June 14, 2021, and Commissioner Frenden seconded the motion. Motion passed, 9 to 0, with Commissioners Nazor, Jarl, Neuhaus, Flores, Frenden, Norton, Clinton, Smagula and Herrera voting approval.
