Amanda,

Based on your conversation yesterday, it sounds like the applicant for B-17 would be willing to commit to full compliance with the Save Our Springs Initiative Ordinance, without utilization of the Redevelopment Exception, for the subject property. If this can be memorialized, I will remove Save Our Springs Alliance opposition from your proposed rezoning case.

I fully understand that there are two other parcels that the applicant intends to combine with this parcel as part of a larger development. Those parcels have restrictive covenants that the applicant intends to use as part of a vested rights claim. As we discussed, SOS objects to the use of those restrictive covenants as a means to skirt Austin's environmental regulations. However, I also acknowledge that that is a separate conversation and we can protest that decision at a later date.

We would encourage the applicant to consider the environmental impact his proposed development will have on the Edwards Aquifer and the Barton Springs Zone.

Please note that I write this letter as a <u>former</u> attorney of SOS; however, I am trying to wrap up a few items that started before I terminated my employment. I am handling this as a courtesy to SOS to help with the transition.
