To speak remotely at the **AUGUST 3, 2021, AFRICAN RESOURCE ADVISORY COMMISSION** Meeting, members of the public must:

- Speakers must call in at least 15 minutes prior to meeting start in order to speak, late callers will not be accepted and will not be able to speak.
