# Technical Progress

- ATD technical teams providing transparency and consistency in application of ordinances
  - Transition to SIF
  - Offset Agreements (Credits to the SIF)
- Ongoing discussions with development community and their representatives
  - “Grandfathering” of projects in progress
  - Larger, multi-phased projects
  - General questions and education
- Developed SIF Estimator Worksheet as public-facing document
  - Will help developers to budget for SIF Collection amount based on land uses and intensities
  - Will further help ATD be consistent in assessment of fees

# Project Implementation Overview

- Fees begin to be collected June 2022
  - Projects will require time to be fully funded from Impact Fees
- Project implementation staff will work with multiple transportation disciplines to ensure projects that address:
  - Safety
  - Equitability
  - Funding Leveragability
  - AMSP Alignment



# Next Steps

- Continue to develop public-facing portal to view collected funds and projects
- IT and back-end updates in AMANDA
- Updating TIA Guidelines to provide direction for SIF assessment and offsets
- Updating SIF/ATD websites
- Ongoing work groups to ensure cohesive roll-out and collection in 2022
- Release SIF Estimator Worksheet (end of July 2021)
