

37 **PART 5.** In accordance with Chapter 271 of the Texas Election Code, the
38 November 2, 2021 special municipal election may be held jointly with the various
39 political subdivisions that share territory with the City of Austin and that are holding
40 elections on that day. The City Clerk may enter and sign joint election agreements
41 with other political subdivisions for this purpose, and their terms as stated in the
42 agreements are hereby adopted.

43 **PART 6.** The Council finds that the need to immediately begin required
44 preparations for this election constitutes an emergency. Because of this emergency,
45 this ordinance takes effect immediately on its passage for the immediate preservation
46 of the public peace, health, and safety.
