Authorize negotiation and execution of Amendment No. 8 to an interlocal agreement with Austin Community College to provide childcare quality improvement services, to add two 12-month extension options each in an amount not to exceed \$51,128, for a revised total agreement amount not to exceed \$356,649.

Funding in the amount of \$51,128 is included in the Fiscal Year 2021-2022 Austin Public Health Department Operating Budget.

Prior Council Action:

February 15, 2018 - Council authorized negotiation and execution of Amendment No. 3 to add \$1,247 for the agreement period ending September 30, 2018 and increase funding for the three remaining renewal options. on a 10-0 vote with Council Member Casar off the dais.

April 13, 2017 - Council authorized negotiation and execution of Amendment No.1 to add \$1,121 to the agreement period ending September 30, 2017 and increase funding for the four remaining renewal options, on a 9-0 vote with Council Member Troxclair abstaining and Council Member Pool absent.

August 18, 2016 - Council authorized an inter-local agreement with Austin Community College for a 12-month term beginning on October 1, 2016, with four 12-month renewal options, on a 9-1 vote with Council Member Zimmerman voting nav and Council Member Gallo abstaining.

Additional Backup Information:

This action will authorize the negotiation and execution of Amendment No. 8 to an agreement with Austin Community College to provide childcare quality improvement services, adding two 12-month extension options, each in an amount not to exceed \$51,128, for a revised total agreement amount not to exceed \$356,649.

Amendment No. 7 was a budget amendment to move funds between cost categories in an amount greater than 10% of the total award amount.

Amendment No. 6 exercised renewal Option #4 in the amount of \$51,128 for the period of October 1, 2020 to September 30, 2021.

Amendment No. 5 exercised renewal Option #3 in the amount of \$51,128 for the period of October 1, 2019 to September 30, 2020.

Amendment No. 4 exercised renewal Option #2 in the amount of \$51,128 for the period of October 1, 2018 to September 30, 2019.

Amendment No. 3 added \$1,247 to the agreement for the 12-month period of October 1, 2017 to September 30, 2018, and increased funding by \$1,247 for each remaining extension option.

Amendment No. 2 exercised renewal Option #1 in the amount of \$49,881 for the period of October 1, 2017 to September 30, 2018.

Amendment No. 1 added \$1,121 to the agreement for the 12-month period of October 1, 2016 to September 30, 2017 and increased funding by \$1,121 for each remaining extension option.

The original interlocal agreement was authorized for a 12-month period with Austin Community College to provide childcare quality improvement services in an amount not to exceed \$48,760, with four 12-month extension options each in an amount not to exceed \$48,760, for a total contract amount not to exceed \$243,800.
