Arts & Culture Non-Profit Relief: Background

- **\$2 million** (part of City's American Rescue Plan Act (ARPA) allocation)
- **100** one-time, flat, unrestricted grants of **\$20,000**
- Application period: **July 14 – August 2nd**
- Notifications: Week of August 16th
- Funding distribution: Week of August 23rd
- Changes
 - Not reimbursement driven
 - 100% of awards based on score (Equity, Organization, Urgency)
 - Simplified application

Arts & Culture Non-Profit Relief Applicants


- 217 Total Applicants
 - **196 Eligible**
 - 21 Ineligible (Not Arts & Culture NP; Not 501c3)
- 163 Eligible Applicants are **Cultural Funding Recipients** (83%)
- 45 Eligible Applicants have a **Venue** (23%)
- 15 Eligible Applicants have received **Shuttered Venue Operator** funding (8%)
- 96 Applicants did **not** receive previous NP Relief Grants (49%)

- All applicants were scored against the established Matrix



Equity	<ul style="list-style-type: none">• Demographics of Board (Race/ethnicity; Gender; LGBTQIA; Disability)• Demographics of Executive Director or person serving in a leadership role (Race/ethnicity; Gender; LGBTQIA; Disability; Veteran)	40%
Organization	<ul style="list-style-type: none">• Number of Employees (FTEs)• Annual Revenues• Populations served• Operates a venue/creative space	31%
Urgency	<ul style="list-style-type: none">• Effects from COVID-19 pandemic• Has not received any other City funding• Has not received Shuttered Venue Operations Grant program	29%

AC NP Relief Grant - Board % Gender












