## ORDINANCE NO.

## AN ORDINANCE AMENDING THE NUMBER OF SPECIAL EVENTS DAYS AT ZILKER METROPOLITAN PARK FOR THE 2021 TRAIL OF LIGHTS EVENT.

## BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

## **PART 1.** FINDINGS. The council finds the following:

- 1. The annual Trail of Lights event occurs in December annually and is a partnership with the City of Austin ("Trail of Lights Event");
- 2. An unprecedented pandemic, COVID -19, has affected the globe and created enhanced safety requirements and significant planning which has affected live events world-wide;
- 3. Planning for large events in any year requires significant dependable variables to allow for appropriate organization, promotion and publication of event details;
- 4. A traditional in-person event is not possible, safe or in alignment with protecting the community's health;
- 5. For the 2021 event year, a drive-through event may be the only safe way for Austinites to enjoy holiday activities;
- 6. The timeline needed to plan a successful event that can accommodate a modified number of attendees in vehicles requires advance approval of the maximum number of event nights possible to ensure a meaningful experience for the maximum number of Austinites possible in a drive-through event;
- 7. The Trail of Lights Event must obtain Austin Public Health's approval as well as comply with City's special event permitting process;
- 8. Approximately 1,300 cars per event night can be safely accommodated in a drive-through model;
- 9. A drive-through event will allow Barton Springs Road, FM 2244 and Texas Loop 1 (MoPac) access roads to remain open;
- 10. A drive-through event will allow existing Trail of Lights Foundation programs such as "STARS Nights" to continue;
- 11. The Trail of Lights Foundation will not assess an admission fee in 2021 if the event is drive-through; and

12. Due to the extenuating and unprecedented circumstances, this ordinance provides a viable option for the 2021 Trail of Lights Event, which is a large and important community event, should local conditions fail to improve.

**PART 2.** For the reasons described above, council amends section 8-1-15(C)(1) (*Limits on Special Events*) to authorize up to 15 additional event days for the 2021 Trail of Lights Event. This amendment authorizes the 2021 Trail of Lights Event to use Zilker Metropolitan Park for a maximum of 30 days if Austin's stage of risk is Stage 3, 4, or 5 as set forth in Austin Public Health's risk-based guidelines and the 2021 Trail of Lights event:

(a) is drive-through only; and

(b) complies with all other special event requirements, including approval from Austin Public Health.
