WHEREAS, the City of Austin, Texas has a long lasting and exceedingly beneficial sister city relationship with the City of Saltillo, Coahuila, Mexico recognized in 1968 by City Council Resolution No. 681107-8; and,

WHEREAS, the City of Austin owns numerous items of medical, public health and public safety equipment, supplies, and materials, which it finds to be surplus, and are not being used, nor are they expected to be used by the City of Austin, and it desires to sell or donate them; and,

WHEREAS, the City of Saltillo has an urgent need for such equipment for its local hospitals and emergency response units as it continues to fight against the COVID-19 global pandemic; and

WHEREAS, the City of Austin desires to continue fostering friendly relations and understanding between the citizens of Austin and with the citizens of Saltillo through the donation or sale of such surplus equipment, supplies, and materials to the City of Saltillo; and

WHEREAS, the Council finds there is a public purpose in helping others to defend against the global pandemic; NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

The City Manager is directed to establish and implement a procedure for the disposition of surplus medical, public health and public safety equipment, supplies, and other materials, listed on Exhibit A, attached and incorporated herein by reference, to sister city Saltillo, Coahuila, Mexico that assures:

1. Requests for surplus are made by an official representative of the entity requesting surplus;

- 2. Marks, patches, symbols, logos, and seals identifying items as the property of the City of Austin are removed before disposition;
- 3. If payment is required, payment is made in U.S. funds;
- 4. If payment is required, payment is made within ten working days of notification of agreement to sell at fair market value;
- 5. Transportation costs of equipment, supplies, and materials will be borne by the requesting entity; and
- 6. The City of Austin will not incur additional costs in carrying out this policy.
