Public notice was given for this Request for Qualifications CLMP315 2021 Engineering Services for Power Production Rotation List, through the City's Vendor Connection web portal. Eight firms submitted qualifications statements and responses were opened on July 14, 2021. Of the eight submittals received none of the firms submitting were certified MBE/WBE.

Participation goals stated in the solicitation were 7.67% MBE and 3.64% WBE. The recommended firms provided an MBE/WBE Compliance Plan that met the goals of the solicitation and was approved by the Small and Minority Business Resources Department.
