The second ranked firm provided an MBE/WBE Compliance Plan that met the goals and was approved by the Small and Minority Business Resources Department. Public notice was given for this Request for Qualifications CLMA043, Beverly S. Sheffield Northwest District Park and Montopolis Neighborhood Park Aquatic Facilities project, through the City's Austin Finance Online web portal. Three proposals were received and opened August 4, 2021. Of the three proposals received, none of the firms were certified MBE/WBE. Flintco, LLC was determined to be the best value.
