Thank you all for your service to the City of Austin and the Austin community, it is greatly acknowledged and appreciated.

I'm writing today to go on the record and have my voice heard in opposition to case number (SPC-2021-0131A) and permit number (2021-058117 SP) for the Zilker Cafe that would allow for alcohol to be sold just outside of Barton Springs Pool.

According to the CDC website, alcohol is involved in 70% of drowning deaths.

I am the Executive Director of the local water safety and drowning prevention organization, Colin's Hope. I am also the Co-Chair of the Central Texas Drowning Prevention Action Team, the Vice President of the Safe Kids Austin Board, a Board Member for the Texas Drowning Prevention Alliance and the Co-Chair for the National Drowning Prevention Alliance Advisory Board. All of that to say that I do drowning prevention 365 days a year and often what feels like 24 hours a day. We work around the clock to educate adults and children about things they can do to be safer around water. One of those very simple steps we give is to NOT mix alcohol with swimming. This proposal would undo our work by literally encouraging people to consume alcohol and then go swim in (cold) water while being intoxicated. It is unfathomable and very risky for the swimmers, the lifeguards and the City of Austin.

I would also like to highlight the additional burdens that will be placed upon our incredible City of Austin Aquatics team of life guards and aquatic professionals. These individuals would be asked to act as security guards/bouncers, law enforcers WHILE also trying to remain vigilant, undistracted and attentive to their roles as water safety and drowning prevention professionals. This is unacceptable and again will increase risk for all.

I have trained thousands of life guards and aquatic professionals locally and around the country and I have heard testimonies from them about the incredible stress and challenges when dealing with swimmers who are drinking alcohol. They have shared stories of having to remove an intoxicated person from the facility. AND I have heard and seen and witnessed lifeguards who have made rescues of intoxicated swimmers and have seen the trauma and emotional hardship that results when a lifeguard is unable to save a drowning victim. These are all things that can be prevented.

Drowning is FAST, SILENT AND PREVENTABLE.

The last drowning that occurred at Barton Springs involved alcohol.

Please do your part as leaders in the Austin community to deny this permit so that we can keep our citizens safer around one of the city's crown jewel- Barton Springs.

Thank you for your service on the Planning Commission. Please know you are appreciated.
I'm writing today to oppose alcohol sales just outside of Barton Springs Pool. I spoke against the CUP at both the <u>Community Meeting</u> on June 17 <sup>th</sup> , 2021, the <u>PARD board meeting</u> on June 22, 2021, (where the

board voted 4-2 to NOT RECOMMEND the CUP), and then again a the PARD board meeting on September 28, 2021 (where the board again voted--this time 8-1 to NOT RECOMMEND the CUP).

Not a single Barton Springs staff member or swimmer spoke in favor of this CUP.

More importantly, the PARD board voted twice to not recommend the sale of alcohol at the Zilker Cafe 30 steps from the entrance to Barton Springs. The public has spoken and been heard by the PARD board. Why is this dangerous proposal being discussed yet again?

The city is proposing a galactically bad idea to sell alcohol 30 steps from the pool entrance. (Not to mention 35 feet from the train, and 200 feet from the playground).

Barton Springs is a three-acre pool. On any given summer day there are potentially 3,000 people for the lifeguards to look after and, all too often, rescue. That's without alcohol sales 30 steps from the pool entrance.

Drownings happen fast and require split second decision-making from lifeguards. Imagine delays in their responses if they were mentally worn down by playing bouncer to drunk people all day?

I was actually part of a rescue myself when a drowning swimmer pulled me underwater as I was swimming laps. I had to invoke my lifeguard training to not drown myself and then hold the victim's head above water so he could breathe until a Barton Springs lifeguard could reach him.

This guy had been drinking.

The last death at Barton Springs Pool in 2016 was attributed to alcohol.

This horrifying proposal adds untold burden to already overworked (and understaffed) lifeguards.

I spoke with several lifeguards, and, despite not being able to specifically publicly oppose this proposal, they made their feelings crystal clear. They were angry, stunned, and aghast.

Why would the city make an abhorrent decision to create a new burden on these lifeguards?

Is the city going to pay attention to a KVUE Twitter poll or scientific data and how the lifeguards feel about this decision? Twitter polls and surveys are, to put it mildly, a poor basis for public health policy.

Yes, the alcohol will be sold in Zilker Park, outside the pool gates. That does not stop alcohol from entering the pool in the bodies of people who have access to alcohol 30 steps from the entrance to the pool. "Hey – let's go for a swim" "Wait a sec while I finish my drink" "Well – hurry up, we're going!"

Below my main points of opposition, you'll find references (below the bold line) for the following:

- Statements from Kim McNeeley. Why are we pursuing a CUP based on the survey requests of 16 out of 450 people?
- Transcript of my questions from the Community Meeting on June 17, 2021, followed by Parks staffs' inadequate answers

- Parks staff justifying the CUP based on results from a Twitter poll
- Journal articles about how alcohol consumption contributes to drowning

- o I have obtained this survey. Parks is proposing selling alcohol 30 steps from the entrance to Barton Springs Pool based on <u>3% of people surveyed.</u>
  - I question Kim McNeeley's justification for pushing a proposal forward where 97% of 450 people did not indicate they would purchase alcohol from the cafe.
  - Ask yourself: Why are we pursuing something that 16 out of 450 people requested?
- Listen to the two meetings linked above from start to finish. *Not a single* Barton Springs swimmer is in favor of this CUP.
  - o Barton Springs is a city and national natural treasure, not an amusement park. It is a unique public and ecological resource. *Is selling alcohol consistent with the message we want to send our children about the delicate and rare nature of the Springs?*
- There are other concessions that sell alcohol within PARD property, specifically Alta's Cafe at the Waller Creek Boathouse. The Waller Creek boathouse is for boating, which inherently involves riding on a giant flotation device. That is a very different activity than swimming in Barton Springs. Swimming has been banned in Lady Bird Lake since 1964.

I am writing in opposition to Item B-11 "Zilker Cafe" site permit to authorize beer and wine sales in Zilker Park.

For more than 30 years I have been a daily, year round swimmer at Barton Springs. As the city around us has transformed, Barton Springs has remained relatively unchanged (just don't get me started about water quality and the actual condition of the pool (filled with sediment), however!). Barton Springs is a gathering place for Austinites, it is a place where we join together with friends and families, where we bring out of town guests for a glimpse of a truly unique and uplifting place. It is not and has never been a

destination for dining or drinking—we have ABUNDANT options in Austin for those activities—many just a short distance from the pool.

Barton Springs offers an accessible, affordable place to cool off in spring-fed waters, interact with others in a natural setting, and observe nature. Pool patrons include folks of all ages — from infants and young children to teens and the elderly. They are at the pool to enjoy an outing in an environment that isn't dominated by commercialization, where technology is optional, and where relaxation is the purpose. Alcohol sales would undermine this atmosphere; complicate the workplace for pool staff; introduce conditions for swimmers and visitors that are potentially unsafe; and diminish the natural park setting by converting it into an outdoor cafe setting.

Hello All,

I am writing AGAIN in opposition to selling alcohol at the hot dog stand at Barton Springs Pool.

This is a colossally bad idea. Even though most hot dog patrons will feed their hungry kids and move on, a few will linger for multiple drinks. Just one person who drinks too much can cause injury to another or experience injury him/herself. Consider these:

- 1. Drowning. Alcohol is involved in many drownings. My T-shirt that says "Mothers Against Drunk Diving" brought forth a comment the first time I wore it. A woman told me that her high school class field trip ended in disaster when a teenager who had drunk a beer or two jumped into shallow water and crushed his skull. Alcohol and swimming pools are a dangerous, if not deadly, combination.
- 2. Vehicle accident in parking lot, running over an excited child who gets separated from parents near the pool or train. Small child, not visible in rear view mirror, driver doesn't see him/her. Years of regret.
- 3. Carrying alcohol off hot dog stand property into pool. Current rules do not permit alcohol in the pool, but there's no breathalyzer at the pool entrance. Lifeguards have to deny entrance to people who appear drunk or people with alcohol. These individuals often threaten lifeguards or on occasion lay down and block entrance (as happened recently). We must protect lifeguards from belligerent public.
- 4. Throwing beer and wine receptacles over the fence into the pool, hitting a swimmer on the head, littering bottom of pool with trash. Why would we want that?
- 5. Gunfight or mass shooting, now that guns are legal, and people can get belligerent when they drink.

- 6. Molestation of women. When I wear my "No Perverts at BSP" T-shirt, women approach me with stories about men masturbating while watching them exercise or similar behavior. Alcohol shakes off inhibitions and will make this problem worse. Back in 2017, at 7:40 am, a young man in wetsuit (probably not drunk) assaulted me, a senior citizen, while I was swimming, so I know of what I speak.
- 7. Who will keep order? It takes police a while to respond, especially now that they feel defunded. Who will call the police? How will the hot dog stand keep its patrons on hot dog stand property?
- 8. Alcohol will encourage cigarette smoking, in spite of the pool being a "smoke-free" area. This is a problem for those of us with compromised lungs, because smoke settles like a blanket on the water surface.
- 9. Where will people pee and poop? Hot dog stand has no restrooms, Barton Springs bathhouse has fragile old toilets.

TACB rules forbid alcohol sales within 300 feet of residences, churches, schools, hospitals, day care centers and social service facilities. A family swimming pool, a place for exercise and relaxation, fits logically into the preceding list. The hot dog stand is separated from Barton Springs by ZERO distance and no fence separates it from the pool entrance.
