

ORDINANCE NO.

1 **AN ORDINANCE ANNEXING APPROXIMATELY 242 ACRES OF LAND OUT**
2 **OF THE SANTIAGO DEL VALLE GRANT, LOCATED IN TRAVIS COUNTY,**
3 **TEXAS, AND REFERRED TO AS THE “PILOT KNOB MUNICIPAL UTILITY**
4 **DISTRICT NO. 1, TRACT I”, “PILOT KNOB MUNICIPAL UTILITY DISTRICT**
5 **NO. 4, TRACTS J, L, AND M”; AND “PILOT KNOB MUNICIPAL UTILITY**
6 **DISTRICT NO. 5, TRACT K” FOR THE LIMITED PURPOSES OF PLANNING**
7 **AND ZONING IN ACCORDANCE WITH THE STRATEGIC PARTNERSHIP**
8 **AGREEMENT BETWEEN THE CITY OF AUSTIN AND THE PILOT KNOB**
9 **MUNICIPAL UTILITY DISTRICTS NO.1 , NO. 4 AND NO. 5.**

11 **BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:**

13 **PART 1.** The Council makes the following findings.

- 14 (A) The City of Austin and the Pilot Knob Municipal Utility District No. 1, No. 4
15 and No. 5 (“District”) entered into a Consent Agreement and Strategic
16 Partnership Agreement (“Agreements”) specifying the terms for limited and
17 full-purpose annexation of territory within the District.
- 18 (B) Under the terms of the Agreements, additional land located within the defined
19 Project Area may be added to the District and the City’s limited purpose
20 jurisdiction when the developer acquires fee simple title to those tracts of land.
- 21 (C) The City received documentation that the developer purchased the territory
22 described in **Exhibit A**, referred to as the Pilot Knob Municipal Utility District
23 No. 1, Tract I; No. 4, Tracts J, L, and M; and No. 5, Tract K (collectively
24 “Annexation Area”).
- 25 (D) All procedural requirements imposed by state law and the Agreements for the
26 limited purpose annexation of territory described in **Exhibit A** have been met.
- 27 (E) The limited purpose annexation of this territory serves the interests of the
28 current and future residents of the City of Austin.
- 29 (F) This ordinance extends the City limits to include the Pilot Knob Municipal
30 Utility District No. 1, Tract I, No. 4, Tracts J, L and M; and No. 5, Tract K in
31 accordance with City Charter Article I, Section 7.

32 **PART 2.** As provided by the Agreements, the present boundary limits of the City are
33 amended to include the territory described in **Exhibit A** for the limited purposes of
34 planning and zoning. The territory is within the extraterritorial jurisdiction of the City of
35 Austin in Travis County, Texas.

36 **PART 3.** The City Council declares that its purpose is to annex to the City of Austin
37 each part of the area described in **Exhibit A** as provided in this ordinance, whether any
38 other part of the described area is effectively annexed to the City. If this ordinance is
39 held invalid as to any part of the area annexed to the City of Austin, that invalidity does
40 not affect the effectiveness of this ordinance as to the remainder of the area.

41 If any area or lands included within the description of the area set out in **Exhibit A** are:
42 (1) presently part of and included within the general limits of the City of Austin; (2)
43 presently part of and included within the limits of any other city, town, or village; or (3)
44 are not within the jurisdiction or power of the City of Austin to annex, then that area is
45 excluded and excepted from the area annexed under this ordinance.

BEING all of that called 24.747 acre tract of land conveyed to Carma Easton LLC by Special Warranty Deed recorded in Document No. 2019033881 of the Official Public Records of Travis County, Texas.

TRACT M

BEING all of that 133.355 acre tract of land being all of the called 56.135 acre tract of land referred to as "Parcel 1" and all of that called 77.220 acre tract of land referred to as "Parcel 2" conveyed to Carma Easton LLC by Special Warranty Deed with Vendor's Lien recorded in Document No. 2018130093 of the Official Public Records of Travis County, Texas.
