PART 1. Council amends the Exhibit A to the Fiscal Year 2021-2022 City of Austin Fee and Fine Ordinance (Ordinance No. 20210811-002) to reduce the fire alarm system plan review and fire sprinkler plan review fees for 1-10 devices as set forth in Exhibit A of this Ordinance. This includes reducing the fire alarm system plan review fee for 1-10 devices from \$117 to \$58 and reducing the fire sprinkler plan review fee for 1-10 devices from \$204 to \$58.
