Funding for the remaining contract term is contingent upon available funding in future budgets.

Purchasing Language:

The Financial Services Department issued an Invitation for Bids (IFB) 8600 SLW1055 for these services. The solicitation was issued on August 16, 2021 and it closed on September 9, 2021. Of the four offers received, the recommended contractor submitted the lowest responsive offer. Additionally, Austin Public Health will utilize the contract due to the demand to provide alternative methods of maintaining hygiene for vulnerable populations throughout the City.
