ANALYSIS / ADDITIONAL INFORMATION: This budget amendment is in response to Resolution No. 20211014-046 related to accommodate the resources and staff needed to continue virtual testimony and hybrid participation of Council Members, Board and Commission Members, and Subcommittee members. This includes three new positions within the Support Services Fund; one Administrative Specialist position in the Office of the City Clerk and two Video Production Specialist Senior positions in the Communications and Public Information Office. Additionally, two IT Support Analysts positions within the Information and Technology Fund for the Communications and Technology Management (CTM) Department are also required. This action only increases the number of authorized positions and does not impact Fiscal Year 2021-2022 appropriation levels. The personnel costs for the five positions are anticipated to be absorbed by these departments for FY 2022. Annualized funding of \$453,058 for these positions will be included as part of the FY 2023 budget process.
