- 4. PAC New Member Orientation, Selection of Full Member and Objective setting for 2022-** PAC members unanimously voted for members Patricia Schaub and Garrett Hall to replace members Stephanie Webb and Andrew Glazner, who both resigned from the PAC. Members unanimously approved the vote on a 8-0 vote with Riegel and Glazner absent. PAC members reviewed the PAC 2022 orientation document and briefly discussed objectives for 2022.
