- AHFC2.** Approve an inducement resolution related to an application for private activity bond financing that authorize an allocation of up to \$20,000,000 in private activity volume cap multi-family non-recourse bonds to Cairn Point Austin at Springdale, LP, or an affiliated entity, for a proposed affordable multi-family development to be known as Cairn Point, located at 5612 Springdale, Austin, Texas 78723.
