**AHFC1.** Approve a resolution adopting the Austin Housing Finance Corporation Capital Budget for Fiscal Year 2021-2022 in the amount of \$97,342,903; authorizing the development of program guidelines; and establishing administrative approval limits for the general manager.

**Resolution No. 20210811-AHFC001 was approved on consent on Vice President Harper-Madison's motion, Directors' Ellis' and Renteria's second on an 11-0 vote.**

**AHFC2.** Approve a resolution adopting the Austin Housing Finance Corporation Grant Operating Budget for Fiscal Year 2021-2022 in the amount of \$8,396,231 and the Housing Assistance Fund Budget for Fiscal Year 2021-2022 in the amount of \$5,225,000 for a total budget of \$13,621,231; authorizing the development of program guidelines for the named housing programs for Fiscal Year 2021-2022; authorizing the transfer of budget amounts under certain conditions; and establishing administrative approval limits for the general manager.

**Resolution No. 20210811-AHFC002 was approved on consent on Vice President Harper-Madison's motion, Directors' Ellis' and Renteria's second on an 11-0 vote.**
