# Arts & Culture Non-Profit Relief: \$3.92m

---

- **\$2 million** (part of City's American Rescue Plan Act (ARPA) allocation)
  - **100** one-time, flat, unrestricted grants of **\$20,000**
  - Notifications: Week of August 16th; Funding distribution: Week of August 23rd
- Additional Funds added and distributed 11/23/2021
  - **\$1 million** Council Approved Budget Amendment (50 awards)
  - **\$420,000** ARPA (21 awards)
- Additional Funds added and approved by council 12/9/2021
  - **\$500,000** (25 awards)
  - COA executed contract 12/22/21; BBB invoiced 12/27/21
  - **Checks cut and mailed on 12/31/21!**
  - CM Alter asked us to “act with expediency... ideally by December 31, 2021” = success!

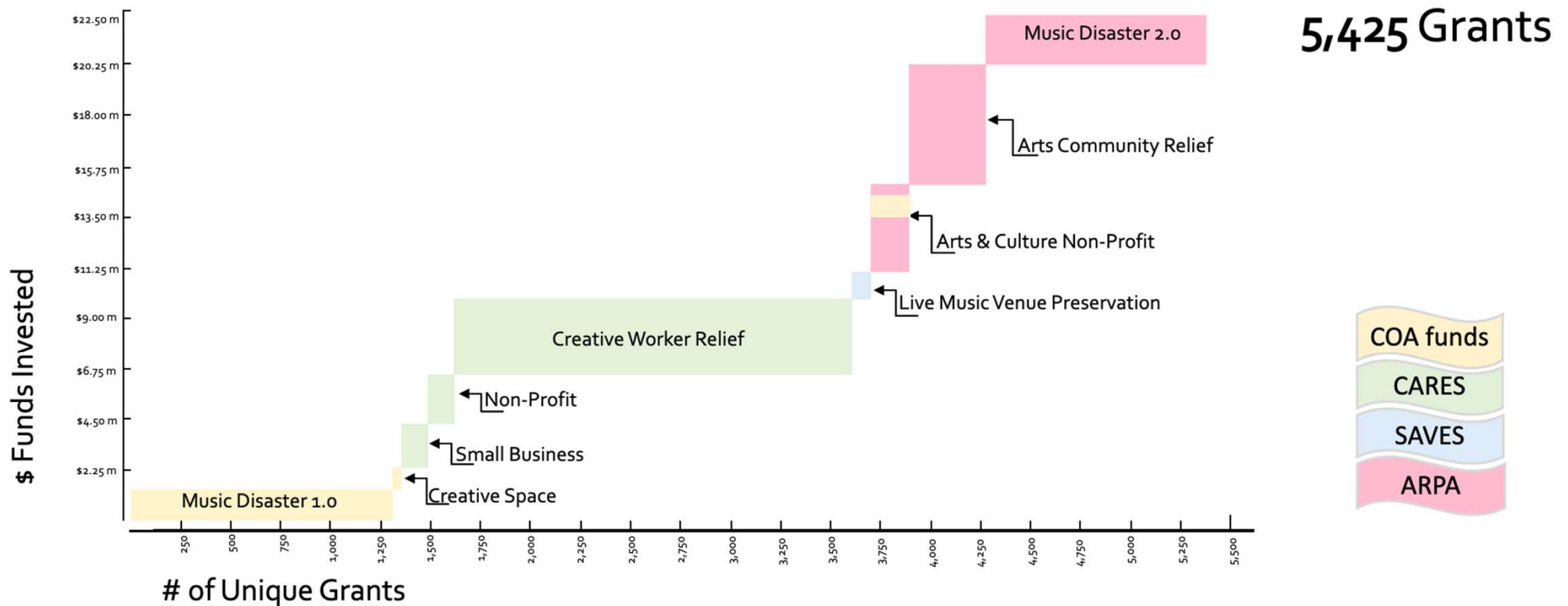
# Arts Community Relief (ARPA): \$5.32m

---

- Council approved fund allocations - November 18, 2021
- Pivot to third party announced– December 15, 2022
- Notification to cultural contractors from COA – December 17, 2022
- Award emails/ links sent from BBB\* – December 22, 2022
- Purchasing finalized contract with third party – January 13, 2022
- BBB invoiced – January 18, 2022
- Funds received by BBB; 335 checks (\$5m) cut & mailed – January 21, 2022

\*22 contractors (\$71,702.10) received funding from COA directly before we pivoted to BBB.
