

## M/WBE Summary

Public notice was given for this solicitation, CLMC865 Jain Lane Street Realignment, through the City's Vendor Connection web portal. Three bids were received and opened on December 16, 2021. Of the three of bids received, one bid was from an MBE/WBE certified firm. Austin Underground, Inc. submitted the lowest responsive bid:
