

# Bipartisan Infrastructure Law (BIL or IIJA)



- Reauthorizes USDOT, extends funding for some programs, and creates new programs for 5 years
- New relevant programs:
  - Safe Streets for All
  - Reconnecting Communities
- New policy emphases:
  - Safety
  - Equity
  - Environmental Justice (EJ)
  - Multi-modal
  - Jobs

## RAISE

(Formerly Build Grant)

- Capital and planning grants for nationally or regionally significant projects
- PWD applied in 2019 and 2020 for the Redbud Trail bridge (Not Awarded)
- EDD applied for Colony Loop in 2018 (Not Awarded)

## SMART

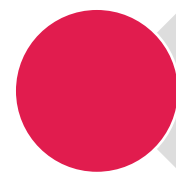
- Demonstration projects in the area of Intelligent Transportation Systems
- ATD pursued the 2015 SMART City Grant - (Awarded Finalist Stipend but ultimately Not Awarded Grant status)
- ATD applied in 2018 for a traveler information system (Not Awarded)

## CAMPO

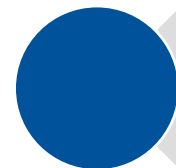
- ATD and PW previously applied and were awarded \$80M in 2017 CAMPO grants, but projects rescinded to award money to I-35 project
- Active Grants:
  - ✓Lakeline Blvd.
  - ✓Braker Lane
  - ✓W. Rundberg
  - ✓Slaughter
  - ✓William Cannon
- ATD actively working with CAMPO towards next grant cycle



# RAISE Grant (TIGER): Pittsburgh I-579 Cap



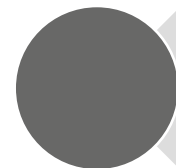

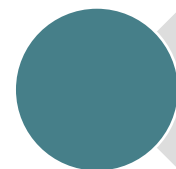

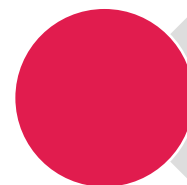

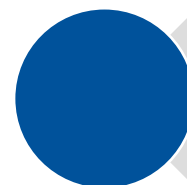

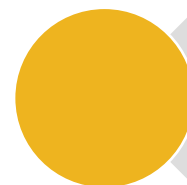
# SMART: Dallas S.M. Wright Corridor



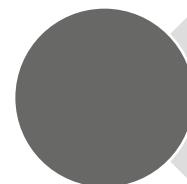

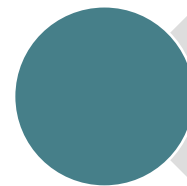

boulevard in South Dallas

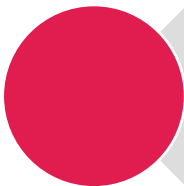
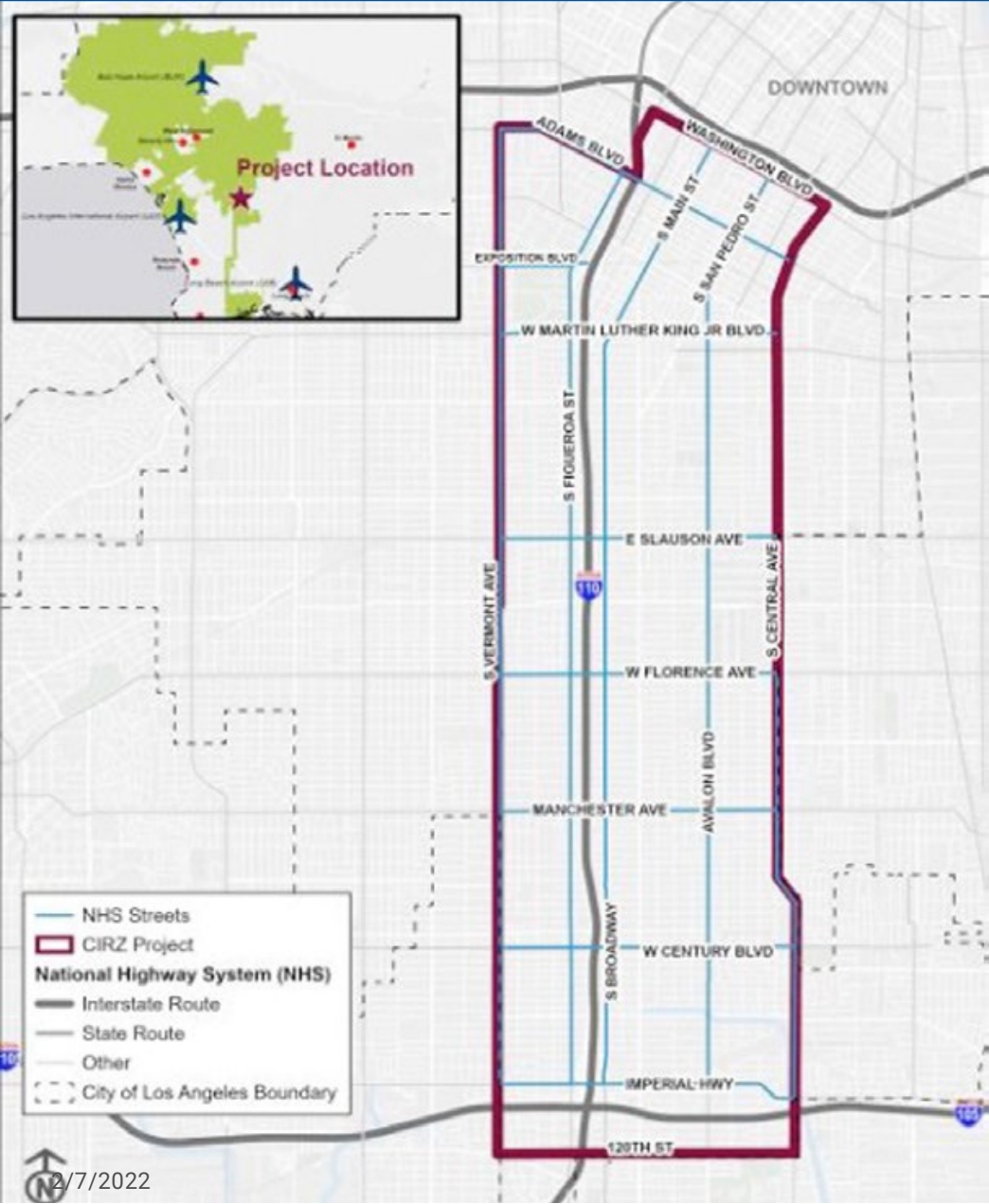


Connected vehicle infrastructure

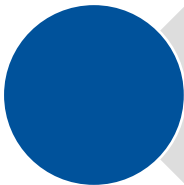

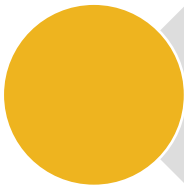
# INFRA: Los Angeles Community Infrastructure and Resiliency Zone Safe Streets Component



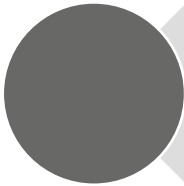

(70% Local Match Provided)



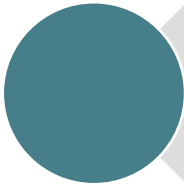

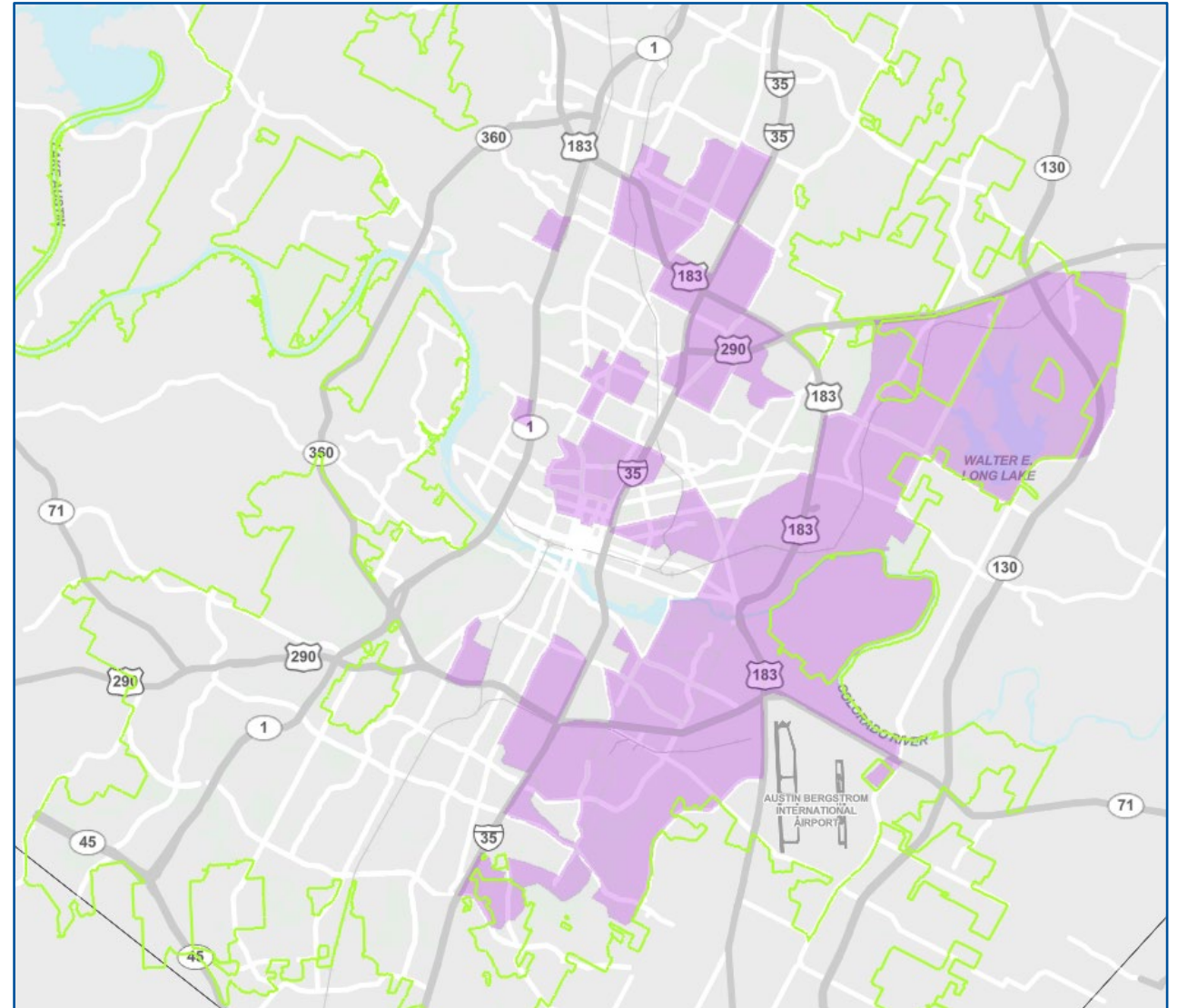
# US DOT Areas of Persistent Poverty

Current areas of persistent poverty shaded in violet

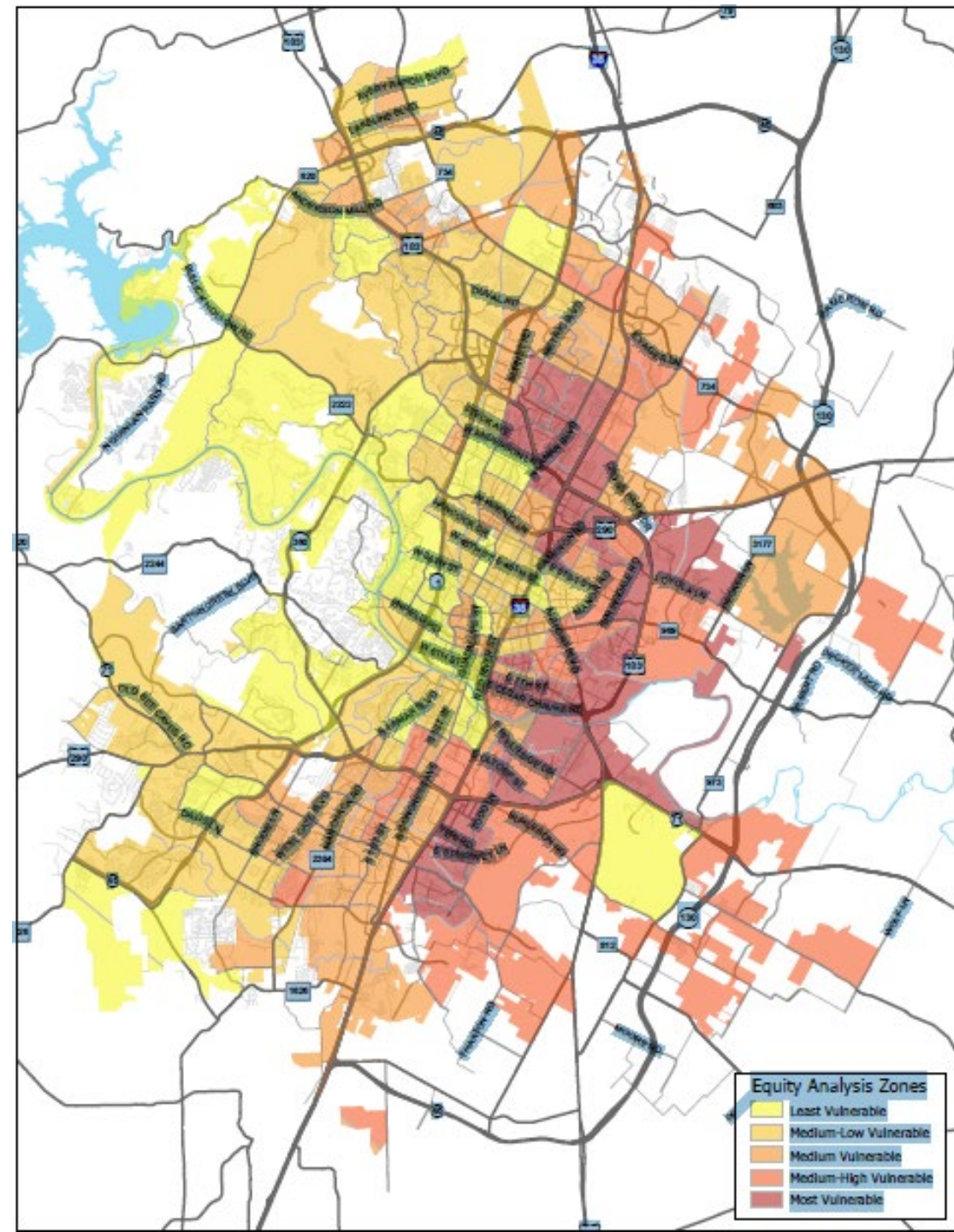


2020 USDOT analysis of Census data, visualization by ATD OOD

# ATD's Equity Analysis Zones

## Variables:

- People of Color
- Black/Indigenous/Latinx
- Median Household Income
- On Food Stamps/SNAP
- Rent over 35% of monthly income
- Without broadband internet
- Less than 1 vehicles per working occupant
- Has a disability
- Senior (65+)



# Strategic Plan to Win Grants



Identify projects that meet DOT emphases

Safety, Equity, Environmental Justice, Multi-modal, Jobs

Create high probably list amongst Dept.'s

Ensure COA is solidly focused on key projects, not competing against itself

Dedicate resources to develop proposals

Includes project purpose, scope, schedule, budget, community support, demographics, job and equity impact

Seek Council, U.S. Rep. support

Coordinate Regionally

Confirm matching funds and source

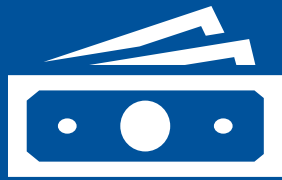
Refine proposal once NOFO issued



# Strategic Plan to Win Grants



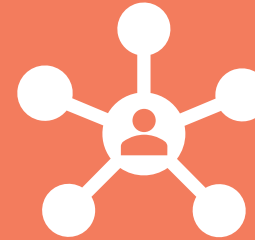
“Shovel Ready” is still a thing



Bond projects are good candidates for federal grants due to available match monies



Federalizing a Bond project can add several years (contracts & processes) to a project completion date



Congress members receive multiple requests from entities in same city/region

Regional significance important



Competitive grants offer closer to 50% match vs 20% required

# Just “One” Thing

## 1

- Submit **one** competitive project per grant category per year
- USDOT: Austin and region often competes against itself
- USDOT and US Reps not likely to pick two projects in same area
- Suggest: Unite behind **one** project

# Recap



US DOT releases NOFOs (Notice of Funding Opportunity) by categories at different dates

Departments to coordinate on most eligible projects

Preparing projects requires committed time and resources

Advice: Pursue larger projects

Substantial match: 20 - 50% needed

Garner Council/Cmtty Support

RCA for match monies before Apr. 14

On-going mobility grant coordination

Prepare, refine 1-5 year grant cycle
