Public notice was given for this solicitation, CLMC882 and Waller Creek - 4th St. Creek Side Inlet Temporary Wall Replacement Project, through the City's Vendor Connection web portal. Four bids were received and opened on January 27, 2022. Of the four bids received zero bids were from MBE/WBE certified firms. Jay-Reese Contractors, Inc. submitted the lowest responsive bid:
