Posting Language

Conduct a public hearing related to an application by Northwind Apartments, LP, or an affiliated entity, for housing tax credits for a multi-family development to be financed through the private activity bond program and to be known as Northwind Apartments, located at or near 11122, 11204, 11208, and 11216 Cameron Road, Austin, Texas 78754, within the City, and consider a resolution related to the proposed development, the application, and the allocation of housing tax credits and private activity bonds.

No funding from the City of Austin or the Austin Housing Finance Corporation is being requested. This item has no fiscal impact.

Prior Council Action:

March 24, 2022 - Council set a public hearing for April 7, 2022, related to an application by Northwind Apartments, LP for housing tax credits for a multi-family development that will be financed through the private activity bond program.

This action conducts a public hearing to receive public comment on an application that will be (or has been) submitted to the Texas Department of Housing and Community Affairs (TDHCA). The Applicant, Northwind Apartments, LP, or an affiliated entity, seeks funding for the development through 4% Low Income Housing Tax Credits (LIHTCs) and private activity bonds. The property is located within the City in council district 1.

After the public hearing, Council will consider a resolution of no objection about the proposed development, the application, and, if necessary, the allocation of housing tax credits and private activity bonds.

Proposed Development

Northwind Apartments, LP, which is affiliated with Kittle Property Group, Inc., plans to develop a 240-unit multifamily development to be located at 11122, 11204, 11208, and 11216 Cameron Road, Austin, Texas 78754. The community will be affordable to households earning at or below 70% of the Austin Median Family Income (MFI). The intended target population of the development is the general population. The development is proposed to be partially funded with 4% LIHTCs and tax-exempt bonds issued by Travis County Housing Finance Corporation (TCHFC). The general partner of the development's partnership will be an affiliate of TCHFC. Because of the affiliation with TCHFC, the property will be exempt from paying property tax. No funding from the Austin Housing Finance Corporation is being requested.
