ANALYSIS / ADDITIONAL INFORMATION: This item amends the FY 2021-22 Austin Convention Center Department (ACCD) Tourism and Promotion Fund to provide necessary funding to the Austin Convention and Visitors Bureau, doing business as Visit Austin. Visit Austin has experienced a significant decrease in funding as a result of the COVID-19 pandemic, which has led to staff furloughs and a reduction in programming and marketing of the City of Austin as a destination.

In review of potential funding for the Austin Convention and Visitors Bureau, doing business as Visit Austin, staff identified a combined total of \$1,082,155 in prior-year unexpended funds beyond what was estimated within the ACCD Tourism and Promotion Fund. Approval of this item will allow ACCD to utilize these prior-year funds in the current fiscal year to increase contractual funding to Visit Austin by a total of \$1,082,155. A companion Resolution agenda item to amend the FY 2021-22 Marketing Plan and Approved Budget for Visit Austin will accompany this budget amendment.
