Additional Backup Information:

On March 6, 2020, a Declaration of Local Disaster was issued by Mayor Adler to allow the City to take measures to avoid the spread of the Coronavirus (COVID-19) across the City and County. On March 13, 2020, Governor Abbot issued a Declaration of State of Disaster that allowed for additional steps to prepare for, respond to, and mitigate the spread of COVID-19. The COVID-19 response is ongoing.

The response by the City has required temporary housing agreements, alternative care sites, both large testing and large vaccination operations, as well as tasks in support of special at-risk populations. To provide for goods and services urgently needed to respond to these emergencies, multiple contracts were executed. This item is for contracts that exceeded the City Manager's authority.
