- •Once a request to speak has been called in or emailed to the board liaison, residents will receive either an email or phone call providing the telephone number to call on the day of the scheduled meeting.
- •Speakers must call in at least 15 minutes prior to meeting start in order to speak, late callers will not be accepted and will not be able to speak.
- •Speakers will be placed in a queue until their time to speak.

6. CARE STRATEGIES

- a. Service Standards Training
 - Aka Standards of Care
 - Elements and expectations for implementing services
 - Governed by HRSA
- b. Updating the LPAP service standard
 - Local AIDS Pharmaceutical Assistance
 - Provides ongoing medication assistance not covered by ADAP
 - EFA covers medication in short term not covered by ADAP and LPAP
 - i. Remove requirement about ADAP denials
 - LPAP provider indicated delay in Texas HIV medication program processing applications (8-12 weeks), clients waiting for medication
 - Service standard says clients must apply for ADAP first
 - Want to alleviate burden on EFA
 - Proposal to remove ADAP denial requirement to access LPAP
 - EFA is currently only being used to fund medication, but per service standard, can be used to fund other items
 - Needs to be brought to full Business meeting/PSRA
 - Only currently funded EFA providers can use these funds, although others have ADAP but not EFA
 - Committee would like to know what actual need around emergency medicine is
 - AA can distribute questions from Planning Council to providers
 - Proposal to change wording in service standard to allow LPAP to start if
 ADAP is delayed by a certain amount of time (TBD)
 - May be window of people who do not need ADAP denial (income 200-500%)
 - Committee would like more information before changing wording
 - o LPAP, ADAP, EFA formularies
 - o Jaseudia will draft language changes
 - Ask subrecipients for timelines on applications

- THMP advisory committee meeting this Friday possible to make public comment in future months
- No vote this meeting
