6 7 8 9 10	<b>PART 1.</b> On April 11, 2019, the City Council approved Ordinance No. 20190411-033 adopting the Austin Strategic Mobility Plan (ASMP) as an amendment to the Imagine Austin Comprehensive Plan. On June 10, 2020, the City Council initiated amendments to the ASMP to add the Project Connect System Plan and associated technical elements.
11 12	<b>PART 2</b> . The council finds, in accordance with Article X of the Charter of the City of Austin, the following:
13 14	(1) on May 10, 2022, the Planning Commission held a public hearing and recommended the proposed amendments to the ASMP; and
15 16	(2) on May 19, 2022, the council held a public hearing on the proposed amendments.
17 18	<b>PART 3.</b> The Council amends Part 3 of Ordinance No. 20190411-033 to add a new Subsection (d) to read as follows:
19 20 21 22 23 24 25 26 27	Part 3(d) Nothing in the ASMP limits the City's Traffic Engineer's authority to make certain operational changes to a roadway within the right of way to improve safety and mobility. Accordingly, a change to the Street Network Table that does not impact the adopted right of way widths is not considered a roadway addition, deletion, change in classification, or change of alignment that requires an amendment to the Imagine Austin Comprehensive Plan. The Director of the Austin Transportation Department or his successor in function is required to coordinate with Capital Metro for changes to the roadway that include transit priority treatments and dedicated pathways.
28 29 30	<b>PART 4.</b> In accordance with Article X of the Charter of the City of Austin, the council adopts the amended ASMP, attached as Exhibit "A" to this ordinance, and amends the Imagine Austin Comprehensive Plan.
