Pursuant to the 2022 Austin Energy Base Rate Review Procedural Guidelines § C(2)(a), no confidential materials should be involved in any filings. Pursuant to the 2022 Austin Energy Base Rate Review Procedural Guidelines § C(2)(b), no personally identifiable information, including but not limited to social security numbers, driver's license numbers, account numbers, account usage data, or any other data that might compromise a person's privacy, should be included in any filings. Further, pursuant to Texas Government Code Section 552.137, an e-mail address of a member of the public that is provided for the purpose of communicating electronically with a governmental body is confidential and not subject to disclosure. Pursuant to the 2022 Austin Energy Base Rate Review Procedural Guidelines § G(1)(a), the Impartial Hearing Examiner does not have the authority to issue protective orders.

The City of Austin Law Department has reviewed the RFIs listed above and determined that responsive Austin Energy information is considered confidential customer information and confidential under Texas Government Code Section 552.137 which Austin Energy cannot legally disclose.
