**BYLAWS OF THE
AIRPORT ADVISORY COMMISSION**

ARTICLE 1. NAME.

The name of the commission is the Airport Advisory Commission (AAC).

ARTICLE 2. PURPOSE AND DUTIES.

- (A) The AAC reviews, assesses, and makes recommendations to the Austin City Council concerning the Austin-Bergstrom International Airport (AUS):
- Capital improvement projects,
 - Proposed aviation grants,
 - Proposed aviation contracts,
 - Annual operating budgets, and
 - Quality of services and customer experience.
- (B) In its recommendations, the AAC ensures consistency with good business practices, integrity, and the values of the City of Austin and AUS, including:
- Safety,
 - Public service and engagement,
 - Responsibility and accountability,
 - Innovation and sustainability,
 - Diversity and inclusion, and
 - Ethics and integrity.
- (C) The AAC advises and offers help to solve problems and advance the mission and initiatives of AUS.
- (D) The AAC brings public input to the airport leadership and engages community stakeholders as needed to promote public awareness and good decision making.
- (E) The AAC facilitates and promotes communication between AUS staff and the Austin City Council.
- (F) In all their work, members of the AAC advocate the interests of the airport's customers, City of Austin public, and the Austin City Council.

ARTICLE 3. MEMBERSHIP.

- (A) The Commission is composed of eleven members appointed by the city council.
- (B) A member serves at the pleasure of the city council.
- (C) Commission members serve for a term of four years beginning March 1st on the year of appointment.
- (D) An individual Commission member may not act in an official capacity except through the action of the Commission.
- (E) A Commission member who is absent for three consecutive regular meetings or one-third of all regular meetings in a “rolling” twelve month timeframe automatically vacates the member’s position subject to the holdover provisions in Section 2-1-27 of the City Code. This does not apply to an absence due to illness or injury of the Commission member, an illness or injury of a Commission member’s immediate family member, active military service, or the birth or adoption of the Commission member’s child for 90 days after the event. The Commission member must notify the staff liaison of the reason for the absence not later than the date of the next regular meeting of the Commission. Failure to notify the liaison before the next regular meeting of the Commission will result in an unexcused absence.
- (F) At each meeting, each Commission member shall sign an attendance sheet which indicates that the member does not have a conflict of interest with any item on that agenda, or identifies each agenda item on which the member has a conflict of interest. Failure to sign the sheet results in the member being counted as absent and his/her votes are not counted.
- (G) A member who seeks to resign from the Commission shall submit a written resignation to the chair of the Commission, the staff liaison, or the city clerk’s office. If possible, the resignation should allow for a thirty day notice so the city council can appoint a replacement.

ARTICLE 4. OFFICERS.

- (A) The officers of the Commission shall consist of a chair, ~~and~~ a vice-chair, and a secretary.
- (B) Officers shall be elected annually by a majority vote of the Commission at the first regular meeting after April 1st. In the event a current officer becomes ineligible to serve as an officer, the Commission may hold an emergency election as needed.
- (C) The term of office shall be one year, beginning May 1st and ending April 30th. An officer may continue to serve until a successor is elected. A person may not serve as an officer in a designated position of a Commission for more than four consecutive one-year terms. A person who has served as an officer in a designated position of a Commission for four consecutive terms is not eligible for re-election to that designated office until the expiration of two years after the last date of the person’s service in that office. The Commission may override the term limit provision for an officer by an affirmative vote of two- thirds of the authorized Commission members.
- (D) A member may not hold more than one office at a time.

3 **ARTICLE 5. DUTIES OF OFFICERS.**
4

- 5 (A) The chair shall preside at Commission meetings, appoint all committees, represent the Commission
6 at ceremonial functions and approve each final meeting agenda.
7
8 (B) In the absence of the chair, the vice-chair shall perform all duties of the chair. In the absence of the
9 chair and vice chair, the secretary shall perform all duties of the chair.
10

12 **ARTICLE 6. AGENDAS.**
13

- 14 (A) Two or more Commission members may place an item on the agenda by oral or written request to
15 the staff liaison at least five days before the meeting. After first consulting with and receiving input
16 from the staff liaison, the chair shall approve each final meeting agenda.
17
18 (B) The Commission liaison shall submit the meeting agenda through the online agenda posting system
19 for each meeting not less than 72 hours before the meeting.
20
21 (C) Posting of the agenda must comply with Texas Government Code Chapter 551 (Texas Open
22 Meetings Act).
23

25 **ARTICLE 7. MEETINGS.**
26

- 27 (A) The board meetings shall comply with Texas Government Code Chapter 551 (Texas Open
28 Meetings Act).
29
30 (B) Commission meetings shall be governed by Robert's Rules of Order.
31
32 (C) The Commission may not conduct a closed meeting without the approval of the city attorney.
33
34 (D) The Commission shall meet monthly. In November of each year, the Commission shall adopt a
35 schedule of the meetings for the upcoming year, including makeup meeting dates for the holidays
36 and cancelled meetings.
37
38 (E) The chair may call a special meeting, and the chair shall call a special meeting if requested by three
39 or more members. The call shall state the purpose of the meeting. A Commission may not call a
40 meeting in addition to its regular scheduled meetings as identified in its adopted meeting schedule,
41 more often than once a quarter, unless the meeting is required to comply with a statutory deadline
42 or a deadline established by Council.
43
44 (F) Six members constitute a quorum.
45
46 (G) If a quorum for a meeting does not convene within one-half hour of the posted time for the meeting,
47 then the meeting may not be held.
48

- 1 (H) To be effective, a Commission action must be adopted by an affirmative vote of the number of
2 members necessary to provide a quorum.
3
4 (I) The chair has the same voting privilege as any other member.
5
6 (J) The Commission shall allow citizens to address the Commission on agenda items and during a
7 period of time set aside for citizen communications. The chair may limit a speaker to three minutes.
8
9 (K) The staff liaison shall prepare the Commission minutes. The minutes of each Commission meeting
10 must include the vote of each member on each item before the Commission and indicate whether a
11 member is absent or failed to vote on an item.
12
13 (L) The city clerk shall retain agendas, approved minutes, internal review reports and bylaws. The
14 Aviation Department shall retain all other Commission documents. The documents are public
15 records under Texas Local Government Code Chapter 552 (Texas Public Information Act).
16
17 (M) The chair shall adjourn a meeting not later than 10 p.m., unless the Commission votes to continue
18 the meeting.
19
20 (N) Each person and Commission member attending a Commission meeting should observe decorum
21 pursuant to Section 2-1-48 of the City Code.
22
23 (O) A member of the public may not address a Commission at a meeting on an item posted as a briefing.
24

25 **ARTICLE 8. COMMITTEES/WORKING GROUPS.**

26 **COMMITTEES**

- 27
28
29 (A) The Airport Advisory Commission will have no committees.
30
31 (B) Each committee must be established by an affirmative vote of the Commission. A committee
32 cannot meet until its creation is approved by the Council Audit and Finance Committee. Each
33 committee shall consist of at least three Commission members appointed by the chair. A staff
34 member shall be assigned to each committee by the director of the Department of Aviation.
35
36 (C) The Commission chair shall appoint a Commission member as the committee chair, with the
37 member's consent.
38
39 (D) A majority of the total number of appointed committee members constitutes a quorum.
40
41 (E) Each committee shall meet on a regularly scheduled basis at least quarterly.
42
43 (F) Each committee shall make an annual report to the Commission at the January Commission
44 meeting.
45
46 (G) Committee meetings must be posted in accordance with Texas Government Code Chapter 551
47 (Texas Open Meetings Act).
48

- 1 (H) At each committee meeting, a committee member shall sign in on a sheet provided and shall
2 indicate that the member has no conflict of interest with any item on the committee meeting agenda,
3 or identify each agenda item on which the member has a conflict of interest.
4
5

6 **WORKING GROUPS**
7

- 8 (A) The Commission can determine the size of a working group but the number of Commission
9 members serving on the working group must be less than a quorum of the Commission.
10
11 (B) A working group may designate a chair, with the member's consent, but is not required to do so.
12
13 (C) Quorum requirements do not apply to working groups.
14
15 (D) Staff support will not be provided for working groups.
16
17 (E) Working groups are not required to post their meetings in accordance with the Texas Government
18 Code Chapter 551 (Texas Open Meetings Act).
19
20

21 **ARTICLE 9. PARLIAMENTARY AUTHORITY.**
22

23 The rules contained in the current edition of Robert's Rules of Order shall govern the Commission
24 in all cases to which they are applicable, except when inconsistent with these bylaws or with special
25 rules of procedure which the Commission or city council may adopt.


27 **ARTICLE 10. AMENDMENT OF BYLAWS.**
