## **PROPOSAL**

---

Remodel a ca. 1893 house. Expand existing wood deck to the rear, modify existing front porch, modify window openings at various locations throughout, replace windows throughout, replace existing wood siding.

## **PROJECT SPECIFICATIONS**

---

- 1) Construct a wood deck at the rear of the house.
- 2) Remodel main façade. Proposed changes include removal and replacement of porch posts, changes to dimensions of decking, installation of a planter, and addition of multiple wider sets of stairs.
- 3) Replace existing metal roof with new metal roof.
- 4) Replace existing horizontal wood siding with vertical fiber cement siding throughout.
- 5) Change window openings in multiple locations and replace windows throughout. Proposed new windows are vertically oriented casements and horizontal fixed windows, placed irregularly throughout.

## **ARCHITECTURE**

---

The house at 1400 Garden St is a single-story L-plan National Folk style with a cross-gabled metal roof and wood siding. The existing windows are not original.

## **RESEARCH**

---

Columbus W. Moore built the house located at 1400 Garden Street in the early 1890s. Moore lived in the house for roughly 20 years where he worked as a carpenter and contractor, utilizing his home as his office. Moore served as a City alderman during his time in the home. He was a prolific builder, landing contracts to build at the Travis County fairgrounds, the City's water settling basin, a Southwestern Telegraph and Telephone exchange building, and the Confederate Women's Home, among others. He served as president of Austin's Builder's Exchange group, hosting contractor conventions and organizing events for local professionals.

The house was then occupied by various tradesmen from 1912-1920, including a contractor, miller, and blacksmith.

From 1927-35 James and Elvira Sylvester lived in the house. After James Sylvester passed away in the early 1930s, his wife continued to live in the house until 1941. The house was rented briefly in the 40s before being bought by Pedro and Esther Tamayo. The Tamayo family owned the house from 1947-1952, and Sterling and Eula Borders owned it from 1955-1957.

## **DESIGN STANDARDS**

---

The City of Austin's [Historic Design Standards](#) (March 2021) are based on the Secretary of the Interior's Standards for Rehabilitation and are used to evaluate projects at potential historic landmarks. The following standards apply to the proposed project:

### Residential additions

#### 1. Location

The proposed changes are located at the front and rear of the house. Window openings and replacements will occur on all sides of the house.

#### 2. Scale, massing, and height

The proposed work does not affect the scale, massing, or height.

#### 3. Design and style

The extension of the rear deck is compatible. The proposed modification of the front porch and window openings at the front of the house create major visual impacts and are not compatible.

#### 4. Roofs

The replacement of the current roofing material with new metal roof is compatible.

#### 5. Exterior walls

Replacing the existing horizontal wood siding with the proposed vertical Hardie siding throughout is not compatible.

#### 6. Windows, screens, and doors

The proposed window openings and replacement windows on the East, West, and South elevations are not compatible.

#### 7. Porches and decks

The proposed extension of the rear deck is compatible. The proposed modification of the front deck is not compatible.

#### Summary

The project does not meet the applicable standards.

### **PROPERTY EVALUATION**

---

The 2016 East Austin survey recommends the property as contributing to potential local and National Register historic districts.

#### *Designation Criteria—Historic Landmark*

- 1) The building is more than 50 years old.
- 2) The building appears to retain high integrity.
- 3) Properties must meet two criteria for landmark designation (LDC §25-2-352). Staff has evaluated the property and determined that it may meet two criteria:
  - a. Architecture. The building is a good example of National Folk architecture.
  - b. Historical association. The building is associated with alderman and contractor Columbus W. Moore of the Austin Builders' Exchange, serving as his home and business.
  - c. Archaeology. The property was not evaluated for its potential to yield significant data concerning the human history or prehistory of the region.
  - d. Community value. The property does not possess a unique location, physical characteristic, or significant feature that contributes to the character, image, or cultural identity of the city, the neighborhood, or a particular demographic group.
  - e. Landscape feature. The property is not a significant natural or designed landscape with artistic, aesthetic, cultural, or historical value to the city.

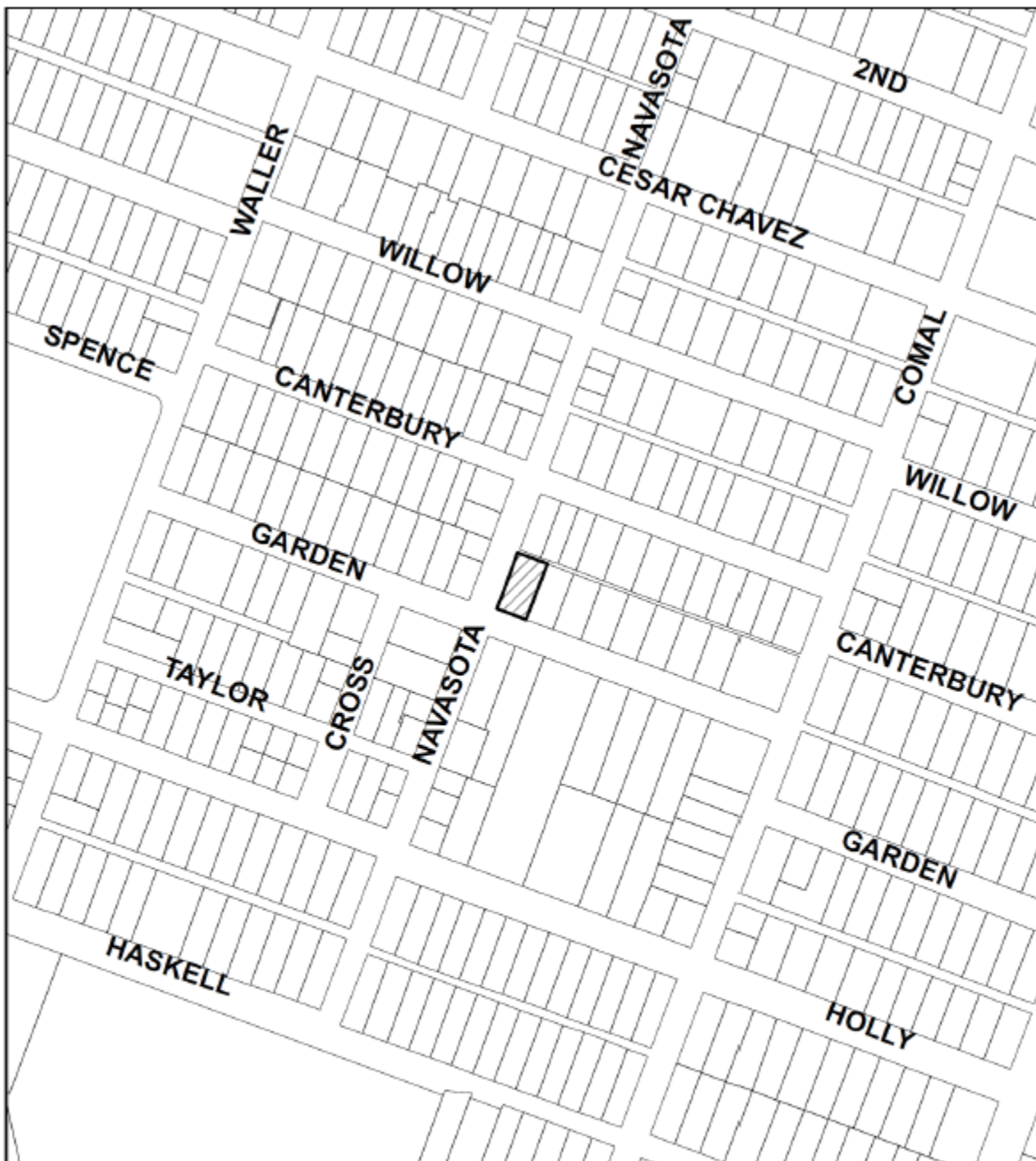
### **STAFF RECOMMENDATION**

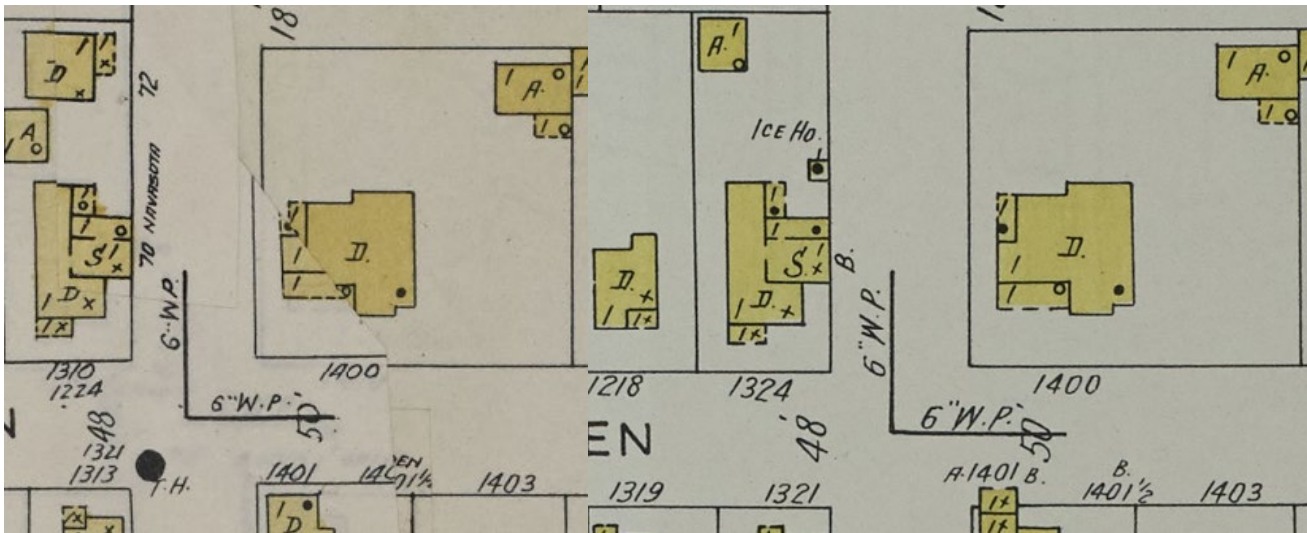

# GRANDSTAND CONTRACT

IT CALLS FOR IMPROVEMENTS  
AT DRIVING PARK LET TO C.  
W. MOORE, CONTRACTOR, OF  
THIS CITY.

## TO BE ERECTED SOON

Work on the Improvements Will Begin  
on Saturday and Rushed—Several  
Stalls and Exhibition Hall to  
Be Put Upon the Grounds.

The contract for the new grand stand, exhibition hall and other improvements at the Driving park was let yesterday morning to C. W. Moore, the well known contractor of this city. The work on the grand stand will begin next Saturday and will be finished within the following ten days. It is the intention to complete the grand stand as soon as possible so as not to interfere with baseball games. The present grand stand will be torn away at once and the new one will replace it as soon as possible. The new grand stand will be put up exactly where the present one is and will be 22x100 feet. It will be raised ten feet off the ground. It will be one of the most modern in the state. On the front row will be a series of loges. The center loge will be fitted up for the press. Immediately back of the loges will be the rows of seats, having a capacity in all of 1000. The front of the grand stand will be screened. The posts will be gotten rid of, that is, they will not be in the way of the spectators. This grand stand will be used by the baseball association and will be completed by the time the boys return to the city from the next trip on the road.

Work on the exhibition hall will not be begun until the grand stand is finished. It will be 50x100 feet, and will be one-story high. This building will be erected on the northeast corner of the grounds.

The contract calls for the construction of 260 stalls on the west side of the grounds. A few of the stalls have been erected already and the remainder will be put in as fast as possible. It is the intention of the fair association to provide accommodation for all the horses that will be here for the fair.

The fair management has decided to ask the merchants and business men of the city to put up \$500 of a \$1000 purse for the merchants' handicap races on Austin day. This purse will be an inducement for the best horses in the country to come here.

The programs are being printed and will be ready in a few days. It has been quite a task to print these programs.

Dr. Shappard, president of the fair association, said yesterday that an effort will be made to procure the services of Dr. Flower of Dallas as one of the judges. He is well known throughout the state and if he is procured it will insure confidence in fairness in all the races. For this reason the management wants to procure him.

# LEASE OF WATER AND LIGHT PLANT

## TEXT OF PROPOSAL

### Fifty Year Water and Light Franchise--To Rebuild the Dam.

Following is the text of the ordinance introduced in the city council Monday night by Alderman C. W. Moore, leasing to William F. Ellis of Stamford, Conn., associates, etc., the entire system of water works, electric lights and power plants at present owned by the city of Austin, and all property belonging or appertaining thereto, including the steam water and light plant heretofore purchased by the city of Austin from the receiver of the Austin Water, Light and Power company and of the city water company, and also granting a franchise to erect a dam across the Colorado river at or near the site of the former dam.

The ordinance was referred to the water and light committee, with instructions to report at a called meeting of the city council to be held tomorrow night and will be considered by the committee at a meeting to be held tonight at the office of City Attorney W. D. Hart. The ordinance reads as follows:

TRAVIS COUNTY FAIR ASSOCIATION RENEWS ITS LEASE, THOUGH AT AN INCREASED RENTAL, AND WILL HOLD FAIR.

## SUCCESS IS EXPECTED

With Buildings In Good Shape, the Officers Will Devote All Their Efforts to Providing for the Attractions.

The Travis County Fair association yesterday concluded a contract re-leasing the fair grounds, but at a much higher price than formerly. Speaking of the deal, C. W. Moore, one of the directors, said:

"Some public spirited citizen, who it was we have been unable to learn, made an offer of \$400 for the property for which we have been paying \$60 a year, practically all it was worth. We were forced to meet the price or lose the property. A meeting of the directors was called and we got together as many of them as could be had upon short notice. We had only until 2 o'clock Saturday afternoon given to us in which to decide. We thought, perhaps, the best way would be to go into the hands of a revolver, but finally we decided that we would make another effort and with the backing of the people of Austin we will succeed. We own the grand stand, worth several thousand dollars, the exhibition

ceod. We own the grand stand, worth several thousand dollars, the exhibition halls, the barns and sheds, the fences and in fact every stick of lumber and every post on the grounds, but these would be worth little more than so much firewood if we had to move everything."

Dr. H. H. Shapard, president of the association, said that yesterday was a critical day in the life of the association, but it had weathered the storm and that it was the intention of the management to hold another fair, a better fair than any yet held, and that it was the belief of the directorate that another fair would put the association on its feet and on the highway to greater success than ever. Said Dr. Shapard:

"The Travis County Fair association started out two years ago with no money. Some enterprising citizens gave it encouragement, buildings were erected and the first fair was a success. The fair last year was ahead of the first one and would have been a success in a money way had not the weather been so bad as to cause us to lose practically two of the best days and decreased the attendance on the other days. The fair this year will be held earlier than last year, probably in September and it will be a success. The fair does more to advertise Austin and bring people here than any carnival ever would and in a few years the Travis County fair will be known from one end of the state to another. We shall require the support of the merchants of the city and in fact of all the citizens, but we feel sure that this will be given freely and that the

fair will become a matter of pride to us all."

The league baseball games will be played at the fair grounds as formerly, the association having concluded yesterday a lease of the grounds for that purpose to Fred Petmecky, who will attend to all matters pertaining thereto.

The directors of the Travis County fair association express much indignation that any one should try to undermine the association and get its grounds away from it or force it to pay a higher rental. They do not feel, however, that it was any grudge against the association which inspired it, but rather that the party, whoever it was, had other interests to serve and did not care how much the fair association might have to suffer.

The county commissioners yesterday awarded to C. W. Moore the contract to erect a residence at the new county farm for the superintendent and decided that the building should be of frame. Five bids were received, the lowest being that of John Depow, \$2121 for frame and \$2518 for brick veneer. The order on the commissioners court docket recites that by having failed to furnish bond within the time prescribed by the court, therefore, the court would refuse to enter into a contract with him and would award the contract to C. W. Moore upon his furnishing a bond in the sum of \$1500 by 10 o'clock this morning. Mr. Moore's bid was \$2638 for frame and \$3272 for brick veneer. Judge Hornsby and Commissioner Fischer wanted to have the building of brick veneer, but Commissioners Ander-

## NEW BUILDING FOR HOME

Confederate Women's Institution Will Have New Structure Costing \$18,000. Contract Let to C. W. Moore.

The contract for a two-story brick building for the Confederate Woman's Home was let yesterday to C. W. Moore for \$15,212. This was exclusive of plumbing, heating and wiring, which will cost nearly \$3000 additional.

Six bids on the main contract were opened by the board of managers at their session yesterday at the institution, just this side of Hyde Park. The figures ranged from that of the successful man up to \$18,374, the bidders being Fischer & Lambie, Wattinger & Ledbetter, Brydson Bros., C. W. Moore, J. F. Johnson of Gatesville and F. F. Compte.

For the heating and plumbing John L. Martin and Donnelly & White submitted proposals. The steam heating went to Donnelly at \$2045, while Martin landed the plumbing at \$643. The wiring went to A. E. Hancock at \$157.

The building will be a slightly one of brick and stucco, adjoining the present building. It will have housing accommodations for thirty-five inmates, with a hospital in connection. At present there are about twenty in the home.

Work will begin right away, according to a statement of T. H. Davis, chairman of the board of managers.

## C. W. MOORE PROUD OF HIS 30-YEAR RECORD AS GENERAL CONTRACTOR

C. W. Moore has a record of thirty years as a general contractor in Austin. He started as a carpenter in Alabama, moved to Texas as a young man and ever since has made his home in Austin. He has not only a unique record as a successful contractor still "on the job," but has become famous as the father of Roy Moore, now of Birmingham, one of the best known baseball players in the Southern Association.

Mr. Moore has just been awarded the contract for the \$25,000 Athletic Club House being built on West Twelfth Street by W. T. Caswell. The active work of construction has already been started.

Mr. Moore and his wife, after rearing a family of three children, have renewed their youth by opening their home to University students. They claim to have acquired the habit during the war, when citizens were urged to house the boys who came to Austin in such numbers that the boarding houses could not care for them. They learned to love the boys and have been unable to shut their doors against their entreaties. Mr. Moore states that he and his wife get a great deal of pleasure from the association of these boys in their home.

Besides being a member of the Rotary Club and Chamber of Commerce, Mr. Moore is interested in civic enterprises throughout the city. If he has a hobby, he says it is the Children's Home.

Mr. Moore is interested in the building program of Austin and states that in his opinion, 1924 should be a banner year in the building industry there. He is now confining his contracting to larger structures and does not enter bids on residences of the medium type, as he once did.
