PROPOSAL

Demolish a ca. 1921 building.

ARCHITECTURE

One-story Craftsman bungalow with double front doors, 1:1 wood windows with 9:1 screens, exposed rafter tails and triangular brackets at gable ends, and a partial-width front porch. The cross-gabled roof is covered with corrugated metal, and the building exterior is clad in horizontal wood siding.

RESEARCH

The house at 512 E. Monroe Street was constructed around 1921 as a rental property, then sold to Buford and Mable Brown in 1928. Buford Brown worked as a life insurance salesman, a loan officer, and a cashier at the American National Bank; he held the latter position until shortly before his death in 1960. Mable Brown, a musician, was active in Austin's music clubs and Delta Kappa Sigma society.

PROPERTY EVALUATION

The property contributes to the Travis Heights - Fairview Park National Register district.

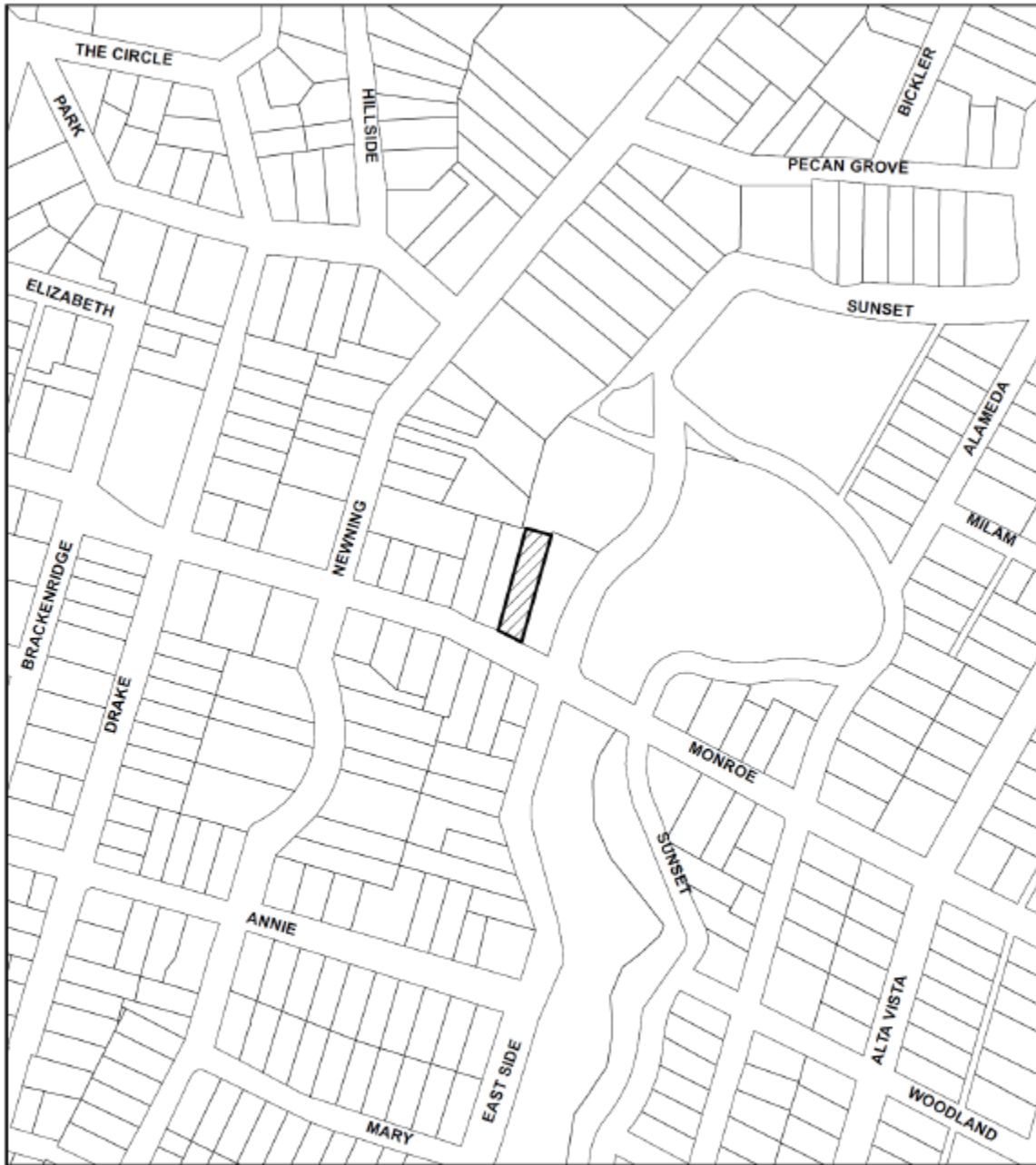
Designation Criteria—Historic Landmark

- 1) The building is more than 50 years old.
- 2) The building appears to retain high integrity.
- 3) Properties must meet two criteria for landmark designation (LDC §25-2-352). Staff has evaluated the property and determined that it does not meet two criteria:
 - a. Architecture. The building is a good example of the Craftsman style.
 - b. Historical association. The property does not appear to have significant historical associations.
 - c. Archaeology. The property was not evaluated for its potential to yield significant data concerning the human history or prehistory of the region.
 - d. Community value. The property does not possess a unique location, physical characteristic, or significant feature that contributes to the character, image, or cultural identity of the city, the neighborhood, or a particular demographic group.
 - e. Landscape feature. The property is not a significant natural or designed landscape with artistic, aesthetic, cultural, or historical value to the city.

STAFF RECOMMENDATION

Strongly encourage rehabilitation and adaptive reuse, then relocation, over demolition, but approve the application upon completion of a City of Austin Documentation Package. Plans for new construction must be reviewed by the Historic Landmark Commission prior to demolition permit release.

Handsome Old Painting Loaned Museum Proves Attraction to Open-House Visitors

Portrait at Least 110 Years Old

On the east wall of the Texas Memorial museum's Pioneer room hangs a handsome old painting that has been attracting a great deal of attention and comment from recent visitors to the interesting new institution.

Central Texans who attend the museum's special "open-house" in their honor this Saturday or Sunday afternoon may view the painting as well as many other notable history, anthropology, botany, zoology exhibits in the state's "wonder house."

The painting, of two small girls, four and six years of age, was loaned to the museum by Mrs. Buford Brown of Austin. Subjects of the artist were the granddaughters of Robert Ralston, founder of the Ralston family in Philadelphia, and "a man of the largest possible distinction in his day, as one of the Quaker City's merchant princes, and as a philanthropist of nationwide celebrity. The little girls in the painting were Mrs. Ralston's grandmother and great aunt. The picture belonged to Mrs. Brown's mother, the late Mrs. William S. Dugat of Beeville.

Painted in Philadelphia between 110 and 115 years ago, it later was taken south with the Ralston family and graced the colonial mansion the Ralstons built just outside Natchez, Miss. The Civil war came and went and the picture was taken by the family to a new home in New Orleans after the Natchez house burned. Next it went to Los Angeles, Calif., and later was brought to the home of Mrs. Brown's mother at Beeville. It came to the museum here recently from the Nelson Art gallery in Kansas City.

The wonderfully preserved painting, apparently as fresh as the day it was finished is one of the numerous exhibits that form special attractions at the museum. Others of unusual popular interest include saddles for men and women of all periods in Texas history; irons for branding cattle and used on famous pioneer ranches of the Southwest;

prison locks and keys used on New Orleans in 1874, presented by A. S. Hull; a painting of William Barrett Travis, commander of the Texas; arichly-carved mahogany desk used in the first supreme court office in Austin and brought to the capitol in an oxcart from natural history.
