Posting Language

Authorize award and execution of a construction contract with Alpha Paving Industries, LLC, for the Street Rehabilitation Phase 3 Indefinite Delivery/Indefinite Quantity No. 4 contract in the amount of \$6,000,000 for an initial one-year term, with a one-year extension option of \$6,000,000, for a total contract amount not to exceed \$12,000,000.

[Note: This contract will be awarded in compliance with City Code Chapter 2-9A (Minority Owned and Women Owned Business Enterprise Procurement Program) by meeting the goals with 7.86% MBE and 1.76% WBE participation.]

Funding for the initial amount of \$6,000,000 is available in the Capital Budget of the Public Works Department. Funding for the extension option is contingent upon available funding in future budgets.

Additional Backup Information:

The City maintains a street network of approximately 7,850 lane miles of pavement. Street rehabilitation is a strategy that the City uses for maintaining arterial, collector and residential streets. City forces are not equipped to handle this work and accomplished similar work through Indefinite Delivery/Indefinite Quantity (ID/IQ) contracts in past years.

This project is being funded by the 2018 Proposition G Transportation Infrastructure Bond.

ID/IQ contracts provide for an indefinite quantity of services for a fixed time, usually an initial term with extension options. They are commonly used when precise quantities of supplies or services, above a specified minimum, cannot be determined. ID/IQ contracts help streamline the contract process and service delivery and allow the City the flexibility to add work as needs arise or change. As each project is defined, a specific work assignment will be assigned to the contractor who will complete the scope of work for the unit prices included in the contract. Work deadlines will be established for each work assignment.

The Street Rehabilitation Phase 3 ID/IQ No. 4 project is a maintenance repair strategy for selected arterial, collector, and residential streets throughout Austin. The project involves pavement surface milling and overlaying, which may be accompanied by localized road base structure repairs or full depth replacement. The project also includes spot curb and gutter replacement to address ponding and Americans with Disabilities Act compliant curb ramp repair, as needed in selected roadway sections.

The base bid was used to identify and determine the lowest responsive bidder and contract unit prices for each bid item.

This request allows for the award and execution of a construction contract with Alpha Paving Industries, LLC, for a period of one year with an optional one-year extension. However, if funds for the initial term are expended staff may accelerate the extension option, but in no event will exceed the total contract amount. The extension option is subject to the agreement of both parties.

If this contract is not approved, the streets will continue to deteriorate resulting in significantly more expensive reconstruction repairs that are more impactful to traffic mobility.

This project will be located Citywide in all Districts.
