Public notice was given for this solicitation CLMC876 Onion Creek Reclaimed Water Main Phase 1, through the City’s Vendor Connection web portal. Three bids were received and opened on March 24, 2022. Of the three bids received two bids were from MBE/WBE certified firms. Austin Underground, Inc. submitted the lowest responsive bid including total allowances of \$385,000:
