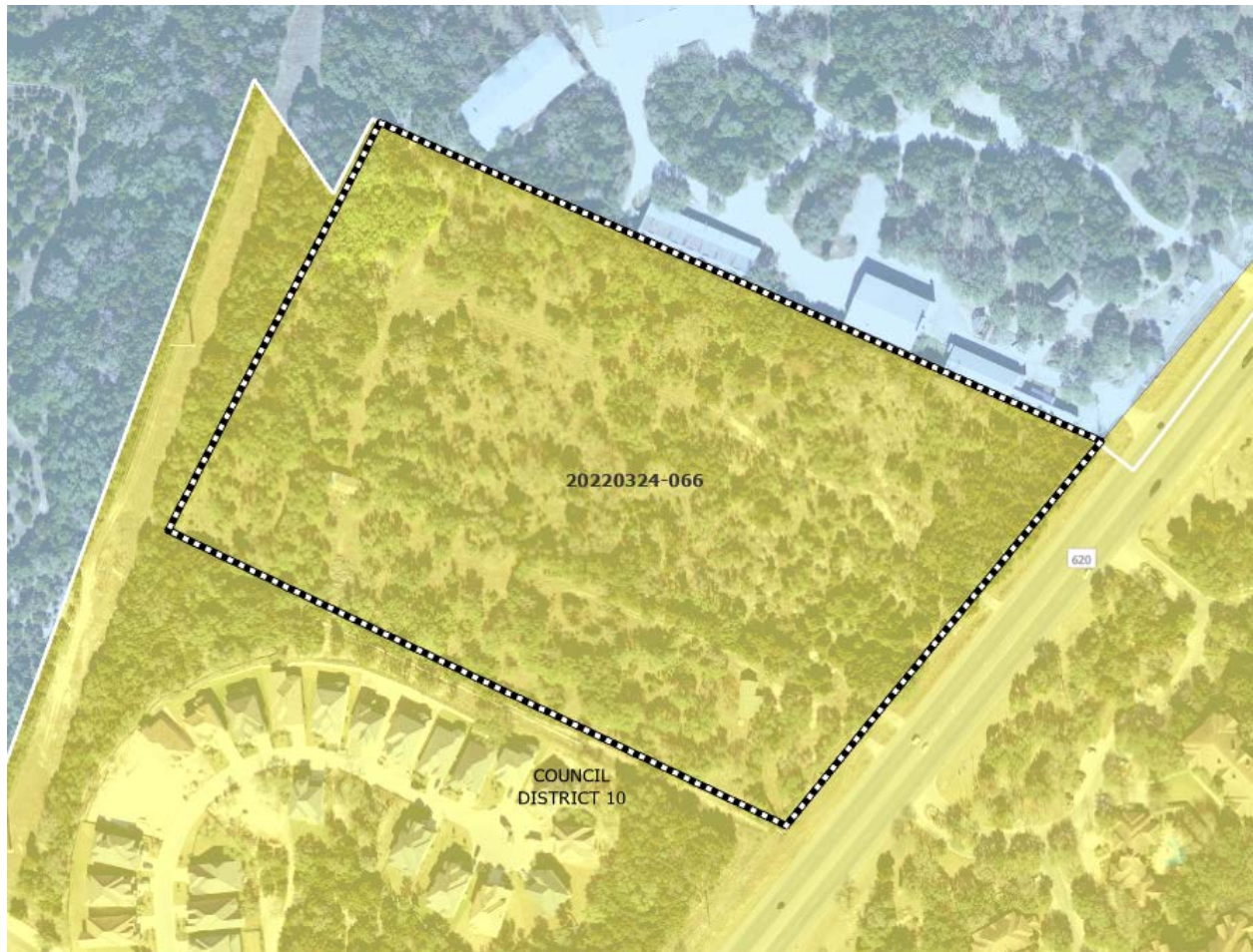

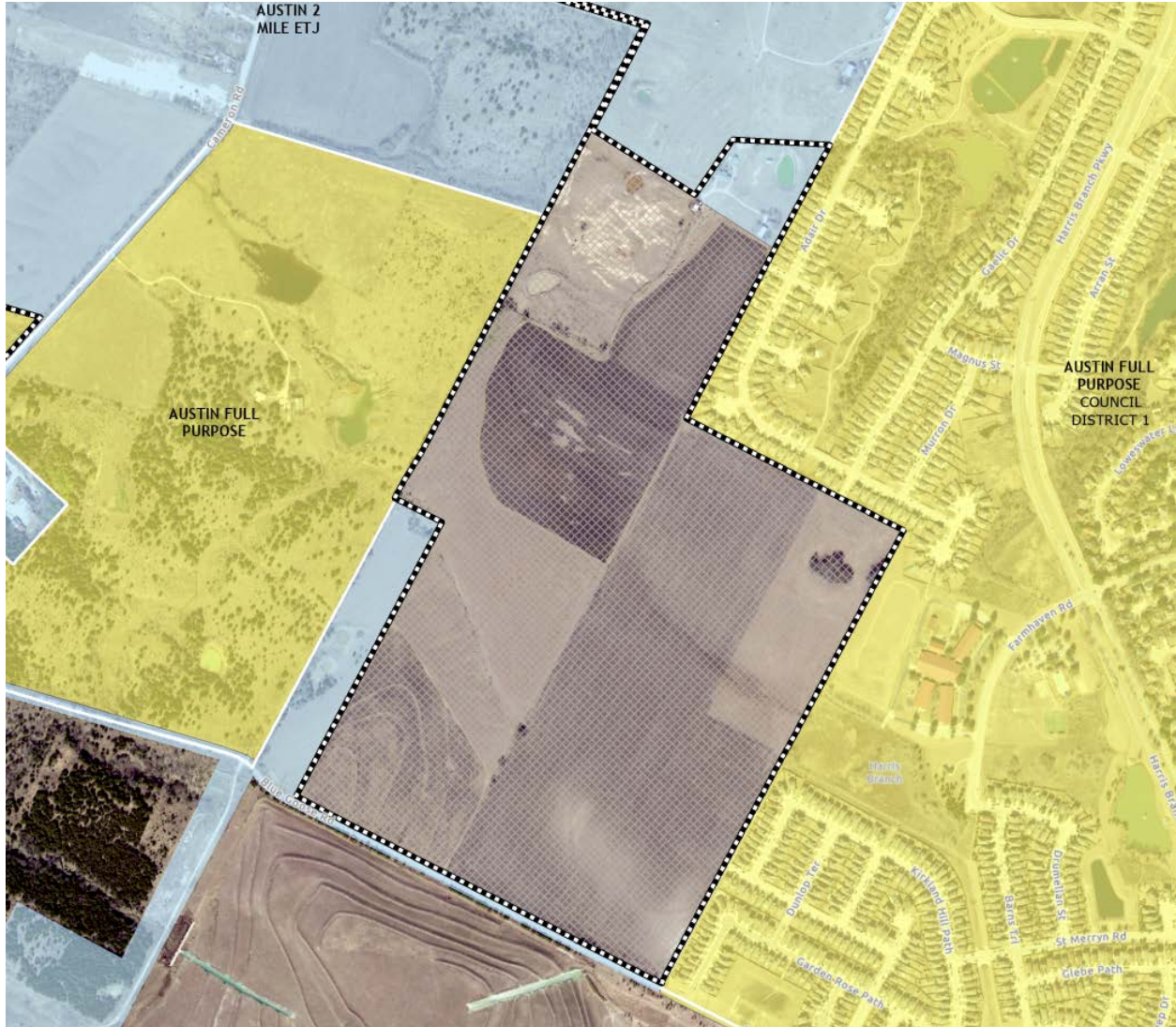

Texas Children’s Hospital South Full Purpose Annexation Area



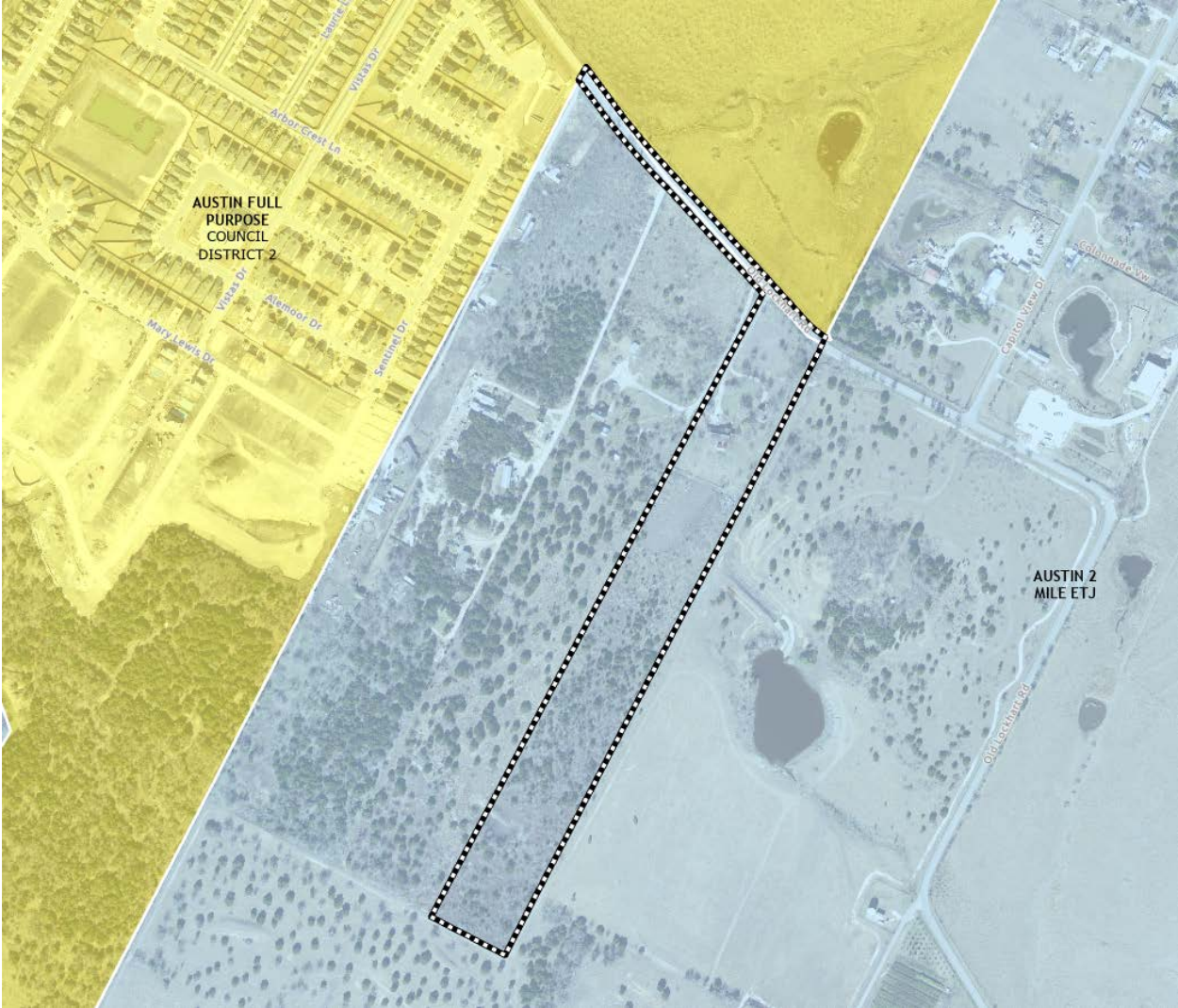
Property to be developed as Texas Children’s Hospital, South Campus. Already included in Council District 5 (was limited purpose jurisdiction).

Blue Goose Road Full Purpose Annexation Area



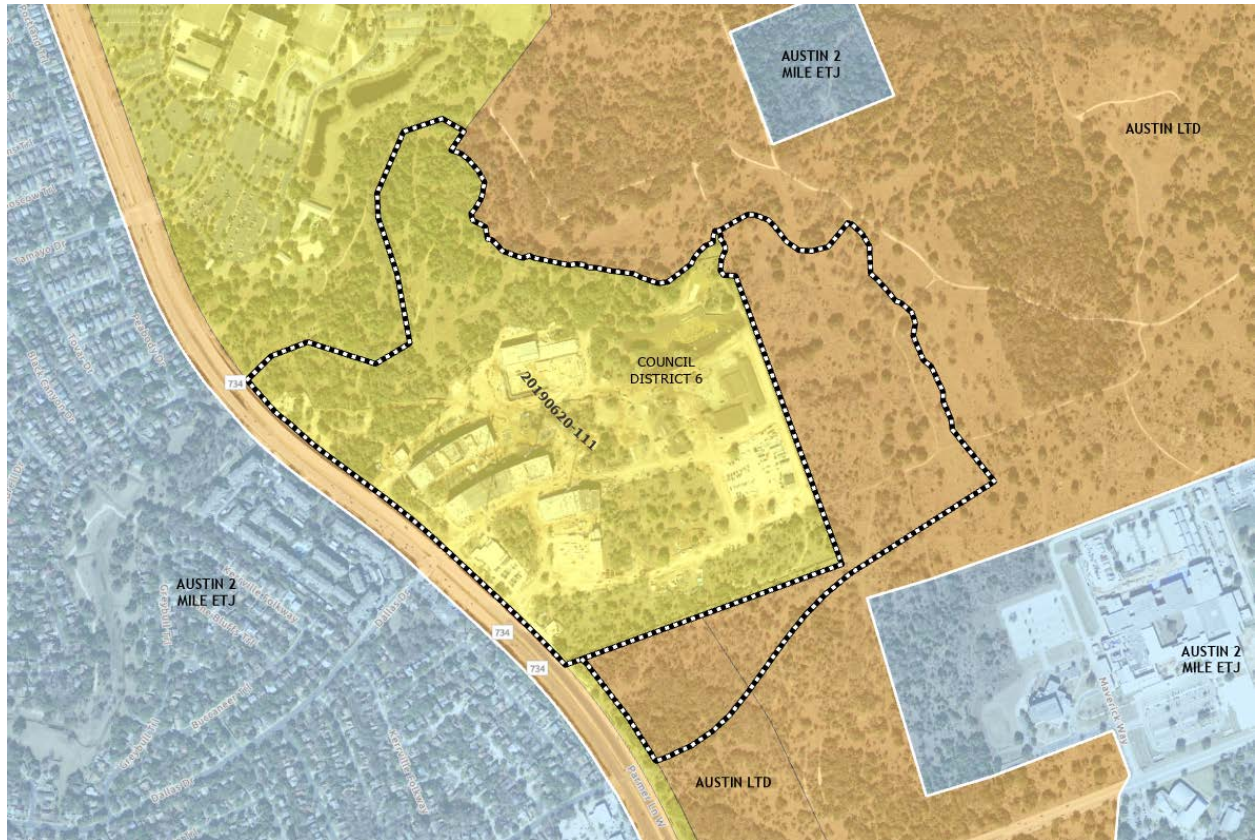

Old Lockhard Road Full Purpose Annexation Area



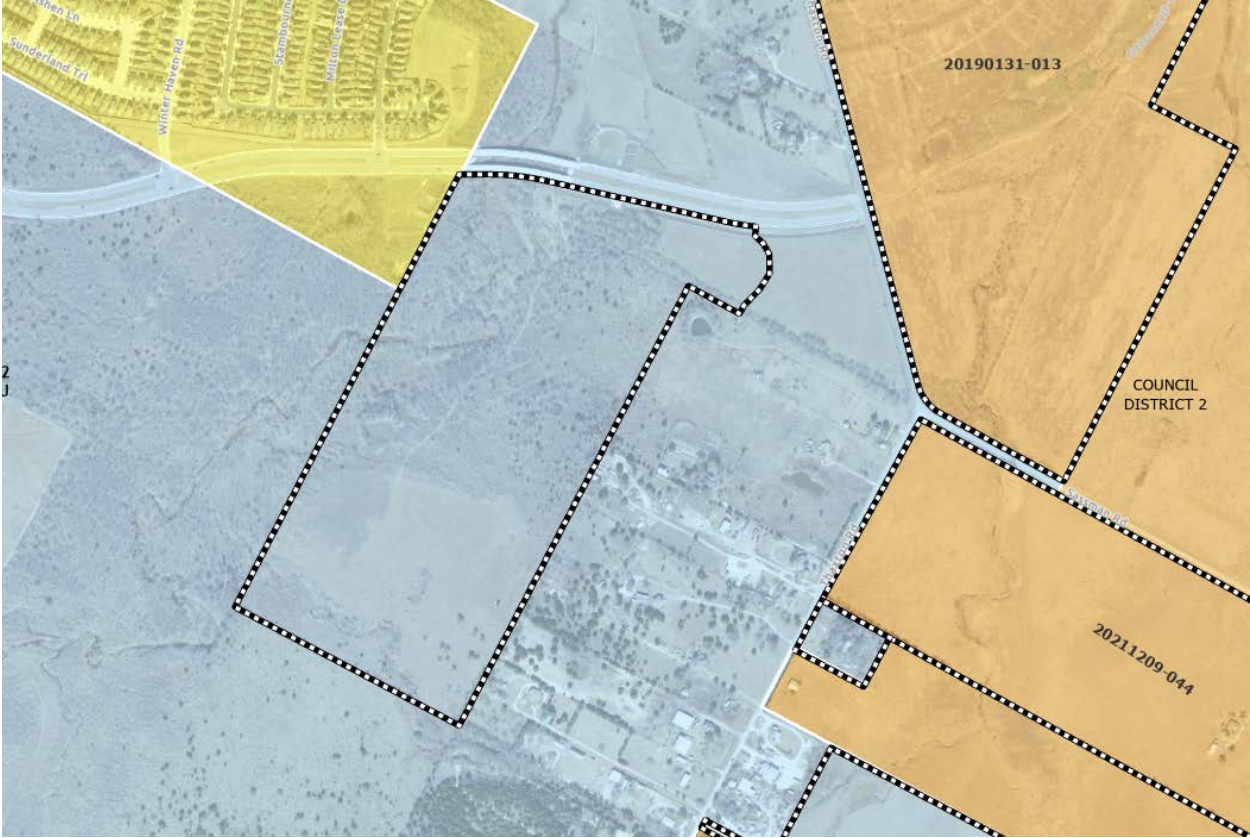

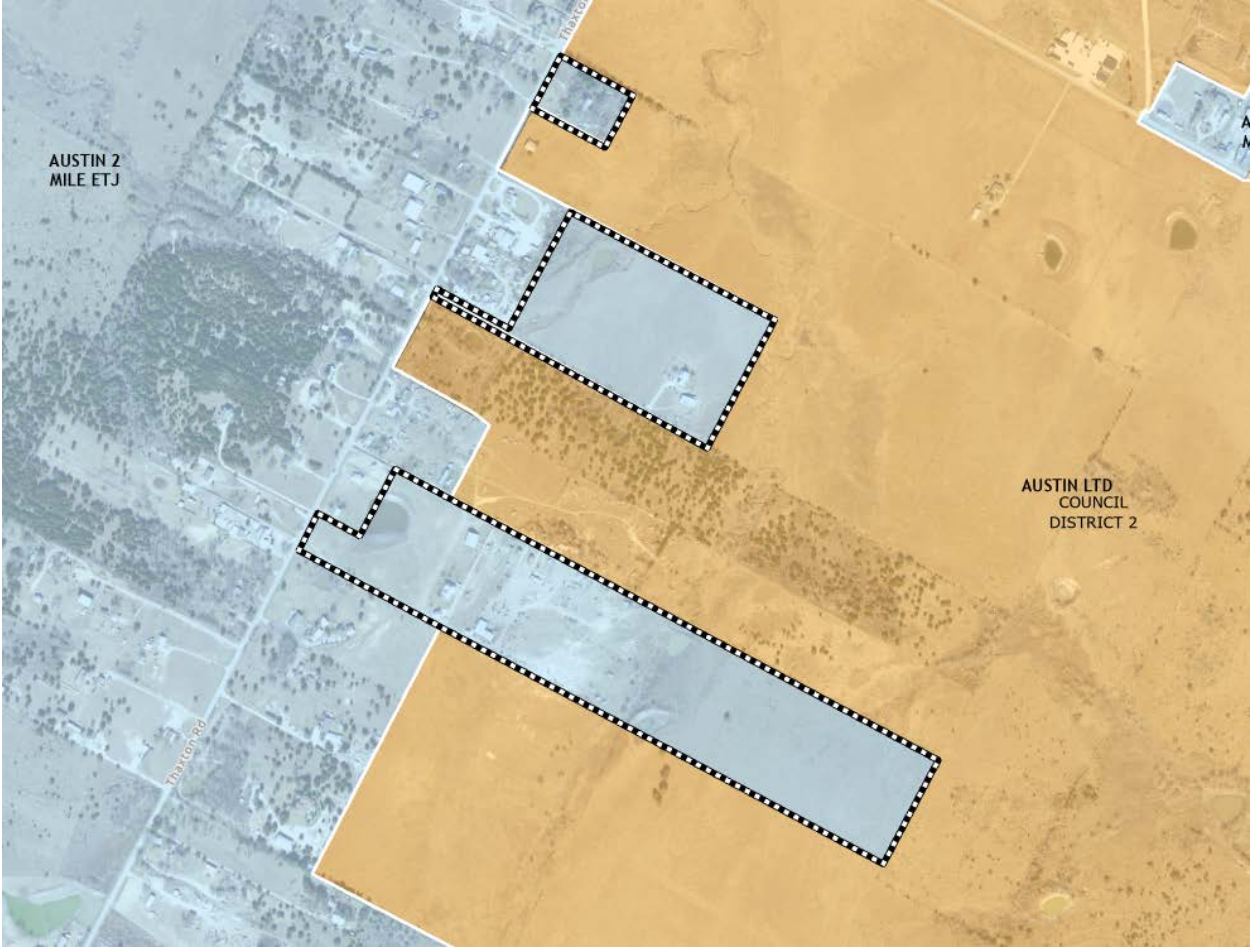
