## **ORDINANCE NO. 20220728-143**

AN ORDINANCE REZONING AND CHANGING THE ZONING MAP FOR THE PROPERTY LOCATED AT 7400 SOUTH CONGRESS AVENUE FROM SINGLE-FAMILY STANDARD LOT (SF-2) DISTRICT AND COMMUNITY COMMERCIAL (GR) DISTRICT TO COMMUNITY COMMERCIAL-MIXED USE-CONDITIONAL OVERLAY (GR-MU-CO) COMBINING DISTRICT.

## BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

**PART 1.** The zoning map established by Section 25-2-191 of the City Code is amended to change the base district from single-family standard lot (SF-2) district and community commercial (GR) district to community commercial-mixed use-conditional overlay (GR-MU-CO) combining district on the property described in Zoning Case No. C14-2021-0193, on file at the Housing and Planning Department, as follows:

Lot 1, Block A, SOUTH CONGRESS DISTRICT FINAL PLAT – A RESUBDIVISION OF THE ENNIS SUBDIVISION, a subdivision in the City of Austin, Travis County, Texas, according to the map or plat of record in Document No. 202100236 of the Plat Records of Travis County (the "Property"),

locally known as 7400 South Congress Avenue in the City of Austin, Travis County, Texas, generally identified in the map attached as **Exhibit "A"**.

**PART 2.** The Property within the boundaries of the conditional overlay combining district established by this ordinance is subject to the following conditions:

(A) The following uses are prohibited uses on the Property:

Automotive rental

Automotive sales

Bail bond services

Business support services

Drop-off recycling collection

facility

Funeral services

Indoor entertainment

Outdoor entertainment

Pawn shop services

Theater

Automotive repair

Automotive washing (of any type)

Business or trade school

Commercial off-street parking

Exterminating services

Hotel-motel

Indoor sports and recreation

Outdoor sports and recreation

Research services

(B) The following uses are conditional uses of the Property:

Alternative financial services Medical offices (exceeding 5,000 square feet)


(C) The following permitted uses on the Property shall be developed according to the site development standards in Section 25-2-587 (D):

General retail sales (general) Personal improvement services Restaurant (general)

- (D) The maximum height of a building or structure within 620 feet of the west boundary line of the Property is limited to 4 stories (as depicted on **Exhibit "B"**)
- (E) A 125-foot building setback shall be established and maintained parallel to and measured from the west property line (as depicted on **Exhibit "B"**)
- (F) A 65-foot wide vegetative buffer shall be provided and maintained parallel to and measured from the west property line along the south property line extending to the southern right-of-way of Blackberry Drive (as depicted on **Exhibit "B"**). Improvements permitted within the vegetative buffer area are limited to drainage, underground utility improvements or those improvements that may be otherwise required by the City of Austin or specifically authorized in this ordinance.
- (G) Vehicular access from the Property to Blackberry Drive is prohibited. All vehicular access to the Property shall be from other adjacent public streets or through other adjacent property.

**PART 3.** Except as specifically restricted under this ordinance, the Property may be developed and used in accordance with the regulations established for the community commercial (GR) base district, mixed use (MU) combining district, and other applicable requirements of the City Code.

PART 4. This ordinance takes effect on August 8, 2022.  PASSED AND APPROVED


