#### Additional Backup Information:

The contract is for the Young Women's Christian Association of Greater Austin (YWCA) to provide healing modality services to individuals impacted by violence and trauma. The YWCA will use the funds to broaden choices of available healing modalities to address the community's diverse mental health needs. They will offer somatic experiencing, Eye Movement Desensitization and Reprocessing, trust based relational interventions, and narrative therapy. In addition, the YWCA will offer body-based modalities such as yoga therapy, acupuncture, Qigong, Tai Chi, sound therapy, as well as integrated harm reduction therapy. Services will be individualized and provided complimentary "one-stop-shop" accessible to many who otherwise could not afford the average cost. YWCA will partner with licensed professionals such as counselors, clinicians, therapists, and social workers fully trained in providing these specialized services.

The YWCA will also use funds to remain updated on the most current information on harm reduction. YWCA staff will consolidate information from trainings, add a trauma-informed, relational-cultural lens, and provide trainings for social service providers, educators, emerging therapists, and social workers.

Increasing availability and access to culturally resonant healing modalities to those most directly harmed by systemic oppression is a recommendation from the Reimagining Public Safety Task Force (RPSTF). The
