#### CALL TO ORDER

### **PUBLIC COMMUNICATION: GENERAL**

The first ten speakers who register to speak no later than noon the day before the meeting will be allowed a three-minute allotment to address their concerns regarding items not posted on the agenda.

Commissioner Courtney Rosenthal spoke on cryptocurrency and blockchain technology and related City of Austin staff investigations of the technology. She requested the commission request staff presentations on these investigations.

An edit was read into the record to amend the District 4 Council member represented to reflect the election results.

Motion to approve the June 8<sup>th</sup> minutes made by Commissioner Thompson and seconded by Chair Pitts passed on a vote of 7-0 with Commissioner DasGupta not present.

- 3. NEW BUSINESS (Discussion and Possible Action)
  - a. Commission Discussion on FCC Broadband Standards (Discussion and Action)

Motion to assign homework to each commissioner to send questions and feedback to the Commission Liaison regarding the creation of broadband standards for the City of Austin made by Chair Pitts, seconded by Commissioner Apodaca, passed on a vote of 7-0.

# b. Commission Discussion on the Digital Inclusion Strategic Plan (Discussion and Action)

Motion to advance the plan to analyze federal funding opportunities, including how the State intends to make those funds available, and for each Commissioner to contribute thoughts and questions to the Staff Liaison for compilation into a document made by Chair Pitts, seconded by Commissioner Garza, passed on a vote of 7-0.

# c. Commission Discussion on an Intelligent Infrastructure Resolution (Discussion and Action)

The commission discussed a need to discuss draft resolution language, and to consider ways to be indifferent to specific technologies while favoring certain outcomes. The commissioners also expressed an interest in connecting to Travis County on this topic.

# a. Digital Inclusion, Civic Engagement, and Strategic Technology and Telecom Policy Working Group

Chair Pitts noted that this working group met with the Innovation Office, and expressed interest in the Neighborhood Prosperity Index, the Social Vulnerability Index, and the Community Civic Research Agenda.

## b. Knowledge, Information, and Data Stewardship Working Group

Commissioner Apodaca noted that the working group met and discussed a need to speak with CIO Chris Stewart about progress on the website update. The group also discussed voting tablature and the need for the commissioners to reach out to their Council Members about moving this item along. Commissioner Floyd mentioned he will follow up on the 3D home printing, and Chair Pitts noted that there was a need to talk this over with the Chief Homelessness Officer

### c. Technology, Infrastructure, and Innovation Working Group

Commissioner Floyd noted that all of the items have been covered for this group, and that this working group will be focused on creating the resolution mentioned in item 3c.
