"Purchaser" or "TWDB" means the Texas Water Development Board.

100 "Security Register" shall have the meaning given in Section 5 of the Forty-101 Third Supplement.

"State" means the State of Texas.

"State Water Plan" means the State's comprehensive water plan prepared, 103 developed, formulated and adopted by the Texas Water Development Board under 104 authority of Subchapter C of Chapter 16, Texas Water Code.

The terms used in the Forty-Third Supplement and not otherwise defined shall have the meanings given in the Master Ordinance or the Prior Supplements.

The Bonds shall be secured by a lien on, and pledge of, the Net Revenues on parity with the outstanding "Parity Water/Wastewater Obligations" issued in accordance with and under the terms and provisions of the Master Ordinance and the Prior Supplements. There are no Previously Issued Separate Lien Obligations outstanding. Council affirms that the Master Ordinance provides that no additional revenue obligations shall be issued on parity with the Prior Subordinate Lien Obligations.

SECTION 2: AUTHORIZATION - DESIGNATION - PRINCIPAL AMOUNT - PURPOSE. Revenue bonds of the City shall be and are authorized to be issued in the aggregate principal amount of \$18,000,000 and designated the "CITY OF AUSTIN, TEXAS, WATER AND WASTEWATER SYSTEM REVENUE BONDS, SERIES 2022A (SWIRFT)" (the "Bonds"), for the purpose of improving and extending the Water/Wastewater System by financing projects that are part of the State Water Plan, and paying costs of issuance, in conformity with the Constitution and laws of the State, including Chapter 1502.

SECTION 3: FULLY REGISTERED OBLIGATIONS-AUTHORIZED 123 **DENOMINATIONS – STATED MATURITIES - DATE**. The Bonds shall be 124 issued as fully registered obligations, without coupons, shall be in denominations 125 of \$5,000 or any integral multiple thereof (within a Stated Maturity), shall be 126 numbered consecutively from R-1 upward (except as provided in Section 9 of the 127 Forty-Third Supplement). The Bonds shall bear interest on the unpaid principal 128 amounts from the date and at the rate(s) per annum as specified in Section 4 below 129 (calculated on the basis of a 360-day year of twelve 30-day months). Interest on 130 the Bonds shall be payable on May 15 and November 15 in each year, commencing on May 15, 2023, until maturity or prior redemption, as provided in 132 the FORM OF BOND. 133

# SECTION 4: PRINCIPAL PAYMENTS AND INTEREST RATES: **REDEMPTION**.

(a) The Bonds shall be dated September 27, 2022 (the "Dated Date"), shall 136 be in any Authorized Denomination, shall bear interest from their Delivery Date in 137 the manner described in the FORM OF BOND at the rates per annum, and the 138 principal on the Bonds shall mature on November 15 in each of the years and in 139 the amounts, respectively, set forth in Schedule I attached to this Forty-Third 140 141 Supplement.

(b) The City may redeem Bonds prior to their scheduled maturity on the dates and in the manner set forth in the FORM OF BOND. If less than all of the maturities of the Bonds are redeemed by the City, the City shall determine the maturities and amounts to be redeemed and shall direct the Paying Agent/Registrar to call Bonds by lot within a maturity and in a principal amount for redemption. Notice of any redemption shall be given in the manner set forth in the FORM OF BOND. Notice of any redemption also shall be given by United States mail, first class postage prepaid, (i) at least 30 days prior to the scheduled redemption date to the MSRB and to any national information service that disseminates redemption 151 notices, and (ii) at least 90 days prior to the scheduled redemption date to the 152 TWDB. Any notice sent to the MSRB and to any national information service that 153 disseminates redemption notices must be sent so that the notice is received at least 154 two days prior to the general mailing of notice as set forth in the FORM OF 155 BOND. 156

(c) Each redemption notice, whether required in the FORM OF BOND or 157 otherwise by this Forty-Third Supplement, shall contain a description of the Bonds 158 to be redeemed, including the complete name of the Bonds, the series, the date of 159 issue, the interest rate, the maturity date, the CUSIP number, if any, the amounts 160 called for redemption, the publication and mailing date for the notice, the date of 161 redemption, the redemption price, the name of the Paying Agent/Registrar and the 162 address at which the Bond may be redeemed including a contact person and 163 telephone number. All redemption payments made by the Paying Agent/Registrar 164 to the registered owners of the Bonds shall include a CUSIP number relating to 165 each amount paid to such registered owner. 166 167

SECTION 5: TERMS OF PAYMENT PAYING AGENT -/REGISTRAR. The principal of, premium, if any, and the interest on the Bonds, due and payable by reason of maturity, redemption or otherwise, shall be payable only to the Holders appearing on the registration and transfer books maintained by the Paying Agent/Registrar and the payment shall be in any coin or currency of the United States of America, which at the time of payment is legal tender for the payment of public and private debts, and shall be without exchange or collection charges to the Holders.

176 The selection and appointment of the Paying Agent/Registrar for the Bonds 177 is approved and confirmed. Books and records relating to the registration, payment, exchange and transfer of the Bonds (the "Security Register") shall at all 178 times be kept and maintained on behalf of the City by the Paying Agent/Registrar, 179 all as provided in the Forty-Third Supplement, in accordance with the terms and 180 provisions of a "Paying Agent/Registrar Agreement," substantially in the form of 181 paying agent agreements previously approved by council in connection with the 182 issuance of public securities, and such reasonable rules and regulations as the 183 Page 5 of 31

Paying Agent/Registrar and the City may prescribe. The City covenants to 184 maintain and provide a Paying Agent/Registrar at all times until the Bonds are paid 185 and discharged, and any successor Paying Agent/Registrar shall be a bank, trust 186 company, financial institution or other entity qualified and authorized to serve in 187 such capacity and perform the duties and services of Paying Agent/Registrar. 188 Upon any change in the Paying Agent/Registrar for the Bonds, the City agrees to 189 promptly cause a written notice of the change to be sent to each Holder by United 190 States Mail, first class postage prepaid, which notice shall also give the address of 191 the new Paying Agent/Registrar. 192

If required by law, the City shall not execute the Paying Agent/Registrar 193 Agreement unless the Paying Agent/Registrar has confirmed to the City that it has 194 made disclosure filings to the Texas Ethics Commission in accordance with 195 Section 2252.908, Texas Government Code. Within 30 days of receipt of the 196 disclosure filings from the Paying Agent/Registrar, the City will submit a copy of 197 the disclosure filings to the Texas Ethics Commission. 198

Principal of and premium, if any, on the Bonds shall be payable at the Stated 199 Maturities or redemption of the Bonds, only upon presentation and surrender of the 200 Bonds to the Paying Agent/Registrar at its designated office in Dallas, Texas (the 201 "Designated Payment/Transfer Office"). Interest on the Bonds shall be paid to the 202 Holders whose names appear in the Security Register at the close of business on 203 the Record Date (the last Business Day of the month next preceding each interest 204 payment date), and interest shall be paid by the Paying Agent/Registrar (i) by 205 check sent United States Mail, first class postage prepaid, to the address of the 206 Holder recorded in the Security Register or (ii) by such other method, acceptable to 207 the Paying Agent/Registrar, requested by, and at the risk and expense of, the 208 Holder. If the date for the payment of the principal of or interest on the Bonds is a 209 day other than a Business Day, then the date for payment shall be the next 210 succeeding Business Day; and payment on that date shall have the same force and 211 212 effect as if made on the original date payment was due. If TWDB is the Beneficial Owner of 100% in aggregate principal amount of the Bonds then Outstanding, 213 principal shall be paid to TWDB by wire transfer, at no expense to TWDB.

In the event of a non-payment of interest on one or more maturities on a scheduled payment date, and for 30 days thereafter, a new record date for the interest payment for the maturity or maturities (a "Special Record Date") will be established by the Paying Agent/Registrar, if and when funds for the payment of interest have been received from the City. Notice of the Special Record Date and of the scheduled payment date of the past due interest (which shall be 15 days after the Special Record Date) shall be sent at least five Business Days prior to the Special Record Date by United States Mail, first class postage prepaid, to the address of each Holder of such maturity or maturities appearing on the Security 223

Register at the close of business on the last Business Day next preceding the date of mailing of the notice.

SECTION 6: **REGISTRATION-TRANSFER-EXCHANGE OF BONDS** - **PREDECESSOR BONDS**. The Paying Agent/Registrar shall obtain, record, and maintain in the Security Register the name and address of each registered owner of the Bonds issued under the provisions of the Forty-Third Supplement. Any Bond may, in accordance with its terms and the terms of the Forty-Third Supplement, be transferred or exchanged for Bonds of other authorized denominations upon the Security Register by the Holder, in person or the Holder's authorized agent, upon surrender of the Bond to the Paying Agent/Registrar for cancellation, accompanied by a written instrument of transfer or request for exchange executed by the Holder or the Holder's authorized agent, in form satisfactory to the Paying Agent/Registrar.

Upon surrender for transfer of any Bond (other than the Initial Bond authorized in Section 9 of the Forty-Third Supplement) at the Designated Payment/Transfer Office of the Paying Agent/Registrar, the Paying Agent/Registrar shall register and deliver, in the name of the designated transferee(s), one or more new Bonds executed on behalf of, and furnished by, the City of authorized denominations and having the same Stated Maturity and of a like aggregate principal amount as the Bond or Bonds surrendered for transfer.

At the option of the Holder, Bonds (other than the Initial Bond authorized in Section 9 of the Forty-Third Supplement) may be exchanged for other Bonds of authorized denominations and having the same Stated Maturity, bearing the same rate of interest and of like aggregate principal amount as the Bonds surrendered for exchange, upon surrender of the Bonds to be exchanged at the Designated Payment/Transfer Office of the Paying Agent/Registrar. Whenever any Bonds are surrendered for exchange, the Paying Agent/Registrar shall register and deliver new Bonds, executed on behalf of, and furnished by, the City, to the Holder requesting the exchange.

All Bonds issued upon any transfer or exchange of Bonds shall be delivered at the Designated Payment/Transfer Office of the Paying Agent/Registrar, or sent by United States Mail, first class postage prepaid, to the Holder and, upon the delivery, the same shall be valid obligations of the City, evidencing the same obligation to pay, and entitled to the same benefits under the Forty-Third Supplement, as the Bonds surrendered in such transfer or exchange.

All transfers or exchanges of Bonds under this Section shall be made without expense or service charge to the Holder, except as otherwise provided in the Forty-Third Supplement, and except that the Paying Agent/Registrar shall require payment by the Holder requesting such transfer or exchange of any tax or

263 other governmental charges required to be paid with respect to such transfer or264 exchange.

Bonds canceled by reason of an exchange or transfer under the provisions of the Forty-Third Supplement are defined to be "Predecessor Bonds," evidencing all or a portion, as the case may be, of the same obligation to pay evidenced by the Bond or Bonds registered and delivered in the exchange or transfer. Additionally, the term "Predecessor Bonds" shall include any mutilated, lost, destroyed, or stolen Bond for which a replacement Bond has been issued, registered and delivered under Section 19 of the Forty-Third Supplement and the new replacement Bond shall be deemed to evidence the same obligation as the mutilated, lost, destroyed, or stolen Bond.

Neither the City nor the Paying Agent/Registrar shall be required to transfer or exchange any Bond called for redemption, in whole or in part, within 45 days of the date fixed for redemption of the Bond; provided, however, this limitation of transfer shall not be applicable to an exchange by the Holder of the unredeemed balance of a Bond called for redemption in part.

The Paying Agent/Registrar for the Bonds shall act as the closing agent for the delivery of the Bonds to the TWDB, and in connection therewith, the Paying Agent/Registrar understands the Bonds are to be delivered to the TWDB using the book-entry only system provided by DTC.

The City agrees to deliver to the Paying Agent/Registrar one initial Bond, numbered T-1, as provided in Section 9 of the Forty-Third Supplement, and registered to the TWDB following the approval by the Attorney General of the State and the registration by the Comptroller of Public Accounts. Proceeds from the Bonds will be held in escrow and disbursed to the City in accordance with procedures approved by the TWDB.

SECTION 7: BOOK-ENTRY-ONLY TRANSFERS AND TRANSACTIONS. Notwithstanding the provisions contained in Sections 4, 5 and 6 of the Forty-Third Supplement relating to the payment, and transfer/exchange of the Bonds, the City approves and authorizes the use of the "Book-Entry-Only" securities clearance, settlement and transfer system provided by The Depository Trust Company, New York, New York ("DTC"), a limited purpose trust company organized under the laws of the State of New York, in accordance with the operational arrangements referenced in the Blanket Issuer Letter of Representation, by and between the City and DTC (the "Depository Agreement").

Pursuant to the Depository Agreement and the rules of DTC, the Bonds shall
be deposited with DTC, who shall hold the Bonds for its participants (the "DTC
Participants"). While the Bonds are held by DTC under the Depository

Agreement, the Holder of the Bonds on the Security Register for all purposes, including payment and notices, shall be Cede & Co., as nominee of DTC, notwithstanding the ownership of each actual purchaser or owner of each Bond (the "Beneficial Owners") being recorded in the records of DTC and DTC Participants.

In the event DTC determines to discontinue serving as securities depository for the Bonds or otherwise ceases to provide book-entry clearance and settlement of securities transactions in general or the City determines that DTC is incapable of properly discharging its duties as securities depository for the Bonds, the City covenants and agrees with the Holders of the Bonds to cause Bonds to be printed in definitive form and provide for the Bond certificates to be issued and delivered to DTC Participants and Beneficial Owners, as the case may be. The Bonds in definitive form shall be assigned, transferred and exchanged on the Security Register maintained by the Paying Agent/Registrar and payment of the Bonds not held by DTC under the Depository Agreement shall be made in accordance with the provisions of Sections 4, 5 and 6 of the Forty-Third Supplement.

SECTION 8: EXECUTION - REGISTRATION. The Bonds shall be executed on behalf of the City by the Mayor or Mayor Pro Tem under its seal reproduced or impressed on the Bonds and countersigned by the City Clerk. The signature of the officers on the Bonds may be manual or facsimile. Bonds bearing the manual or facsimile signatures of individuals who are or were the proper officers of the City on the Dated Date shall be deemed to be executed on behalf of the City, notwithstanding that those individuals or either of them shall cease to hold the offices at the time of delivery of the Bonds to the Purchaser and with respect to Bonds delivered in subsequent exchanges and transfers, all as authorized and provided in Chapter 1201.

No Bond shall be entitled to any right or benefit under the Forty-Third Supplement, or be valid or obligatory for any purpose, unless there appears on the Bond either a certificate of registration substantially in the form provided in the FORM OF BOND, manually executed by the Comptroller of Public Accounts of the State or his or her authorized agent, or a certificate of registration substantially in the form provided in the FORM OF BOND, manually executed by an authorized officer, employee or representative of the Paying Agent/Registrar, and either certificate upon any Bond signed shall be conclusive evidence, and the only evidence, that the Bond has been certified, registered and delivered.

338 SECTION 9: INITIAL BOND. The Bonds shall be initially issued as a
339 single fully registered bond, payable in the aggregate principal amount of the
340 Bonds, and numbered T-1 (the "Initial Bond"). The Initial Bond shall be registered
341 in the name of the Purchaser or its designee. The Initial Bond shall be submitted to
342 the Office of the Attorney General of the State for approval, certified and

registered by the Office of the Comptroller of Public Accounts of the State and delivered to the Purchaser. Any time after the delivery of the Initial Bond, the Paying Agent/Registrar, pursuant to written instructions from the Purchaser, or its designee, shall cancel the Initial Bond delivered and exchange for the Initial Bond definitive Bonds of authorized denominations, Stated Maturities, principal amounts and bearing applicable interest rates for transfer and delivery to the Holders named at the addresses identified for the Holders; all pursuant to and in accordance with such written instructions from the Purchaser, or its designee, and any other information and documentation as the Paying Agent/Registrar may reasonably require.

SECTION 10: FORMS. The Bonds, the Registration Certificate of the Comptroller of Public Accounts of the State, the Certificate of Registration, and the form of Assignment to be printed on each of the Bonds, shall be substantially in the forms set forth in the FORM OF BOND set forth in **Exhibit A** to the Forty-Third Supplement, with appropriate insertions, omissions, substitutions, and other variations as are permitted or required by the Forty-Third Supplement, and may have such letters, numbers, or other marks of identification (including identifying numbers and letters of the Committee on Uniform Securities Identification Procedures (CUSIP) of the American Bankers Association) and any other legends and endorsements (including insurance legends in the event the Bonds, or any maturities of the Bonds, are purchased with insurance and any reproduction of an opinion of counsel) as may be established by the City or determined by the officers executing the Bonds as evidenced by their execution of the Bonds. Any portion of the text of any Bond may be set forth on the reverse of the Bond, with an appropriate reference on the face of the Bond.

The definitive Bonds and the Initial Bond shall be printed, lithographed, or engraved, typewritten, photocopied or otherwise reproduced in any other similar manner, all as determined by the officers executing the Bonds as evidenced by their execution of the Bonds.

SECTION 11: CRITERIA FOR ISSUANCE OF PARITY WATER/ WASTEWATER OBLIGATIONS. The City has provided certain criteria and established certain covenants and agreements in relation to the issuance of Parity Water/Wastewater Obligations of the Water/Wastewater System pursuant to the 375 Master Ordinance and Prior Supplements. The Forty-Third Supplement provides 376 for the authorization, issuance, sale, delivery, form, characteristics, provisions of 377 payment, and security of the Bonds which are Parity Water/Wastewater 378 Obligations. The Master Ordinance is incorporated by reference and made a part 379 of the Forty-Third Supplement for all purposes, except to the extent modified and 380 supplemented by the Prior Supplements and the Forty-Third Supplement, and the 381 Bonds are declared to be Parity Water/Wastewater Obligations under the Master 382 Ordinance and Prior Supplements. The City determines that it will have sufficient 383 Page 10 of 31

funds to meet the financial obligations of the Water/Wastewater System, including 384 sufficient Net Revenues to pay the Annual Debt Service Requirements of the 385 Bonds and the Previously Issued Parity Water/Wastewater Obligations and to meet 386 all financial obligations of the City relating to the Water/Wastewater System. 387

388 SECTION 12: PLEDGE. The Net Revenues of the Water/Wastewater System are pledged to the payment of the Bonds, and the Bonds, together with the 389 Prior Subordinate Lien Obligations and the Previously Issued Parity 390 Water/Wastewater Obligations currently Outstanding, shall be equally and ratably 391 secured by a parity lien on and pledge of the Net Revenues of the 392 Water/Wastewater System in accordance with the terms of the Master Ordinance 393 and the Forty-Third Supplement. Additionally, the Bonds and the Previously 394 Issued Parity Water/Wastewater Obligations shall be equally and ratably secured 395 by a lien on the funds, if any, deposited to the credit of the Debt Service Fund in 396 accordance with the terms of the Master Ordinance, the Prior Supplements and the 397 Forty-Third Supplement. The Parity Water/Wastewater Obligations, and the 398 interest on the Parity Water/Wastewater Obligations, shall constitute a lien on the 399 Net Revenues of the Water/Wastewater System and be valid and binding and fully 400 perfected from and after the date of adoption of the Forty-Third Supplement 401 without physical delivery or transfer of control of the Net Revenues, the filing of 402 the Forty-Third Supplement or any other act, all as provided in Chapter 1208. The 403 owners of the Parity Water/Wastewater Obligations shall never have the right to 404 demand payment out of funds raised or to be raised by taxation, or from any source 405 other than specified in the Master Ordinance, the Prior Supplements and the Forty-406 Third Supplement. 407

Chapter 1208 applies to the issuance of the Bonds and the pledge of the Net Revenues of the Water/Wastewater System granted by the City under this Section 12, and the pledge is valid, effective and perfected. If Texas law is amended at any 410 time while the Bonds are Outstanding such that the pledge of the Net Revenues of 412 the Water/Wastewater System granted by the City under this Section 12 is to be subject to the filing requirements of Chapter 9, then to preserve to the registered 413 owners of the Bonds the perfection of the security interest in the pledge, the City 414 agrees to take measures as it determines are reasonable and necessary under Texas 415 law to comply with the applicable provisions of Chapter 9, and enable a filing to 416 perfect the security interest in the pledge to occur. 417

SECTION 13: DEBT SERVICE FUND. By reason of the issuance of the 418 Bonds, the City need not establish any special accounts within the Debt Service 419 Fund and following the delivery of the Bonds, the City agrees and covenants that 420 in addition to the deposits for the payment of the Previously Issued Parity 421 Water/Wastewater Obligations there shall be deposited to the credit of the Debt 422 Service Fund an amount equal to one hundred percent (100%) of the amount 423 required to fully pay the interest on and principal of the Bonds falling due on or 424

before each maturity, mandatory redemption date and interest payment date, and
such deposits shall be made in substantially equal monthly amounts on or before
the 14th day of each month beginning on or before the 14th day of the month next
following the month the Bonds are delivered to the Purchaser.

The required monthly deposits to the Debt Service Fund for the payment of principal of and interest on the Bonds shall continue to be made in the manner provided in this Section until such time as (i) the total amount on deposit in the Debt Service Fund is equal to the amount required to fully pay and discharge all Parity Water/Wastewater Obligations then Outstanding or (ii) the Bonds are no longer outstanding, *i.e.*, fully paid as to principal and interest or all the Bonds have been refunded.

Any accrued interest received from the Purchaser shall be deposited in the Debt Service Fund, and shall be taken into consideration and reduce the amount of the monthly deposits that would otherwise be required to be deposited to the credit of the Debt Service Fund from the Net Revenues of the Water/Wastewater System.

SECTION 14: **RESERVE FUND**. In accordance with the provisions of the Prior Supplements authorizing the issuance of certain of the Previously Issued Water/Wastewater Obligations, the Required Reserve Amount is funded with cash and Credit Facilities originally issued by Ambac Assurance Corporation and XL Capital Assurance Inc.

The Reserve Fund shall be funded with proceeds of the Bonds, in the amount described in the letter of instructions executed in accordance with Section 26 of the Forty-Third Supplement, and in accordance with the Board Resolution.

Furthermore, in accordance with Section 10(d) of the Master Ordinance,
council finds that the Gross Revenues will be sufficient to meet the obligations of
the Water/Wastewater System, including sufficient Net Revenues to satisfy the
Annual Debt Service Requirements of Parity Water/Wastewater Obligations
currently Outstanding and the financial obligations of the City under any Credit
Facility entered into with the Credit Facility providers.

SECTION 15: **PAYMENT OF BONDS**. On or before the first scheduled 454 interest payment date, and on or before each subsequent interest payment date and 455 principal payment date while any Bond is Outstanding, the City shall cause an 456 amount to be transferred to the Paying Agent/Registrar in immediately available 457 funds from the Debt Service Fund sufficient to pay the interest on and the principal 458 amount of the Bonds, as shall become due on each payment date, respectively, at 459 460 maturity or by redemption prior to maturity. The Paying Agent/Registrar shall destroy all paid Bonds and furnish the City with an appropriate certificate of 461 cancellation or destruction. 462 463

# SECTION 16: COVENANTS TO MAINTAIN TAX-EXEMPT STATUS.

The City covenants to refrain from any action which would adversely affect, or to take any action to assure, the treatment of the Bonds as obligations described in section 103 of the Code, the interest on which is not includable in the "gross income" of the holder for purposes of federal income taxation. In furtherance thereof, the City covenants as follows:

(a) to take any action to assure that no more than 10 percent of the proceeds of the Bonds or the projects financed therewith (less amounts deposited to a reserve fund, if any) are used for any "private business use", as defined in section 141(b)(6) of the Code or, if more than 10 percent of the proceeds are so used, that amounts, whether or not received by the City, with respect to such private business use, do not, under the terms of this Forty-Third Supplement or any underlying arrangement, directly or indirectly, secure or provide for the payment of more than 10 percent of the debt service on the Bonds, in contravention of section 141(b)(2) of the Code;

(b) to take any action to assure that in the event that the "private business use" described in subsection (a) hereof exceeds 5 percent of the proceeds of the Bonds or the projects financed therewith (less amounts deposited into a reserve fund, if any) then the amount in excess of 5 percent is used for a "private business use" which is "related" and not "disproportionate", within the meaning of section 141(b)(3) of the Code, to the governmental use;

(c) to take any action to assure that no amount which is greater than the lesser of \$5,000,000, or 5 percent of the proceeds of the Bonds (less amounts deposited into a reserve fund, if any), is directly or indirectly used to finance loans to persons, other than state or local governmental units, in contravention of section 141(c) of the Code;

(d) to refrain from taking any action which would otherwise result in the
Bonds being treated as "private activity bonds" within the meaning of section
141(a) of the Code;

496 (e) to refrain from taking any action that would result in the Bonds being
497 "federally guaranteed" within the meaning of section 149(b) of the Code;

(f) to refrain from using any portion of the proceeds of the Bonds,
directly or indirectly, to acquire or to replace funds which were used, directly or
indirectly, to acquire investment property (as defined in section 148(b)(2) of the
Code) which produces a materially higher yield over the term of the Bonds, other
than investment property acquired with --

(1) proceeds of the Bonds invested for a reasonable temporary period, until such proceeds are needed for the purpose for which the Bonds are issued,

(3) amounts deposited in any reasonably required reserve or replacement fund to the extent such amounts do not exceed 10 percent of the proceeds of the Bonds;

(g) to otherwise restrict the use of the proceeds of the Bonds or amounts
treated as proceeds of the Bonds, as may be necessary, so that the Bonds do not
otherwise contravene the requirements of section 148 of the Code (relating to
arbitrage);

(h) to refrain from using the proceeds of the Bonds or the proceeds of any
prior bonds to pay debt service on another issue more than ninety (90) days after
the issuance of the Bonds in contravention of section 149 of the Code (relating to
advance refundings); and

(i) to pay to the United States of America at least once during each fiveyear period (beginning on the Delivery Date of the Bonds) an amount that is at
least equal to 90 percent of the "excess earnings", within the meaning of section
148(f) of the Code, and to pay to the United States of America, not later than 60
days after the Bonds have been paid in full, 100 percent of the amount then
required to be paid as a result of Excess Earnings under section 148(f) of the Code.

The City understands that the term "proceeds" includes "disposition 525 proceeds" as defined in the Treasury Regulations and, in the case of a refunding 526 bond, transferred proceeds (if any) and proceeds of the refunded bonds expended 527 528 prior to the date of the issuance of the Bonds. It is the understanding of the City that these covenants are intended to assure compliance with the Code and any 529 regulations or rulings promulgated by the U.S. Department of the Treasury 530 pursuant to the Code. In the event that regulations or rulings are hereafter 531 promulgated which modify or expand provisions of the Code, as applicable to the 532 Bonds, the City will not be required to comply with any covenant contained in this 533 Section to the extent that the failure to comply, in the opinion of nationally-rec-534 ognized bond counsel, will not adversely affect the exemption from federal income 535 taxation of interest on the Bonds under section 103 of the Code. In the event that 536 regulations or rulings are hereafter promulgated which impose additional 537 requirements which are applicable to the Bonds, the City agrees to comply with the 538 additional requirements to the extent necessary, in the opinion of nationally-recog-539 nized bond counsel, to preserve the exemption from federal income taxation of 540 interest on the Bonds under section 103 of the Code. In furtherance of the 541 Page 14 of 31

foregoing, the Mayor, the City Manager or Acting or Interim City Manager, any
Assistant City Manager, the Chief Financial Officer of the City, any Deputy
Financial Officer of the City and the City Treasurer may execute any certificates or
other reports required by the Code and make such elections, on behalf of the City,
which may be permitted by the Code as are consistent with the purpose for the
issuance of the Bonds. In order to facilitate compliance with the above clause (i), a
"Rebate Fund" is established by the City for the sole benefit of the United States of
America, and the Rebate Fund shall not be subject to the claim of any other person,
including without limitation the registered owners of the Bonds. The Rebate Fund
is established for the additional purpose of compliance with section 148 of the
Code.

# SECTION 16A: ALLOCATION OF, AND LIMITATION ON, EXPENDITURES FOR THE BOND-FINANCED PROPERTY; DISPOSITION OF BOND-FINANCED PROPERTY.

The City covenants to account for on its books and records the expenditure of proceeds from the sale of the Bonds and any investment earnings thereon to be used for the improvement and extension of the System (referred to in this Section as a "Project") by allocating proceeds to expenditures within 18 months of the later of the date that (a) the expenditure on a Project is made or (b) each such Project is The foregoing notwithstanding, the City shall not expend such completed. proceeds or investment earnings more than 60 days after the later of (a) the fifth anniversary of the Delivery Date of the Bonds or (b) the date the Bonds are retired, unless the City obtains an opinion of nationally-recognized bond counsel substantially to the effect that such expenditure will not adversely affect the taxexempt status of the Bonds. For purposes of this Section, the City shall not be obligated to comply with this covenant if it obtains an opinion of nationallyrecognized bond counsel to the effect that such failure to comply will not adversely affect the excludability for federal income tax purposes from gross income of the interest.

The City covenants that the property constituting the Project will not be sold or otherwise disposed in a transaction resulting in the receipt by the City of cash or other compensation, unless the City obtains an opinion of nationally-recognized bond counsel substantially to the effect that the sale or other disposition will not adversely affect the tax-exempt status of the Bonds. The portion of the property comprising personal property and disposed of in the ordinary course of business shall not be treated as a transaction resulting in the receipt of cash or other compensation. The City shall not be obligated to comply with this covenant if it obtains an opinion of nationally-recognized bond counsel to the effect that the failure to comply will not adversely affect the excludability for federal income tax purposes from gross income of the interest. (a) <u>Required Owner Consent for Amendments</u>. The owners of a majority in Outstanding Principal Amount of the Bonds shall have the right from time to time to approve any amendment to the Forty-Third Supplement which may be deemed necessary or desirable by the City; provided, however, nothing contained in the Forty-Third Supplement shall permit or be construed to permit the amendment of the terms and conditions in the Forty-Third Supplement so as to:

SECTION 17: AMENDMENT OF FORTY-THIRD SUPPLEMENT.

- (1) Make any change in the maturity of any of the Outstanding Bonds;
- (2) Reduce the rate of interest borne by any of the Outstanding Bonds;
- (3) Reduce the amount of the principal payable on the Bonds;
- (4) Modify the terms of payment of principal of, premium, if any, or interest on the Outstanding Bonds or impose any conditions with respect to such payment;
- (5) Affect the rights of the owners of less than all of the Bonds then Outstanding;
- (6) Amend this subsection (a) of this Section; or
- (7) Change the minimum percentage of the principal amount of Bonds necessary for consent to any amendment;

unless such amendment or amendments be approved by the owners of all of the Bonds affected by the change or amendment then Outstanding.

606 Notice of Amendment Requiring Consent. If at any time the City (b) shall desire to amend the Forty-Third Supplement under this Section, the City shall 607 cause notice of the proposed amendment to be published in a financial newspaper 608 or journal published in The City of New York, New York, and a newspaper of 609 general circulation in the City, once during each calendar week for at least two 610 successive calendar weeks. The notice shall briefly set forth the nature of the 611 612 proposed amendment and shall state that a copy of the notice is on file with the Paying Agent/Registrar for the Bonds. Publication is not required, however, if 613 notice in writing is given by United States Mail, first class postage prepaid, to each 614 owner of the Bonds. 615

Time Period for Obtaining Consent. If within one year from (i) the 616 (c) date of the first publication of notice or (ii) the date of the mailing by the Paying 617 Agent/Registrar of written notice to the owners of the Bonds, whichever date first 618 occurs if both methods of giving notice are used, the City shall receive an 619 instrument or instruments executed by the owners of at least a majority in 620 Outstanding Principal Amount of the Bonds consenting to and approving such 621 amendment in substantially the form of the copy of such instrument on file with 622 each Paying Agent/Registrar, the governing body of the City may pass the 623 amendatory ordinance in substantially the same form. 624

Revocation of Consent. Any consent given by the owner of a Bond 625 (d) pursuant to the provisions of this Section shall be irrevocable for a period of six 626 months from the date for measuring the one year period to obtain consents noted in 627 paragraph (c) above, and shall be conclusive and binding upon all future owners of 628 the same Bonds during such period. At any time after six months from the date for 629 measuring the one year period to obtain consents noted in paragraph (c) above, 630 consent may be revoked by the owner who gave the consent, or by a successor in 631 title, by filing written notice with the Paying Agent/Registrar for the Bonds and the 632 City, but revocation shall not be effective if the owners of at least a majority in 633 Outstanding Principal Amount of the then Outstanding Bonds as determined in 634 accordance with this Section have, prior to the attempted revocation, consented to 635 and approved the amendment. 636

(e) <u>Implementation of Amendment</u>. Upon the passage of any amendatory ordinance pursuant to the provisions of this Section, the Forty-Third Supplement shall be deemed to be amended, and the respective rights, duties and obligations of the City under the Forty-Third Supplement and all the owners of then Outstanding Bonds shall be determined, exercised and enforced in all respects in accordance with the amendment.

643 (f) <u>Amendment without Consent</u>. The preceding provisions of this
644 Section notwithstanding, the City by action of its governing body may amend the
645 Forty-Third Supplement for any one or more of the following purposes:

(1) To add to the covenants and agreements of the City contained in the Forty-Third Supplement, other covenants and agreements thereafter to be observed, grant additional rights or remedies to the owners of the Bonds or to surrender, restrict or limit any right or power reserved in the Forty-Third Supplement to or conferred upon the City;

(2) To make provision for the purpose of curing any ambiguity, or curing, correcting or supplementing any defective provision contained in the Forty-Third Supplement, or in regard to clarifying matters or questions arising under the Forty-Third Supplement, as are necessary or desirable and not contrary to or inconsistent with the Forty-Third Supplement and which shall not adversely affect the interests of the owners of the Bonds then Outstanding;

(3) To modify any of the provisions of the Forty-Third Supplement in any other respect whatever, provided that any modification shall be, and be expressed to be, effective only after all the Bonds outstanding at the date of the adoption of the modification shall cease to be outstanding; (4) To make amendments to the Forty-Third Supplement as may be required, in the opinion of Bond Counsel, to ensure compliance with sections 103 and 141 through 150 of the Code and the regulations promulgated under and applicable to those sections and regulations;

(5) To make changes, modifications or amendments as may be necessary or desirable to allow the owners of the Bonds to avail themselves of a book-entry system for payments, transfers and other matters relating to the Bonds, which changes, modifications or amendments are not contrary to or inconsistent with other provisions of the Forty-Third Supplement and which shall not adversely affect the interests of the owners of the Bonds;

(6) To make amendments to the vSupplement as permitted by Section 21(e) of the Forty-Third Supplement;

(7) To make changes, modifications or amendments as may be necessary or desirable to obtain the approval of the Bonds from the Attorney General of Texas, to obtain or maintain the granting of a rating on the Bonds by a Rating Agency or to obtain or maintain a Credit Agreement or a Credit Facility; and

(8) To make changes, modifications or amendments as may be necessary or desirable, which shall not adversely affect the interests of the owners of the Bonds, in order, to the extent permitted by law, to facilitate the economic and practical utilization of interest rate swap agreements, foreign currency exchange agreements, or similar types of agreements with respect to the Bonds.

Notice of an amendment may be published by the City in the manner described in
clause (b) of this Section; provided, however, that the publication of a notice shall
not constitute a condition precedent to the adoption of an amendatory ordinance
and the failure to publish a notice shall not adversely affect the implementation of
an amendment as adopted pursuant to the amendatory ordinance.

Ownership. For the purpose of this Section, the ownership and other 694 (g) matters relating to all Bonds shall be established by the Security Register 695 maintained by the Paying Agent/Registrar. Furthermore, the owner of any Bonds 696 insured as to the payment of principal of and interest shall be deemed to be the 697 insurance company providing the insurance coverage on the Bonds; provided, the 698 amendment to the Forty-Third Supplement is an amendment that can be made with 699 the consent of a majority in Outstanding Principal Amount of the Bonds and the 700 insurance company is not in default with respect to its obligations under its 701 insurance policy, if any. 702

SECTION 18: FINAL DEPOSITS; GOVERNMENT OBLIGATIONS. 703 All or any of the Bonds shall be deemed to be paid, retired and no longer 704 outstanding within the meaning of the Forty-Third Supplement when payment of 705 the principal of, and redemption premium, if any, on the Bonds, plus interest on the 706 Bonds to the due date (whether the due date is by reason of maturity or otherwise) 707 708 either (i) shall have been made or caused to be made in accordance with the terms of the Bonds, or (ii) shall have been provided by irrevocably depositing with, or 709 making available to, the Paying Agent/Registrar, in trust and irrevocably set aside 710 exclusively for this payment, (1) money sufficient to make the payment or 711 (2) Government Obligations, certified by an independent public accounting firm of 712 national reputation, to mature as to principal and interest in amounts and at the 713 times as will insure the availability, without reinvestment, of sufficient money to 714 make this payment, and all necessary and proper fees, compensation and expenses 715 of the Paying Agent/Registrar with respect to which the deposit is made shall have 716 been paid or the payment provided for the satisfaction of the Paying 717 718 Agent/Registrar. Once a Bond shall be deemed to be paid under the Forty-Third Supplement, it shall no longer be secured by or entitled to the benefit of the Forty-719 Third Supplement, the Master Ordinance or a lien on and pledge of the Net 720 Revenues of the Water/Wastewater System, and shall be entitled to payment solely 721 from the money or Government Obligations. 722

Any moneys so deposited with the Paying Agent/Registrar, or an authorized 723 escrow agent, may at the direction of the City also be invested in Government 724 Obligations, maturing in the amounts and at the times as set forth in this Section, 725 and all income from all Government Obligations not required for the payment of 726 the Bonds, the redemption premium, if any, and interest on the Bonds, with respect 727 728 to which the money has been so deposited, shall be turned over to the City or deposited as directed by the City. The City covenants that no deposit will be made 729 730 or accepted under clause (ii) of this Section and no use made of any deposit which would cause the Bonds to be treated as arbitrage bonds within the meaning of 731 section 148 of the Code. 732

Notwithstanding any other provisions of the Forty-Third Supplement, all money or Government Obligations set aside and held in trust pursuant to the provisions of this Section for the payment of the Bonds, the redemption premium, if any, and interest on the Bonds, shall be applied to and used for the payment of the Bonds, the redemption premium, if any, and interest on the Bonds and the income on the money or Government Obligations shall not be considered to be "Gross Revenues" under the Forty-Third Supplement.

740 SECTION 19: DAMAGED, MUTILATED, LOST, STOLEN, OR
741 DESTROYED BONDS. In the event any Outstanding Bond is damaged,
742 mutilated, lost, stolen, or destroyed, the Paying Agent/Registrar shall cause to be
743 printed, executed, and delivered, a new bond of the same principal amount,

maturity, and interest rate, as the damaged, mutilated, lost, stolen, or destroyed 744 Bond, in replacement for the Bond in the manner provided in this Section. An 745 application for the replacement of damaged, mutilated, lost, stolen, or destroyed 746 Bonds shall be made to the Paying Agent/Registrar. In every case of loss, theft, or 747 destruction of a Bond, the applicant for a replacement bond shall furnish to the 748 City and to the Paying Agent/Registrar security or indemnity as may be required 749 by them to save each of them harmless from any loss or damage with respect 750 thereto. Also, in every case of loss, theft, or destruction of a Bond, the applicant 751 shall furnish to the City and to the Paying Agent/Registrar evidence to their 752 satisfaction of the loss, theft, or destruction of the Bond, as the case may be. In 753 754 every case of damage or mutilation of a Bond, the applicant shall surrender to the Paving Agent/Registrar for cancellation the Bond so damaged or mutilated. Prior 755 to the issuance of any replacement bond, the Paying Agent/Registrar shall charge 756 the owner of the Bond with all legal, printing, and other expenses in connection 757 with this issuance. Every replacement bond issued pursuant to the provisions of 758 759 this Section by virtue of the fact that any Bond is lost, stolen, or destroyed shall constitute a contractual obligation of the City whether the lost, stolen, or destroyed 760 Bond shall be found at any time, or be enforceable by anyone, and shall be entitled 761 to all the benefits of the Forty-Third Supplement equally and proportionately with 762 any and all other Bonds issued under the Forty-Third Supplement. 763

Notwithstanding the preceding provisions of this Section, in the event any Bond shall have matured, and no default has occurred which is then continuing in the payment of the principal of, redemption premium, if any, or interest on the Bond, the City may authorize the payment of the same (without surrender of the Bond except in the case of a damaged or mutilated Bond) instead of issuing a replacement Bond, provided security or indemnity is furnished as above provided in this Section. Furthermore, in accordance with Chapter 1206 (specifically Section 1206.022), this Section shall constitute authority for the issuance of any replacement bond without necessity of further action by the governing body of the City or any other body or person, and the duty of the replacement of Bonds is authorized and imposed upon the Paying Agent/Registrar, and the Paying Agent/Registrar shall authenticate and deliver replacement bonds in the form and manner and with the effect, as provided in Section 6 of the Forty-Third Supplement for Bonds issued in exchange for other Bonds.

SECTION 20: FORTY-THIRD SUPPLEMENT TO CONSTITUTE A
CONTRACT; EQUAL SECURITY. In consideration of the acceptance of the
Bonds by the Holders from time to time, the Forty-Third Supplement shall be
deemed to be and shall constitute a contract between the City and the Holders from
time to time of the Bonds and the pledge made in the Forty-Third Supplement by
the City and the covenants and agreements set forth in the Forty-Third Supplement
to be performed by the City shall be for the equal and proportionate benefit,
security, and protection of all Holders, without preference, priority, or distinction

as to security or otherwise of any of the Bonds authorized under the Forty-Third
Supplement over any of the others by reason of time of issuance, sale, or maturity
or otherwise for any cause whatsoever, except as expressly provided in or
permitted by the Forty-Third Supplement.

# SECTION 21: CONTINUING DISCLOSURE UNDERTAKING.

(a) <u>Definitions</u>. As used in this Section, the following terms have the meanings ascribed below:

Annual Reports. The City shall provide annually to the MSRB (1) (b) 798 within six months after the end of each fiscal year ending in or after 2022, financial 799 information and operating data with respect to the City of the general type included 800 in the final Official Statement and which is described in Exhibit B to the Forty-801 Third Supplement, and (2) if not provided as part of the financial information and 802 operating data, audited financial statements of the City, when and if available. 803 Any financial statements provided shall be prepared in accordance with the 804 accounting principles described in Exhibit B to the Forty-Third Supplement, or 805 other accounting principles as the City may be required to employ from time to 806 time pursuant to state law or regulation, and audited, if the City commissions an 807 audit of the statements and the audit is completed within twelve months after the 808 end of each fiscal year ending in or after 2022. If audited financial statements of 809 the City are not available by the end of the 12 month period, the City will provide 810 811 notice that the audited financial statements are not available, and will provide unaudited financial statements by the end of the 12 month period and audited 812 financial statements for the applicable fiscal year when and if the audited financial 813 statements become available. 814

815 If the City changes its fiscal year, it will notify the MSRB of the change (and 816 of the date of the new fiscal year end) prior to the next date by which the City 817 otherwise would be required to provide financial information and operating data 818 pursuant to this Section.

819 The financial information and operating data to be provided pursuant to this 820 Section may be set forth in full in one or more documents or may be included by 821 specific reference to any document available to the public on the MSRB's Internet 822 Web site or filed with the SEC.

For these purposes, any event described in the immediately preceding paragraph 12 is considered to occur when any of the following occur: the appointment of a receiver, fiscal agent, or similar officer for the City in a proceeding under the United States Bankruptcy Code or in any other proceeding under state or federal law in which a court or governmental authority has assumed jurisdiction over substantially all of the assets or business of the City, or if jurisdiction has been assumed by leaving the existing governing body and officials or officers in possession but subject to the supervision and orders of a court or governmental authority, or the entry of an order confirming a plan of reorganization, arrangement, or liquidation by a court or governmental authority having supervision or jurisdiction over substantially all of the assets or business of the City.

As used in paragraphs 15 and 16 above, the term "Financial Obligation" means: (i) a debt obligation; (ii) a derivative instrument entered into in connection with, or pledged as security or a source of payment for, an existing or planned debt obligation; or (iii) a guarantee of (i) or (ii), however, the term Financial Obligation shall <u>not</u> include Municipal Securities as to which a final official statement has been provided to the MSRB consistent with the Rule; the term "Municipal Securities" means securities which are direct obligations of, or obligations guaranteed as to principal or interest by, a state or any political subdivision thereof, or any agency or instrumentality of a state or any political subdivision thereof, or any municipal corporate instrumentality of one or more states and any other Municipal Securities described by Section 3(a)(29) of the Securities Exchange Act of 1934, as the same may be amended from time to time; and the term "Obligated Person" means the City.

(d) <u>Filings with the MSRB</u>. All financial information, operating data, financial statements, notices, and other documents provided to the MSRB in accordance with this Section shall be provided in an electronic format prescribed by the MSRB and shall be accompanied by identifying information as prescribed by the MSRB.

The City shall be 897 (e) Limitations, Disclaimers, and Amendments. obligated to observe and perform the covenants specified in this Section with 898 respect to the City and the Bonds while, but only while, the City remains an 899 "obligated person" with respect to the Bonds within the meaning of the Rule, 900 901 except that the City in any event will give the notice required by subsection (c) of this Section of any Bond calls and defeasance that cause the City to be no longer 902 such an "obligated person." 903

The provisions of this Section are for the sole benefit of the Holders and 904 beneficial owners of the Bonds, and nothing in this Section, express or implied, 905 shall give any benefit or any legal or equitable right, remedy, or claim to any other 906 person. The City undertakes to provide only the financial information, operating 907 data, financial statements, and notices which it has expressly agreed to provide 908 pursuant to this Section and does not undertake to provide any other information 909 that may be relevant or material to a complete presentation of the financial results, 910 condition, or prospects of the City or the State or undertake to update any 911 information provided in accordance with this Section or otherwise, except as 912 expressly provided in this Section. The City does not make any representation or 913 warranty concerning the information or its usefulness to a decision to invest in or 914 915 sell Bonds at any future date.

UNDER NO CIRCUMSTANCES SHALL THE CITY BE LIABLE TO
THE HOLDER OR BENEFICIAL OWNER OF ANY BOND OR ANY OTHER
PERSON, IN CONTRACT OR TORT, FOR DAMAGES RESULTING IN
WHOLE OR IN PART FROM ANY BREACH BY THE CITY, WHETHER
NEGLIGENT OR WITHOUT FAULT ON ITS PART, OF ANY COVENANT
SPECIFIED IN THIS SECTION, BUT EVERY RIGHT AND REMEDY OF ANY
PERSON, IN CONTRACT OR TORT, FOR OR ON ACCOUNT OF ANY
BREACH SHALL BE LIMITED TO AN ACTION FOR MANDAMUS OR
SPECIFIC PERFORMANCE.

No default by the City in observing or performing its obligations under this Section shall constitute a breach of or default under the Forty-Third Supplement for purposes of any other provision of the Forty-Third Supplement.

Nothing in this Section is intended or shall act to disclaim, waive, or otherwise limit the duties of the City under federal and state securities laws.

Should the Rule be amended to obligate the City to make filings with or provide notices to entities other than the MSRB, the City agrees to undertake the obligation in accordance with the Rule as amended.

Notwithstanding any provisions in the Forty-Third Supplement to the contrary, the provisions of this Section may be amended by the City from time to time to adapt to changed circumstances resulting from a change in legal requirements, a change in law, or a change in the identity, nature, status, or type of operations of the City, but only if (1) the provisions of this Section, as so amended, would have permitted an underwriter to purchase or sell Bonds in the primary offering of the Bonds in compliance with the Rule, taking into account any amendments or interpretations of the Rule to the date of the amendment, as well as the changed circumstances, and (2) either (a) the Holders of a majority in aggregate principal amount (or any greater amount required by any other provision

of the Forty-Third Supplement that authorizes the amendment) of the Outstanding 943 Bonds consent to the amendment or (b) a Person that is unaffiliated with the City 944 and the State (such as nationally recognized bond counsel) determines that the 945 amendment will not materially impair the interests of the Holders and beneficial 946 owners of the Bonds. The provisions of this Section may also be amended from 947 time to time or repealed by the City if the SEC amends or repeals the applicable 948 provisions of the Rule or a court of final jurisdiction determines that the provisions 949 are invalid, but only if and to the extent that reservation of the City's right to do so 950 would not prevent underwriters of the initial public offering of the Bonds from 951 lawfully purchasing or selling Bonds in the offering. If the City so amends the 952 provisions of this Section, it shall include with any amended financial information 953 or operating data next provided in accordance with subsection (b) an explanation, 954 in narrative form, of the reasons for the amendment and of the impact of any 955 change in the type of financial information or operating data so provided. 956

SECTION 22: REMEDY IN EVENT OF DEFAULT. In addition to all 957 rights and remedies provided by the laws of the State and set forth in the Board 958 Resolution (other than acceleration), the City covenants and agrees particularly that 959 in the event the City (a) defaults in payments to be made to the Debt Service Fund 960 as required by the Forty-Third Supplement or the Master Ordinance, (b) defaults in 961 the observance or performance of any other of the covenants, conditions or 962 obligations set forth in the Forty-Third Supplement or the Master Ordinance or (c) 963 the City declares bankruptcy, the Holders of any of the Bonds shall be entitled to a 964 writ of mandamus issued by a court of proper jurisdiction, compelling and 965 requiring the City and its officers to observe and perform any covenant, condition 966 or obligation prescribed in the Forty-Third Supplement or the Master Ordinance. 967 No delay or omission to exercise any right or power accruing upon any default 968 shall impair any such right or power, or shall be construed to be a waiver of any 969 such default or acquiescence in such default, and every such right and power may 970 be exercised from time to time and as often as may be deemed expedient. 971

The specific remedy provided in this Section shall be cumulative of all other existing remedies and the specification of such remedy shall not be deemed to be exclusive.

SECTION 23: SALE OF BONDS. The Bonds are to be sold by the City to 975 976 the Purchaser for the price of par. The Bonds have been purchased by the Purchaser pursuant to the Board Resolution. The Initial Bond shall be registered in 977 the name of the Texas Water Development Board. The Private Placement 978 Memorandum prepared in connection with the sale of the Bonds to the Purchaser, 979 980 in substantially the form attached to the Forty-Third Supplement, is approved. The City has determined, based upon the advice provided by its financial advisor, that 981 acceptance of the purchase price for the Bonds is on terms advantageous to, and in 982 the best interests of, the City. 983

It is the intent of the parties to the sale of the Bonds that if TWDB ever
determines to sell all or a part of the Bonds, it shall notify the City at least 60 days
prior to the sale of the Bonds of the decision to sell the Bonds.

Payment of amounts due and owing on the Bonds to the TWDB shall be made by wire transfer, at no expense to the TWDB, as provided in the FORM OF BOND.

By agreeing to the purchase the Bonds, the TWDB agrees that the bond proceeds shall be deposited into the escrow fund established in the Escrow Agreement between the City and Wilmington Trust, N.A., Dallas, Texas, and that the procedures set forth in Section 5 of the Forty-Third Supplement satisfy the Board Resolution.

Proceeds from the sale of the Bonds shall be held at a designated state depository or other properly chartered and authorized institution in accordance with Chapter 2256 and Chapter 2257.

SECTION 24: **ADDITIONAL COVENANTS**. In connection with the sale of the Bonds to the TWDB, the City covenants as follows:

(a) <u>Compliance with TWDB Rules and Regulations</u>. The City covenants to comply with the rules and regulations of the TWDB, and to maintain insurance on the Water/Wastewater System in an amount as may be required by TWDB, as further addressed in this Section.

(b) Audits. For so long as the State owns any Bond, the City shall mail a copy of the audit required by the Master Ordinance to the TWDB. The audit shall be performed by an independent certified public accountant, a firm of independent certified public accountants, or a licensed professional auditor, in accordance with generally accepted accounting principles applicable to governmental entities such as the City. In addition, monthly operating statements for the Water/Wastewater 1012 System shall be maintained by the City and made available, on request, to the 1013 1014 TWDB as long as the State owns any Bond, and the monthly operating statement shall be in such detail as requested by the Development Fund Manager of the 1015 TWDB until the Development Fund Manager of the TWDB waives this 1016 requirement. 1017

1018 (c) <u>Final Accounting</u>. The City shall render, and submit within 60 days 1019 of the completion of the project, a final accounting to the TWDB in reference to 1020 the total cost incurred by the City for improvements and extensions to the 1021 Water/Wastewater System which were financed by the issuance of the Bonds, 1022 together with a copy of "as built" plans of the improvements and extensions upon 1023 completion.

(d) <u>Defeasance</u>. Should the City exercise its right under the Master Ordinance to effect the defeasance of the Bonds, the City agrees that it will provide the TWDB with written notice of any defeasance.

(e) <u>Segregation of Funds</u>. The City covenants that proceeds of the Bonds shall remain separate and distinct from other sources of funding from the date of the TWDB commitment through costing and final disbursement.

(f) <u>Environmental Indemnity</u>. Proceeds from the Bonds shall not be used by the City when sampling, testing, removing, or disposing of contaminated soils and/or media at the project site. To the extent permitted by law, the City agrees to indemnify, hold harmless, and protect the TWDB from any and all claims, causes of action, or damages to the person or property of third parties arising from the sampling, analysis, transport, storage, treatment, and disposition of any contaminated sewage sludge, contaminated sediments, and/or contaminated media that may be generated by the City, its contractors, consultants, agents, officials, and employees as a result of activities relating to the project funded with proceeds of the Bonds.

(g) <u>Environmental Determination</u>. In connection with the project financed with the Bonds, the City agrees to implement any environmental determination issued by the Executive Administrator of TWDB to satisfy the environmental review requirements set forth in 31 Texas Administrative Code 371.

(h) <u>Insurance</u>. The City agrees that it will maintain insurance on the Water/Wastewater System in an amount sufficient to protect TWDB's interest in the project financed with the proceeds of the Bonds. The City may self-insure in respect to satisfying this covenant.

(i) <u>Water Conservation Program</u>. The City has implemented or will implement an approved water conservation program in compliance with 31 Texas Administrative Code 371.71(a)(2)(F).

(j) <u>City will not Purchase TWDB Bonds</u>. The City agrees that it or any related party to the City will not purchase, as an investment or otherwise, bonds issued by TWDB including, without limitation, bonds issued by TWDB, the proceeds of which were used by TWDB to purchase the Bonds.

(k) <u>Compliance with Federal Contracting Law</u>. The City acknowledges that it has a legal obligation to comply with any applicable requirements of federal law relating to contracting with disadvantaged business enterprises, and the City shall report to the TWDB the amount of Bond proceeds, if any, that were used to compensate historically underutilized businesses that worked on the project, in accordance with 31 TAC § 363.1312.

(1) <u>Compliance with State Contracting Law</u>. The City acknowledges that it has a legal obligation to comply with any applicable requirements of State law, including, without limitation, Section 15.435 of the Texas Water Code, relating to contracting with historically underutilized businesses.

(m) Form 8038-G. The City will cause to be filed a Form 8038-G, consistent with the requirements of section 149(e) of the Code.

SECTION 25: **CONTROL AND CUSTODY OF BONDS**. The City Manager or Acting or Interim City Manager of the City shall be and is authorized to take and have charge of all necessary orders and records pending the sale of the Bonds, and shall take and have charge and control of the Initial Bond pending the approval thereof by the Attorney General, the registration thereof by the Comptroller of Public Accounts and the delivery thereof to the Purchaser.

Furthermore, the Mayor, Mayor Pro Tem, City Manager or Acting or Interim City Manager, any Assistant City Manager, Chief Financial Officer, any Deputy Financial Officer, City Clerk, Deputy City Clerk, City Treasurer, and City Attorney or Acting or Interim City Attorney, or any one or more of these officials, are authorized and directed to furnish and execute any documents relating to the City and its financial affairs as may be necessary for the sale of the Bonds, the approval of the Attorney General and registration by the Comptroller of Public Accounts and, together with the City's financial advisor, bond counsel and the Paying Agent/Registrar, make the necessary arrangements for their delivery to the Purchaser following the sale.

SECTION 26: PROCEEDS OF SALE. The proceeds from the sale of the
 Bonds shall be used in the manner described in the letter of instructions executed
 by the City.

1096 SECTION 27: LEGAL OPINION. The obligation of the Purchaser to 1097 accept delivery of the Bonds is subject to being furnished a final opinion of 1098 McCall, Parkhurst & Horton L.L.P., approving the Bonds as to their validity, the 1099 opinion to be dated and delivered as of the Delivery Date and payment for the 1100 Bonds. A true and correct reproduction of the opinion is authorized to be printed 1101 on the definitive Bonds or an executed counterpart of the opinion shall accompany 1102 the global Bonds deposited with DTC.

SECTION 28: CUSIP NUMBERS. CUSIP numbers may be printed or
typed on the definitive Bonds. It is expressly provided, however, that the presence
or absence of CUSIP numbers on the definitive Bonds shall be of no significance

or effect as regards the legality thereof and neither the City nor attorneys approving 1106 the Bonds as to legality are to be held responsible for CUSIP numbers incorrectly 1107 printed or typed on the definitive Bonds. 1108

SECTION 29: PAYMENT AND PERFORMANCE ON BUSINESS **DAYS**. Whenever under the terms of the Forty-Third Supplement or the Bonds, the performance date of any provision of the Forty-Third Supplement or the Bonds, including the payment of principal of or interest on the Bonds, shall occur on a day other than a Business Day, then performance, including the payment of principal of and interest on the Bonds, need not be made on that day but may be performed or paid, as the case may be, on the next succeeding Business Day with the same force and effect as if made on the date of performance or payment.

SECTION 30: LIMITATION OF BENEFITS WITH RESPECT TO 1117 THE FORTY-THIRD SUPPLEMENT. With the exception of the rights or 1118 benefits expressly conferred in the Forty-Third Supplement, nothing expressed or 1119 contained in the Forty-Third Supplement or implied from the provisions of the 1120 Forty-Third Supplement or the Bonds is intended or should be construed to confer 1121 upon or give to any person other than the City, the Holders, and the Paying 1122 Agent/Registrar, any legal or equitable right, remedy, or claim under or by reason 1123 of or in respect to the Forty-Third Supplement or any covenant, condition, 1124 stipulation, promise, agreement, or provision contained in the Forty-Third 1125 Supplement. The Forty-Third Supplement and all of the covenants, conditions, 1126 stipulations, promises, agreements, and provisions of the Forty-Third Supplement 1127 are intended to be and shall be for and inure to the sole and exclusive benefit of the 1128 City, the Holders, and the Paying Agent/Registrar as provided in the Forty-Third 1129 1130 Supplement and in the Bonds.

SECTION 31: NOTICES TO HOLDERS - WAIVER. Wherever the 1131 Forty-Third Supplement provides for notice to Holders of any event, the notice 1132 shall be sufficiently given (unless otherwise expressly provided in the Forty-Third 1133 Supplement) if in writing and sent by United States Mail, first class postage 1134 prepaid, to the address of each Holder appearing in the Security Register at the 1135 close of business on the Business Day next preceding the mailing of the notice. 1136

In any case where notice to Holders is given by mail, neither the failure to mail the notice to any particular Holders nor any defect in any notice so mailed shall affect the sufficiency of the notice with respect to all other Bonds. Where the Forty-Third Supplement provides for notice in any manner, the notice may be waived in writing by the Holder entitled to receive the notice, either before or after the event with respect to which notice is given, and the waiver shall be the 1142 equivalent of the notice. Waivers of notice by Holders shall be filed with the 1143 Paying Agent/Registrar, but a filing shall not be a condition precedent to the 1144 validity of any action taken in reliance upon the waiver. 1145

SECTION 32: GOVERNING LAW. The Forty-Third Supplement shall be construed and enforced in accordance with the laws of the State and the United 1147 States of America. 1148

SECTION 33: EFFECT OF HEADINGS. The Section headings in the 1149 1150 Forty-Third Supplement are for convenience of reference only and shall not affect the construction of the Forty-Third Supplement. 1151

SECTION 34: CONSTRUCTION OF TERMS. 1152 If appropriate in the context of the Forty-Third Supplement, words of the singular number shall be 1153 considered to include the plural, words of the plural number shall be considered to 1154 include the singular, and words of the masculine, feminine or neuter gender shall 1155 be considered to include the other genders. References to any named person shall 1156 mean that person and his or her successors and assigns. References to any 1157 constitutional, statutory or regulatory provision means the provision as it exists on 1158 the date the Forty-Third Supplement is adopted by council. Any reference to the 1159 payment of principal in the Forty-Third Supplement shall include the payment of 1160 any mandatory sinking fund redemption payments as described in the Forty-Third 1161 Supplement. Any reference to "FORM OF BOND" refers to the form of the Bonds 1162 1163 in **Exhibit** A to the Forty-Third Supplement.

SECTION 35: SEVERABILITY. If any provision of the Forty-Third 1164 Supplement or its application to any circumstance shall be held to be invalid, the 1165 remainder of the Forty-Third Supplement and its application to other 1166 circumstances shall nevertheless be valid, and council declares that the Forty-Third 1167 Supplement would have been enacted without such invalid provision. 1168

SECTION 36: CONSTRUCTION FUND. A fund entitled the "City of 1169 Austin, Texas Water and Wastewater System Series 2022A (SWIRFT) Revenue 1170 Bonds Construction Fund (the "Construction Fund") is created. Money in the 1171 Construction Fund shall be maintained at an official depository bank of the City. 1172

The proceeds of the Bonds shall be deposited into the Construction Fund and 1173 used by the City for payment of the costs of funding projects that are part of the 1174 State Water Plan to extend and improve the Water/Wastewater System, including 1175 any costs for engineering, financing, financial consultation, administrative, 1176 auditing and legal expenses. Amounts in the Construction Fund shall be used to 1177 pay costs timely, in compliance with applicable federal and State law. 1178

Any surplus proceeds, including the investment earnings derived from the 1179 investment of monies on deposit in the Construction Fund, from the Bonds 1180 remaining on deposit in the Construction Fund after completing the improvements 1181 and extensions to the System and upon the completion of the final accounting as 1182 described in Section 24 of the Forty-Third Supplement, shall be transferred to the 1183 Debt Service Fund to redeem the Bonds owned by TWDB, unless the Executive 1184 Page 30 of 31

Administrator of TWDB approves the use of the surplus proceeds to pay eligible
costs of improving or extending the System by funding projects that are a part of
the State Water Plan.

 SECTION 37: COMPLIANCE WITH CITY HUB REQUIREMENTS.
 The City acknowledges and confirms that it is in compliance with any and all requirements of its ordinances for the use of historically underutilized businesses.

SECTION 38: **PUBLIC MEETING**. It is officially found that the meeting at which the Forty-Third Supplement is adopted was open to the public and public notice of the time, place, and subject matter of the public business to be considered at such meeting, including the Forty-Third Supplement, was given; all as required by Chapter 551.

SECTION 39: EFFECTIVE DATE. This Forty-Third Supplement is
passed on one reading as authorized by Chapter 1201 (specifically Section
1201.028), and shall be effective immediately upon its passage and adoption.

SECTION 40: **CONCURRENT BONDS**. Concurrently with the adoption of this Forty-Third Supplement, Council adopted the Forty-Fourth Supplement and the Forty-Fifth Supplement authorizing the sale of the Concurrent Bonds to TWDB. The City of Austin (the "City"), a body corporate and municipal corporation in the Counties of Travis, Williamson and Hays, State of Texas, for value received promises to pay to the registered owner named above, or their registered assigns (the "Registered Owner"), solely from the revenues identified in this Bond, on the Stated Maturity date specified above the Principal Amount stated above (or so much of the Principal Amount as shall not have been paid upon prior redemption), and to pay interest (computed on the basis of a 360-day year of twelve 30-day months) on the unpaid Principal Amount of this Bond from the interest payment date next preceding the "Registration Date" of this Bond appearing below (unless this Bond bears a "Registration Date" as of an interest payment date, in which case it shall bear interest from such date, or unless the "Registration Date" of this Bond is prior to the initial interest payment date in which case it shall bear interest from the Delivery Date of this Bond specified above at the per annum rate of interest specified above; such interest being payable on May 15, 2023, and on each succeeding November 15 and May 15 until maturity or prior redemption.

Principal of this Bond is payable at its Stated Maturity or redemption to the Registered Owner, upon presentation and surrender, at the Designated Payment/Transfer Office of the Paying Agent/Registrar executing the registration certificate appearing on this Bond, or its successor; provided, however, while this Bond is registered to Cede & Co., the payment of principal upon a partial redemption of the principal amount of this Bond may be accomplished without presentation and surrender of this Bond. Interest is payable to the Registered Owner of this Bond (or one or more Predecessor Bonds, as defined in the Forty-

Third Supplemental Ordinance to the Master Ordinance (the "Forty-Third Supplement")) whose name appears on the "Security Register" maintained by the Paying Agent/Registrar at the close of business on the "Record Date", which is the last business day of the month next preceding each interest payment date and interest shall be paid by the Paying Agent/Registrar by check sent United States Mail, first class postage prepaid, to the address of the registered owner recorded in the Security Register or by such other method, acceptable to the Paying Agent/Registrar, requested by, and at the risk and expense of, the registered owner. The foregoing notwithstanding, so long as the Texas Water Development Board ("TWDB") is the beneficial owner of 100% in aggregate principal amount of the Bonds then outstanding, payment of principal of the Bonds shall be made thereto by wire transfer, at no expense to the TWDB. If the date for the payment of the principal of or interest on the Bonds shall be a Saturday, Sunday, a legal holiday, or a day when banking institutions in the city where the Designated Payment/Transfer Office of the Paying Agent/ Registrar is located are authorized by law or executive order to close, then the date for such payment shall be the next succeeding day which is not such a Saturday, Sunday, legal holiday, or day when banking institutions are authorized to close; and payment on such date shall have the same force and effect as if made on the original date payment was due. All payments of principal of, premium, if any, and interest on this Bond shall be without exchange or collection charges to the owner of this Bond and in any coin or currency of the United States of America which at the time of payment is legal tender for the payment of public and private debts.

This Bond is one of the series specified in its title dated September 27, 2022, issued in the aggregate principal amount of \$18,000,000 (the "Bonds") for the purpose of (i) extending and improving the City's combined water and wastewater system through the financing of projects that are part of the State of Texas' comprehensive water plan approved pursuant to Subchapter C of Chapter 16, Texas Water Code, (ii) funding a reserve fund for the Bonds, and (iii) paying the costs of issuance associated with the Bonds. The Bonds shall be issued in any denomination or denominations in any integral multiple of \$5,000 within a maturity (an "Authorized Denomination"). All capitalized terms not defined herein shall have the same meaning as given said terms in the Master Ordinance or the Forty-Third Supplement.

The Bonds maturing on and after November 15, 2033, may be redeemed prior to their Stated Maturities, at the option of the City, in whole or in part, in principal amounts of \$5,000 or any integral multiple thereof (and if within a Stated Maturity by lot by the Paying Agent/Registrar), on May 15, 2033, or on any date thereafter at the redemption price of par plus accrued interest thereon to the redemption date.

Not less than thirty days prior to a redemption date, the City shall cause a written notice of such redemption to be sent by United States Mail, first class postage prepaid, to the registered owners of each Bond to be redeemed at the address shown on the Security Register and subject to the terms and provisions relating thereto contained in the Forty-Third Supplement. If a Bond (or any portion of its principal sum) shall have been called for redemption and notice of such redemption given, then upon such redemption date such Bond (or the portion of its principal sum to be redeemed) shall become due and payable, and interest thereon shall cease to accrue from and after the redemption date therefor, provided moneys for the payment of the redemption price and the interest on the principal amount to be redeemed to the date of redemption are held for the purpose of such payment by the Paying Agent/Registrar.

In the event a portion of the principal amount of a Bond is to be redeemed and the registered owner is someone other than Cede & Co., payment of the redemption price of such principal amount shall be made to the registered owner only upon presentation and surrender of such Bond to the Designated Payment/Transfer Office of the Paying Agent/Registrar, and a new Bond or Bonds of like maturity and interest rate in any Authorized Denomination for the then unredeemed balance of the principal sum of such Bond or Bonds will be issued to the registered owner, without charge. If a Bond is selected for redemption, in whole or in part, the City and the Paying Agent/Registrar shall not be required to transfer such Bond to an assignee of the registered owner within forty-five days of the redemption date; provided, however, such limitation on transferability shall not be applicable to an exchange by the registered owner of the unredeemed balance of a Bond redeemed in part.

With respect to any optional redemption of the Bonds, unless the Paying Agent/Registrar has received funds sufficient to pay the principal and premium, if any, and interest on the Bonds to be redeemed before giving of a notice of redemption, the notice may state the City may condition redemption on the receipt of such funds by the Paying Agent/Registrar on or before the date fixed for the redemption, or on the satisfaction of any other prerequisites set forth in the notice of redemption. If a conditional notice of redemption is given and such prerequisites to the redemption and sufficient funds are not received, the notice shall be of no force and effect, the City shall not redeem the Bonds and the Paying Agent/Registrar shall give notice, in the manner in which the notice of redemption was given, that the Bonds have not been redeemed.

The Bonds are special obligations of the City payable solely from and, together with the Prior Subordinate Lien Obligations and the Previously Issued Parity Water/Wastewater Obligations currently Outstanding, equally and ratably secured by a parity lien on and pledge of, the Net Revenues of the Water/Wastewater System in the manner provided in the Master Ordinance and the Forty-Third Supplement. Additionally, the Bonds and Previously Issued Parity Water/Wastewater Obligations referenced above shall be equally and ratably secured by a parity lien on the funds, if any, deposited to the credit of the Debt Service Fund in accordance with the terms of the Master Ordinance and the Forty-Third Supplement. The Bonds do not constitute a legal or equitable pledge, charge, lien or encumbrance upon any property of the City or the Water/Wastewater System, except with respect to the Net Revenues. The Holder of this Bond shall never have the right to demand payment of this obligation out of any funds raised or to be raised by taxation.

Subject to satisfying the related terms and conditions, the City has reserved the right to issue additional revenue obligations payable from and equally and ratably secured by a parity lien on and pledge of the Net Revenues of the Water/Wastewater System, in the same manner and to the same extent as the Bonds.

Reference is made to the Master Ordinance and the Forty-Third Supplement, copies of which are on file with the Paying Agent/Registrar, and to all of the provisions of which the Holder by the acceptance of this Bond assents, for definitions of terms; the description of and the nature and extent of the security for the Bonds; the properties constituting the Water/Wastewater System; the Net Revenues pledged to the payment of the principal of and interest on the Bonds; the nature and extent and manner of enforcement of the lien and pledge securing the payment of the Bonds; the terms and conditions for the issuance of additional revenue obligations; the terms and conditions relating to the transfer or exchange of this Bond; the conditions upon which either the Master Ordinance or the Forty-Third Supplement may be amended or supplemented with or without the consent of the Holders; the rights, duties, and obligations of the City and the Paying Agent/Registrar; the terms and provisions upon which the liens, pledges, charges and covenants made in the Master Ordinance and the Forty-Third Supplement may be discharged at or prior to the maturity of this Bond, and this Bond deemed to be no longer Outstanding under the Master Ordinance and the Forty-Third Supplement; and for the other terms and provisions contained in the Master Ordinance and the Forty-Third Supplement. Capitalized terms used in this Bond have the same meanings assigned in the Master Ordinance and the Forty-Third Supplement.

This Bond, subject to certain limitations contained in the Forty-Third Supplement, may be transferred on the Security Register only upon its presentation and surrender at the Designated Payment/Transfer Office of the Paying Agent/Registrar, with the Assignment endorsed by, or accompanied by a written instrument of transfer in form satisfactory to the Paying Agent/Registrar executed by the Registered Owner, or the authorized agent of the Registered Owner. When a transfer on the Security Register occurs, one or more new fully registered Bonds of the same Stated Maturity, of authorized denominations, bearing the same rate of interest and of the same aggregate principal amount will be issued by the Paying Agent/Registrar to the designated transferee or transferees.

The City and the Paying Agent/Registrar, and any agent of either, may treat the Registered Owner of this Bond whose name appears on the Security Register (i) on the Record Date as the owner entitled to payment of interest on this Bond, (ii) on the date of surrender of this Bond as the owner entitled to payment of principal of this Bond at its Stated Maturity, or its redemption, in whole or in part, and (iii) on any other date as the owner for all other purposes, and neither the City nor the Paying Agent/Registrar, or any agent of either, shall be affected by notice to the contrary. In the event of non-payment of interest on a scheduled payment date and for thirty days after such event, a new record date for such interest payment (a "Special Record Date") will be established by the Paying Agent/Registrar, if and when funds for the payment of such interest have been received from the City. Notice of the Special Record Date and of the scheduled payment date of the past due interest (which shall be fifteen days after the Special Record Date) shall be sent at least five business days prior to the Special Record Date by United States Mail, first class postage prepaid, to the address of each Holder appearing on the Security Register at the close of business on the last business day next preceding the date of mailing of such notice.

It is certified, recited, represented and covenanted that the City is a duly organized and legally existing municipal corporation under and by virtue of the Constitution and laws of the State of Texas; that the issuance of the Bonds is authorized by law; that all acts, conditions and things required to exist and be done precedent to and in the issuance of the Bonds to render the same lawful and valid obligations of the City have been properly done, have happened and have been performed in regular and due time, form and manner as required by the Constitution and laws of the State of Texas, the Master Ordinance and the Forty-Third Supplement; that the Bonds do not exceed any constitutional or statutory limitation; and that due provision has been made for the payment of the principal of and interest on the Bonds by a pledge of the Net Revenues of the Water/Wastewater System. In case any provision in this Bond or any application thereof shall be invalid, illegal, or unenforceable, the validity, legality, and enforceability of the remaining provisions and applications shall not in any way be affected or impaired. The terms and provisions of this Bond, the Master Ordinance and the Forty-Third Supplement shall be construed in accordance with and shall be governed by the laws of the State of Texas.
