



# Emergency (P0)+ Urgent (P1) Call Volume by Month Q4 FY 2022\*




#### Budgeted Overtime vs. Actual Overtime\* 9/12/21 - 9/10/22



#### 145th Cadet Class (Regular)


- Started March 28th, 2022 with 84 cadets.

  - Starts October 10, 2022. Predicted 50 Cadets.




## Sworn Authorization FY 2019 through FY 2022
