As a follow up regarding OANA's request about the use of the \$18,500 of mitigation funds, i.e.:

• That these funds be used within a year of being received to plant native trees in the esplanade where needed along the West 12th Street between West Avenue and Colorado Street.

I've had positive conversations about this today with Andrew Smiley of Tree Folks and Dave Anderson representing the applicant.

If Naomi and Caitlan are agreeable and planting trees in the West 12<sup>th</sup> Street esplanade is approved by the city, just for your info, Tree Folks is willing to work with city staff to accomplish this project.
