3a. Briefing: City of Austin Interlocal Updates

Amendment No. 1

- ▶ Increases the total contract authority to \$25M
- ▶ Identifies increased funding provided through the City Budget Adoption
- Identifies additional funding in FY22-23 for the Cultural Trust
- Incorporates Administrative Costs/Fees for Cultural Trust
- ▶ Terms Approved by Council but under Legal and Staff Review

Addendum Item No. 6 – Creative Space Assistance Program (CSAP)

- CSAP is a \$2.5M anti-displacement grant available from City EDD intended to provide short-term support existing venues while the Cultural Trust is established.
- AEDC may review proposals and lease terms to determine commercial, technical, and legal feasibility and provide written reports and assessments to City staff in a format to be mutually agreed upon. AEDC may also provide support with eligibility verification and evaluation scoring.
- ▶ Up to \$250,000 for time and materials
- Request from the City to support three years/cycles of the program
