

WHEREAS, on October 18, 2007, the Council passed Ordinance No. 20071018-008 electing to participate in the Texas Enterprise Zone Program and make local incentives and economic development tools available to qualifying enterprise projects; and,

WHEREAS, the Governor’s Office of Economic Development and Tourism through the Economic Development Bank will consider the project proposed by Samsung Austin Semiconductor, LLC (“Samsung”) as an Enterprise Project pursuant to a nomination and an application made by the City; and

WHEREAS, the City desires to create the proper economic and social environment to induce the investment of private resources in productive business enterprises located in the City and to provide employment to residents of enterprise zones, veterans and other economically disadvantaged individuals; and

WHEREAS, pursuant to Chapter 2303, Subchapter F of the Texas Enterprise Zone Act, Texas Government Code ("Act"), Samsung has applied to the City for designation as an enterprise project; and

WHEREAS, the City finds that Samsung meets the criteria for designation as an Enterprise Project as required by the Act based on the following grounds:

- a) Samsung is a “qualified business” under the Act because it will be engaged in the active conduct of a trade or business at a qualified business site within the City’s jurisdiction located outside of an enterprise zone and at least 35 percent of the business’ new permanent

27 disadvantaged individuals or veterans; and

28 b) There has been and will continue to be a high level of cooperation
29 between public, private, and neighborhood entities within the area;
30 and

31 c) The designation of Samsung as an enterprise project will contribute
32 significantly to the achievement of the plans of the City for
33 development and revitalization of the area; and

34 **WHEREAS**, the City finds that Samsung meets the criteria for local
35 incentives and economic development tools adopted by the City and nominates
36 Samsung for Enterprise Project status on the grounds that this Enterprise Project
37 will be located at the qualified business site and will create a higher level of
38 employment, economic activity, and stability in the area; and

39 **WHEREAS**, the City finds that it is in the best interest of the City to
40 nominate Samsung as an Enterprise Project pursuant to the Act; **NOW**,
41 **THEREFORE**,

42 **BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:**

43 The City nominates Samsung Austin Semiconductor, LLC as an Enterprise
44 Project pursuant to Chapter 2303 of the Texas Government Code.

45 **BE IT FURTHER RESOLVED:**

46 That the findings of the City and its actions approving this Resolution taken
47 at the Council meeting are hereby approved and adopted.

48 **BE IT FURTHER RESOLVED:**

49 That Samsung Austin Semiconductor, LLC is a “qualified business” as
50 defined in Section 2303.402 of the Act and meets the criteria for designation as an
51 Enterprise Project, as set forth in Chapter 2303, Subchapter F of the Act.

52 **BE IT FURTHER RESOLVED:**

53 The local incentives offered to Samsung Austin Semiconductor, LLC are the
54 same as those provided in Ordinance Nos. 20071018-008, 20101104-046, and
55 20191114-068.

56 **BE IT FURTHER RESOLVED:**

57 The Enterprise Project shall take effect on the date of designation of the
58 Enterprise Project by the Governor’s Office of Economic Development and
59 Tourism and terminate five years from the date of designation.

60 This Resolution shall take effect immediately upon its passage and approval.
