

MBE/WBE Summary

Public notice was given for this solicitation CLM940, Walnut Creek WWTP Gas Scrubber System Renewal project, through the City's Vendor Connection web portal. Two bids were received and opened on September 1, 2022. Of the two of bids received, neither firm submitting was a certified MBE/WBE. Matous Construction, Ltd. submitted the lowest responsive bid including an allowance of \$100,000:
