AN ORDINANCE AMENDING THE FISCAL YEAR 2022-2023 PARKS AND RECREATION DEPARTMENT OPERATING BUDGET SPECIAL REVENUE FUND (ORDINANCE NO. 20220817-004) TO ACCEPT AND APPROPRIATE UP TO \$250,000 FROM THE TRAIL OF LIGHTS FOUNDATION FOR CITY EXPENSES AND SERVICES; AND AUTHORIZING THE WAIVER OF CERTAIN FEES AND REQUIREMENTS FOR THE 2022 TRAIL OF LIGHTS AND ZILKER HOLIDAY TREE LIGHTING CEREMONY IN AN AMOUNT NOT TO EXCEED \$240,702.
