

## **M/WBE Summary**

Public notice was given for this solicitation, CLMC924 Wildhorse Ranch WWTP Expansion project, through the City's Vendor Connection web portal. Two bids were received and opened on September 22, 2022. Of the two bids received, neither firm submitting was a certified MBE/WBE. Matous Construction, Ltd. submitted the lowest responsive bid including allowances of \$1,055,500 and an alternate of \$1,375,000:
