



PARKS AND RECREATION BOARD DIRECTOR'S REPORT

COMMUNITY ENGAGEMENT EVENTS:

Zilker Park Vision Plan: On November 15th, the draft Zilker Park Vision Plan was released for review by the community. As the first comprehensive plan for this beloved and complex space, the vision plan aims to provide a guide for the future of Zilker Metropolitan Park. To connect with as many people in Austin as possible, multiple engagement methods and efforts are being implemented:

- Online Draft Plan Review: Community members can read the entire draft plan and provide comments directly on the plan now through January 8, 2023.
- <u>Community Survey</u>: A survey option will also be offered highlighting key elements of the draft plan and guiding principles. Open now through January 8, 2023.
- **Pop-ups in all 10 Districts and Zilker:** The planning team will also host pop-ups through Austin between now and January 8, 2023, at various events throughout the city.

Adams-Hemphill Neighborhood Park Community Meeting: The Parks and Recreation Department is partnering with the Watershed Protection Department (WPD) and Austin Transportation Department to create a park concept plan for potential future improvements. WPD is planning to build two stormwater ponds at the park as part of the Guadalupe St. Flood Risk Reduction project. The concept plan will help ensure ponds are compatible with any potential plans for the park in the future. The department will also host a Pop-up Event.

Armadillo Neighborhood Park Nature Play Open House: As part of Cities Connecting Children to Nature and in partnership with community partners, the department will install nature play features in Armadillo Neighborhood Park. The meeting will build on the previous meeting in February 2020, sharing ideas for the future equipment and providing interactive options for kids in attendance. The department will also host a Zilker Pop-up at this event.

George Morales Dove Springs Recreation Center: The George Morales Dove Springs Recreation Center, in collaboration with Austin Public Health and Public Works, hosted the ground-breaking ceremony for the Dove Springs Public Health Facility on November 5, 2022. A ceremonial dig and ribbon cutting took place on the corner of Palo Blanco Lane and Ainez Drive to celebrate the upcoming start of facility construction. **District 2**

Emma S. Barrientos Mexican American Cultural Center Phase II Groundbreaking: Groundbreaking for Phase 2 is scheduled for December 10th, 10:00 AM. A blessing will performed by Daniel Llanes at 9:30am. The groundbreaking will take place directly to the north of the current building site. The ceremony will be followed by hot beverages and snacks. Phase 2 was funded by the 2018 Bond and includes two new buildings and a renovation of the existing structure. **District 9**


PLANNING UPDATES:

Whisper Valley PUD: On December 1st, City Council will be asked to authorize the negotiation and execution of an amended and restated Whisper Valley Master Parkland Agreement alongside the issuance of the Series 2022 Texas Special Assessment Revenue Bonds. The City of Austin has established the Whisper Valley Planned Unit Development (PUD) and Public Improvement District (PID) for a new 2,000+ acre development in Austin, east of SH 130. The development includes requirements for parkland dedication superiority, further described in the Master Parkland Agreement between the City and the Developer. The City has authority to issue Special Revenue Bonds for public improvements within the PID, including park improvements. The PID is expected to develop a 600-acre public park in accordance with the above. The current Master Parkland Agreement requires an amendment to better define the obligations of the Developer and the PID in developing the parkland. District 1





Parkland Acquisitions: On December 8th, the Parks and Recreation Department (the Department) will request Council action to approve the purchase and sale agreement of two separate properties for future parkland. The Utotem-Country Club Creek property is an assemblage of parcels to be purchased from one owner. The properties consist of approximately 5.42 acres located along Country Club Creek, east of Burleson Road and South of Oltorf Street. This acquisition is expected to function as a neighborhood park, trailhead, and trail connection. The Anderson-Slaughter Creek property consists 6.85 acres along Slaughter Creek, east of IH-35. This acquisition will function as a destination park and close a gap in the Slaughter Creek Greenbelt system. The site features a pooled section of Slaughter Creek that would allow for water-based recreation. It will rejoin existing parkland to the north. These acquisitions are funded through Parkland Dedication (PLD) funds and the 2018 Parks and Recreation Bond. **Districts 3 and 5**

305 Congress "Statesman" Planned Unit Development Amendment (PUD): The item was approved on second reading by Council on November 3rd and is scheduled for a third reading on December 1st. The LAW Department has drafted an Ordinance with several exhibits. The Department is following these items with interest:

- There has been discussion of a fixed or ceiling amount to be paid by the applicant in park fees, regardless of future fee formula calculations.
- The applicant has committed to building the Great Steps, plaza areas, amenitized water ponds,
 ADA access points and reconstructing the trail outside of parkland credit. The remaining park
 amenities to be considered include the Great Lawn, Pier, Water Steps, nature play area, etc.
 The applicant has publicly discussed the building of the Congress Avenue Right of Way access.
 As discussions continue changes to the current draft Ordinance will need to be voted on by
 Council Members via a motion.
- The question of who will maintain the park amenities has not yet been determined. The
 Department is reviewing cost estimates for maintenance and alternatives with the Downtown
 Austin Alliance, the applicant and The Trail Conservancy, per Council's request.

Project Connect: Project Connect is re-evaluating several options considering recent findings that put the project over budget. There has been no timeline given for when new alternatives will be shared with the Department, or when work can be resumed on items such as 6F land transfers. The Department has reviewed Equitable Transit Oriented Development documents and has commented that parks can be a vital part of healthy communities. https://projectconnect.com/. **Multiple Districts**

DEVELOPMENT UPDATES:

Dittmar Recreation Center: Dittmar Recreation Center is installing a pedestrian crosswalk on Dittmar Road. The crosswalk improves pedestrian safety and makes it easier to cross the roadway. The pedestrian crosswalk is still in the process of being completed. **District 2**

Gus Garcia Art in Public Places Mural Project: Work has begun on an outdoor community mural in partnership with Art in Public Places. This mural highlights Gustavo "Gus" Garcia and everything the recreation center named after him represents. The mural project officially started on Monday October 3rd and is expected to be completed by late November- early December. **District 4**

Evergreen Cemetery Road Rehabilitation: On November 3rd, Department staff completed the rehabilitation of 1.2 miles of cemetery road, ahead of schedule and under budget. Project work included the addition of flat concrete "ribbon" curbs on both sides of the road, new asphalt pavement throughout, and drainage repairs to reduce erosion and ponding water. All improvements were made within the existing limits of the old asphalt road and care was taken to remain five feet from all burial plot lines. Completion of the project was a coordinated effort by Cemeteries staff, Department engineering technicians, and Public Works Department technicians. The project utilized the Department Asphalt IDIQ Contract for road construction and repairs and was funded by 2018 Bonds. **District 1**

Asian American Resource Center (AARC) Phase 2 Improvements: The Schematic Design phase for the Performing Arts Center and associated improvements as outlined in the 2019 Plan approved by the City Council is complete. The Phase 2 project is being led by the City of Austin project team, Trahan Architects, and the Construction Manager-At-Risk, FlintCo. The project team presented the schematic design to Asian American Quality of Life Advisory Commissioners on November 15th, and to the Community via an onsite meeting and Zoom on November 17th. The available funding will not cover the





entire construction cost of the Performing Arts Center and the associated site improvements that are needed to support the community. The project team continues to evaluate costs alongside logistics to attain the greatest value. This project embraces the AARC's mission and vision to create a space of belonging and healing for Asian American communities in Austin and beyond, supports and connects the diverse communities, and will be informed by pan-Asian culture and architecture. The Phase 2 project is funded through \$7M from the 2018 Bonds. **District 1**

George Washington Carver Museum and Cultural Center Phase 1a & 1b Facility Expansion: In 2021, City Council approved a Facility Expansion Plan that revisited a previous feasibility study and sought additional updates to develop the new plan in line with current requirements. Phase 1a and 1b of the Council-approved George Washington Carver Facility Expansion Plan will include Architecture/Engineering consultant services. The Department will seek Council approval for the negotiation and execution of a professional services agreement in support of this project on December 1st. The project scope will explore relocating administrative functions to a new upper level to expand the area available for community-centric programming near the main entry, and site improvements that include outdoor classrooms, renovations of existing public restrooms, and a new flexible event lawn with a covered pavilion. Project goals include creating community-focused interior spaces and exterior site improvements that weave the facility into the fabric of the surrounding community and exemplify the ethos, history, and culture of the community itself. The design will be heavily influenced by a community engagement phase at the beginning of the project to help determine scope and direction. The Architecture/Engineering consultant services will include site studies, programming services, design phase services, bid phase services, construction phase services, post-construction phase services, warranty phase services, and all related infrastructure necessary to meet the City of Austin development requirements. Nash Hernandez Building Renovation: The Department will present at a special Council work session on December 6th to discuss the result of City Council resolution 20220616-89, a report issued to Council studying the feasibility and financial impact of an Intergenerational Resource and Activity Center (IGRAC, formerly IRAC) program in the Nash Hernandez Building. Council was updated via memo on October 17, 2022. District 3

Emma S. Barrientos Mexican American Cultural Center (ESB-MACC) Phase 2 Improvements: On December 7, the Joint Venture Miró Rivera Architects + Tatiana Bilbao ESTUDIO (JV MRA+TBE), City of Austin project team and Roger's O'Brien Construction will present Design Development documents to the ESB-MACC Advisory Board. This project follows the guidelines as outlined in the Council-approved ESB-MACC Phase 2 Plan for building expansion and renovation. Funding is available through the voter-approved 2018 General Obligation Bonds in the amount of \$27M. District 9

MAINTENANCE UPDATES:

Security Cameras at Givens Recreation Center: The Givens project to install security cameras to improve facility security is now complete. The Recreation center now has seventeen cameras installed within the facility as well as the immediate perimeter, with the option to add additional cameras in the park if needed. The installation was completed by city vendor Johnson Controls. **District 1**






Delores Duffie Recreation Center: Training from world-renowned nature play expert, Adam Bienenstock, on the design, installation, and maintenance of nature play features for select PARD staff and partners. The Departments playgrounds team will install an outdoor nature playscape for the training that will be used for Nature Based Programs at Delores Duffie in the future. **District 1**

South Austin Recreation Center (SARC): The Multi-purpose Field is complete. 15,000 square feet of sod has been placed on the excavated infield area. The area will remain unused to ensure proper growth until March of 2023. SARC has already received rental inquiries to utilize the updated space. **District 3**

Encampment Removal: Gus Garcia District Park will have an encampment removed in partnership with the Parks and Recreation Department, Austin Public Health and Austin Resource Recovery. The clean-up efforts will likely cost several hundreds of thousands of dollars. The Parks and Recreation Department does not have funding allocated for homeless encampment clean-up and is working on how to accomplish this task with partners. **District 4**





LCRA Agreement: The Parks and Recreation Department and the Lower Colorado River Authority finalized an agreement for managing safety along the lakes through buoy implementation. **All Districts**

Butler Landfill Zilker Metro Park Maintenance Project: Planned maintenance work on the Stratford Drive Butler Landfill lot includes regrading to prevent ponding, gates to control vehicular access to the cap, a pedestrian gate near Lou Neff Road, and an irrigation system to support three re-vegetated acres. A new pump will utilize lake water for irrigation. Clean Scapes has completed the installation of the split-rail fence and gate, and the gravel lot was reopened for public parking in October. The focus for the upcoming weeks will be to complete the irrigation system installation and hydroseeding of the 3-acre revegetation lot. Installation of the new pump at the Zilker Pump House began the week of November 14th. Trail detour signage was coordinated through The Trail Conservancy and Department Operations and Maintenance staff. This work represents the final maintenance phase and it is anticipated to be completed by the end of November 2022. The revegetated lot will remain closed for at least an additional 6-12 weeks for the grasses to be established. Future uses for the lot will be determined according to the Zilker Vision Plan. The project is funded by C3 Presents. District 8

District 1:

Asian American Resource Center's Youth Voices Rising!: Youth Voices Rising! is a leadership series for Asian American youth, in which a cohort of 17 children, ages 10-14, met on Saturday mornings between October 1st 31st, 2022. The students read the novel on their own time to learn about Asian American history through award-winning graphic texts. They also learned skills for recording their family's oral history, creating digital videos and stop-motion animation to activate their family's histories. In October, students read Kiku Hughes' graphic novel, *Displacement*, about the Japanese American Internment Camps in World War II, met with the author herself via Zoom, and created drafts of their own comic strips about their families' immigration history.



Collections Return to O. Henry Museum: O. Henry Museum now has collection items returning to the museum in preparation for re-opening after a prolonged rehabilitation project. The first item to return, and one of the most significant items in the collection, is a carefully restored Square Grand Piano built in the mid-1860s. The piano has been restored with the assistance of the Brush Square Foundation and carefully kept at Mollberg Piano Restoration facilities until the building was again ready to house it. Soon, the O. Youth Sports Organization participation numbers: after nearly two years of COVID-19 restrictions shutting down our youth sports organizations, youth participation in sports have rebounded in a big way. In the 2021-2022 fiscal year, 26,602 youth participants were recorded as participating in sports on City land. Mainly consisting of youth baseball and soccer, these organizations utilize City Parks across town including Circle C Slaughter Creek, Beverly Sheffield Northwest District Park, Roy G. Guerrero Park, Garrison Park and many others. With continued growth and opportunity, there's no doubt Youth Sports Organizations on City land are providing a positive experience for the youth of today and of the future. All Districts

ADMINISTRATIVE UPDATES:

Recreation Management System: The contract with the current vendor, Vermont Systems (RecTrac), for recreation management, expired in September 2022. PARD, with the assistance of the Communications and Technology Management Department (CTM), published a Request for Information (RFI) to survey current technology solutions in the Recreation Management Industry. PARD/CTM received three responses and conducted vendor question and answer sessions and vendor system demonstrations, along with meetings with current user organizations, between September and October 2021. Based on the information gathered, PARD will work with CTM to establish a scope of work (SOW) and conduct a formal solicitation for a future Recreation Management System. As CTM is the principal information technology department that focuses on the delivery and operations of vital IT infrastructure network and telecommunications services for the City, they will facilitate the competitive solicitation process. This includes establishing a CTM project manager and creating a timeline for the solicitation process. In October 2022, PARD began working with a CTM project manager to establish timeline and deliverables for the solicitation scope of work. PARD anticipates the solicitation process will take over a year to complete. PARD will continue to utilize RecTrac services throughout the solicitation process until a recommended vendor is established.

Watercraft Concession at 2418 Stratford Drive: The contract with the current vendor, Rowing Dock, expires April 22, 2023. The Scope of Work (SOW) was developed and presented at the September CCC meeting. The solicitation was published on November 9th, with responses due back in early January 2023. The new agreement is expected to be executed prior to end of current agreement in April 2024.





Management and Operation of the Pharr Tennis Center: This agreement is for the management and operations of the renovated Burnett "Blondie" Pharr Tennis Center (Pharr). The soon to be renovated facility is anticipated to be completed in August 2023. The CCC was briefed at the October 21st meeting on the solicitation, which is anticipated to be released in late 2022 or early 2023

PARD's Operating Budget Status as of November 1, 2022: Of the \$119 million General Fund budget, 9.3 percent or \$11M has been obligated as of the end of October as compared to 9.6 percent spent in the same period of the prior fiscal year. \$0.7M of the \$14.1M budgeted General Fund revenue has been collected as of the end of October. Golf revenue equaling \$1.1M has been collected as of the end of October, which is up compared to the \$0.39M revenue collected by October 2021. Golf Expenditures of \$0.8M have been obligated as of the end of October. Of the \$9.2 million Golf budget, 8.8 percent or \$0.8M has been obligated. This is \$500K higher in spending as of October of the prior fiscal year.

Upcoming Financial Services Trainings: In November and December, PARD FSD will offer multiple training sessions including, but limited to the following areas of Accounting and Purchasing: Cash Handling; ProCard Use; Purchasing; Inventory Policy, and; Donations Policy and Procedures.


Texan by Nature Honoree: The City of Austin Parks and Recreation Department was selected as a <u>Texan By Nature</u> TxN 20 Honoree. The TxN 20 is an effort to recognize the best work in conservation coming from businesses operating and based in Texas. It's an opportunity to showcase innovation, commitment, and best practices from a variety of industries. Austin Parks and Recreation is being recognized for its efforts to improve building sustainability and create land management plans for natural areas.

2018 General Obligation Bond Program Proposition C - Parks and Recreation (\$149 million) Update: Funding from Proposition C has contributed to over 90 projects and 30 parkland acquisition efforts throughout the City of Austin. The Department has spent \$47.2 million of the \$149 million authorized and has a further \$12.8 million under contract. Recent highlights in the program include:

- Completed the Evergreen Cemetery Road Rehabilitation (District 1) project in early November
- Completed the <u>Seaholm Intake Facility Phase I Rehabilitation</u> (District 9) project in September
- Acquired a 4.06 acre parcel as an addition to Latta Branch Greenbelt (District 8) in August
- Started construction on the <u>Givens District Park Vision Plan Phase I Implementation</u> (District 1) in mid-July and expect completion in late Spring 2023
- Started construction on the <u>Brush Square Rehabilitation Phase I</u> (District 9) project in late June and expect completion by Summer 2023
- Started construction on the <u>Pharr Tennis Center Renovation</u> (District 9) project in mid-August expect completion in early Summer 2023
- Received approval from City Council to negotiate a construction contract for the <u>Brownie</u> and <u>Highland</u> Neighborhood Park (District 4) projects in October. Construction will begin in Winter 2022/23
- Continued to progress through permitting for the <u>Givens</u> and <u>Colony Park</u> Pool (District 1) projects with construction expected to start in early calendar year 2023







Due to rising construction costs, the Department continues to hold balances in the Aquatics, Building Renovations, Park Improvements, and Infrastructure categories to serve as program contingencies for ongoing work.
