## AN ORDINANCE AMENDING EXHIBIT A TO ORDINANCE NO. 20220817-005 (CITY OF AUSTIN FEE AND FINE ORDINANCE FOR FISCAL YEAR 2022-2023) TO INCREASE CERTAIN FEES FOR THE CONVENTION CENTER GARAGES NEAR THE CONVENTION CENTER.

## BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

**PART 1.** Council amends Exhibit A to Ordinance No. 20220817-005 (*City of Austin Fee and Fine Ordinance for Fiscal Year 2022-2023*) to increase certain fees for the Convention Center Garages on Second Street and Fifth Street, located near the Convention Center, to more closely align with the cost of service for those garages as follows and as also shown in Attachment 1:

Current rates (approved budget):

0 - 30 minutes	Grace Period
30  minutes - 2  hours	\$5.00
2  hours - 9  hours	\$10.00
9 hours $-12$ hours	\$15.00
12 + hours \$3/hour w/max	\$48.00

Revised rates:

0-30 minutes	Grace Period
30  minutes - 1  hour	\$5.00
1  hour - 6  hours	\$10.00
6  hours - 10  hours	\$15.00
10  hours - 12  hours	\$20.00
12 + hours \$3/hour w/max	\$48.00

**PART 2.** The Austin Convention Center Department has the authority to adjust these fees consistent with the affordable parking program.
